#### Amendment:

Paragraph (24) under the header "Governmental Direction and Support" in Title III is amended by adding a new proviso to read as follows:

...provided, that not to exceed \$10,600 shall be available for the Attorney General for official reception and representation expenses; ...

#### Rationale:

This amendment authorizes the Attorney General to spend the same amount of funds on official reception and representation expenses as the Chief Financial Officer and the Chancellor of the DC Public Schools.

#### Rationale:

This amendment adjusts capital project budgets to fund the purchase of 220 additional WMATA railcars that will cost the region a total of \$615 million. Virginia and Maryland have agreed to the purchase. The District's share will be \$135 million. Contributions will start in FY 2019 as the railcars are delivered.

#### AMENDMENT:

Strike \$8,962,500 (local fund) reduction and \$8,962,500 (dedicated tax) increase in Housing Production Trust Fund in Comptroller Source Group 41 (Contractual Services – Other).

#### RATIONALE:

The amendment would reverse the local reduction to HPTF. The total budget will increase to \$109 million, plus \$7.8 million for HPTF debt service for a total amount of \$116.8 million to HPTF.
