#### I. BACKGROUND AND NEED

On June 2, 2015, Proposed Resolution 21-187, the "Metropolitan Washington Airports Authority Board of Directors Thorn Pozen Confirmation Resolution of 2015" was introduced by Chairman Phil Mendelson at the request of Mayor Muriel Bowser. Proposed Resolution 21-187 would confirm the Mayor's nomination of Mr. Thorn Pozen for appointment to the Metropolitan Washington Airports Authority Board of Directors to a six-year term expiring January 5, 2021. Mr. Pozen is currently a resident of Ward 3.

The Metropolitan Washington Airports Authority (MWAA) was created in 1987 to assume control of Washington Dulles International Airport and Washington National Airport (later renamed Ronald Reagan Washington National Airport). The airports were formerly run by the U.S. Department of Transportation and the Federal Aviation Administration. MWAA is an independent body created through an interstate compact between the Commonwealth of Virginia and the District of Columbia.

In addition to the two airports, MWAA also operates, maintains, and controls the Dulles Toll Road and the Dulles Access Road. In 2008, Virginia officially transferred control of the Toll Road to MWAA in order for MWAA to construct an extension of the Washington Metropolitan Area Transportation Administration's heavy rail line, known as the Silver Line, connecting the Orange Line to Tysons Corner and Dulles Airport. The first phase of the Silver Line opened in July of 2014, with the second phase currently under construction and expected to open in 2020.

The Metropolitan Washington Airports Authority Board of Directors (the Board) governs the activities of MWAA. It is currently composed of 17 members: seven members appointed by the Governor of Virginia, four members appointed by the Mayor of the District of Columbia, three members appointed by the Governor of Maryland, and three members appointed by the President with the advice and consent of the Senate. Board terms are for six years and members may not hold over and serve after the expiration unless they are reappointed. Each member of the Board is eligible for reappointment for one additional term. All members must reside within the Washington Standard Metropolitan Statistical Area, except for the President's appointments each of whom must be a registered voter of a state other than Virginia, Maryland, or the District.<sup>1</sup> These provisions are the result of changes enacted in 2012 to the MWAA interstate compact passed by the Federal Government<sup>2</sup>, the Commonwealth of Virginia<sup>3</sup>, and the District<sup>4</sup> which increased the number and allocation of seats, prohibited the holding over of a seat, and permitted reappointment. This seat was previously held by Ms. Shirley Robinson Hall and has been vacant since January 5, 2015, making the appointment of a new Board member from the District necessary and should be confirmed quickly.

Mr. Thorn Pozen was nominated by Mayor Bowser on June 2, 2015, nearly five months after Ms. Hall's term expired.

Thorn Pozen is a native District resident residing in Ward 3 and is currently a partner in the law firm of Goldblatt Martin Pozen LLP, advising clients on local District issues, including government ethics, land-use, zoning, government relations, and legislative and regulatory matters. Mr. Pozen earned a B.A. with Honors and Distinction in History from Connecticut College and his J.D. from the American University Washington College of Law.

Mr. Pozen has worked in or with District government for over 25 years, starting as a legislative assistant with former Councilmember John Ray in 1988. After serving for more than a year with the Council, Mr. Pozen moved in to a public relations job with the International Brotherhood of Electrical Workers, where he remained for nearly six years. Mr. Pozen returned to working with the District when he joined the D.C. Financial Responsibility and Management Assistance Authority, commonly known as the "Control Board", as a law clerk for two years. From there he worked at several law firms before returning to District government with Ward 4 Councilmember Adrian Fenty, serving as his Chief of Staff for two years before transitioning to a role as Special Counsel in the Office of the Attorney General. He served in this role for the

entirety of the Adrian Fenty mayoral administration and several months of the Vincent Gray administration where he was the Chief Ethics Counselor and Chief FOIA Officer for the District.

In addition to his experience with District government, Mr. Pozen has served on the Boards of Directors for several legal, community, and charitable organizations, including the D.C Appleseed Center for Law and Justice, Horizons Greater Washington, the Jewish Community Relations Counsel of Greater Washington, the Greater Chesapeake and Potomac Chapter of the Juvenile Diabetes Research Foundation, the Council for Court Excellence, and the Steering Committee of the D.C Bar's District of Columbia Affairs Section.

The Committee of the Whole received no testimony in opposition to Mr. Pozen's appointment. At the July 7, 2015 reconvened roundtable on his nomination, he testified about his qualifications for the position on the board and his vision for MWAA to continue their progress on ethics reform and that the District's interests are well-represented. For these reasons, the Committee supports the Mayor's nomination and recommends adoption of PR21-187.

## III. POSITION OF THE EXECUTIVE

Mr. Thorn Pozen is the Mayor's nomination for appointment to the Metropolitan Washington Airports Authority Board of Directors.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission.

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on Public Resolution 21-187 on Thursday, July 2, 2015, but the roundtable was recessed due to a conflict with Mr. Pozen's schedule and reconvened to Tuesday, July 7, 2015. The testimony summarized below is from that roundtable. Copies of written testimony are attached to this report.

Warner Session, Vice Chair, Metropolitan Washington Airports Authority Board of Directors, testified in support of the nominee, citing his experience in District government and legal experience in the private sector, including his work in ethics consulting, that make him well-suited for the Board of Directors. Mr. Session said that this nomination could not have come at a better time, just as MWAA is embarking on a billion dollar capital construction

program at National Airport and the continuing construction of the Silver Line, serving as opportunities for the nominee to weigh in on issues that would advance the interests of the District.

*Thorn Pozen, Nominee,* testified that his service in District government, his legal training, his knowledge of the District, relationships forged during his career, and his devotion to his community made him eminently qualified for the role on the Board. Additionally, Mr. Pozen outlined his five main priorities for his service with the Board.

The Committee received no testimony or comments in opposition to Public Resolution 21-187.

## VI. IMPACT ON EXISTING LAW

Members of the Metropolitan Washington Airports Authority Board of Directors are appointed pursuant to section 5 of the District of Columbia Regional Airports Authority Act of 1985, effective December 3, 1985 (D.C. Law 6-67; D.C. Official Code § 9-904) which establishes the Board, and in accordance with section 2 of the Confirmation Act of 1978, effective March 3, 1979 (D.C. Law 2-142; D.C. Official Code § 1-523.01).

## VII. FISCAL IMPACT

The approval of Public Resolution 21-187 will have no fiscal impact. Members are not compensated by the District government and the operations of the Airports Authority are self-funded.

## VIII. SECTION-BY-SECTION ANALYSIS

After ascertaining a quorum (Chairman Mendelson and Councilmembers Alexander, Allen, Bonds, Cheh, Evans, Grosso, Orange, May, McDuffie, Nadeau, Silverman, and Todd present), Chairman Mendelson moved *en bloc* the report and the print with leave for staff to make technical, editorial, and conforming changes. After an opportunity for discussion, the vote on both the report and print was unanimous (Chairman Mendelson and Councilmembers Alexander, Allen, Bonds, Cheh, Evans, Grosso, Orange, May, McDuffie, Nadeau, Silverman, and Todd voting aye). The meeting adjourned at 1:00 p.m.

# TESTIMONY OF WARNER H. SESSION, ESQ. ON BEHALF OF THORN POZEN TO SERVE AS A MEMBER OF THE METROPOLITAN AIRPORTS AUTHORITY COUNCIL OF THE DISTRICT OF COLUMBIA

## CHAIRMAN PHIL MENDELSON

July 7, 2015

Good morning Chairman Mendelson. I am Warner Session, principal of the Session Law Firm.

I am pleased to appear today in support of Mr. Thorn Posen's confirmation to the Metropolitan Washington Airports Authority Board (the "Airports Authority"). In nominating Mr. Posen, Mayor Bowser has made an excellent to choice to fill the seat vacated by Shirley Robinson Hall. As you know, through legislation the Airports Authority Board was expanded a couple of years ago from 13 to 17 members. With the addition of Thorn Posen, there will now be a full compliment of Directors.

In addition to operating two airports – Reagan National and Dulles International – the Airports Authority operates the Dulles Toll Road and is managing construction of the Metrorail Silver Line. Through these enterprises and through its contractors and dependent industries, the Airports Authority serves as an economic catalyst for the District of Columbia, supporting more than 120,000 for District residents and generating more than \$4.5 billion in annual labor income. Yet, still more can and needs to be done.

It is for this reason that I am excited that Mr. Posen will be joining the Board. Mr. Posen brings a broad base of experience to this assignment. He is a familiar face in the Wilson Building, having previously served as Chief of Staff and Counsel to the Committee on Human Services for then Councilmember Adrian Fenty, and as Special Counsel in the Office of Attorney General for the District of Columbia, managing key legal projects and initiatives of the Attorney General and Mayors Adrian Fenty and Vincent Gray. Mr. Posen also has broad legal experience in the private sector, having been an associate at Arnold and Porter, a partner at Stinson Morrison and Hecker and currently a partner in his own firm – Goldblatt Martin Pozen. His body of experience – in particular, his work as Chief Ethics Counsel for the District of Columbia – makes him well-suited to serve on the Airports Authority Board. Mr. Posen has the right demeanor, judgment and intellect.

Finally, Mr. Posen joins the Airports Authority Board at an important time in its development. As we embark on a billion dollar capital construction program at Reagan National and continue to oversee the nearly three billion dollar construction of the Silver Line, Mr. Posen will be called upon to weigh in and make critical decisions to insure that as a key partner, the District of Columbia's interest are protected and advanced. This means making the Airports Authority more inclusive of District of Columbia businesses and residents. I'm confident that Mr. Posen is up for the task.

# **Statement of Thorn Pozen**

Chairman Mendelson, members of the Committee on the Whole, and committee staff, good morning. I am Thorn Pozen, a nominee for the position of member of the Board of Directors of the Metropolitan Washington Airports Authority ("MWAA"). I am a partner in the Washington, D.C. law firm of Goldblatt Martin Pozen LLP, but please know that my comments this morning are my own and not those of my law firm or our clients.

Let me start by thanking you, Mr. Chairman, for recessing this hearing on the 2<sup>nd</sup> and reconvening it today in order to accommodate my travel schedule. The Committee's flexibility is very much appreciated.

This morning I want to speak briefly about my experience: working with and for the District of Columbia government, in the community here, and through my law practice; all of which, I believe qualify me for the position to which I have been nominated. I want to talk a bit about my vision for my role in that position; and, finally, I want to be sure to answer any questions the Committee may have for me.

First, as for my experience: I was born and raised here in Washington. In my law practice, I focus on advising government and private-sector clients on local government, administrative law, and local and federal government ethics issues. I have served as Special Counsel in the District government, including serving as the District's chief Ethics Counselor and chief FOIA Officer. Additionally, I have served as Chief of Staff to a former D.C. Councilmember and a staffer for the former D.C. Financial Control Board. In all, I have been working for and with the District government for over 25 years of my professional career.

I also serve on the Boards of several legal, community, and charitable organizations in the District, including the D.C. Appleseed Center for Law and Justice, Horizons Greater Washington, the Jewish Community Relations Counsel of Greater Washington, the Greater Chesapeake and Potomac Chapter of the Juvenile Diabetes Research Foundation, the Council for Court Excellence, and the Steering Committee of the D.C. Bar's District of Columbia Affairs Section. I am a graduate of Connecticut College, in New London, Connecticut, from which I graduated with honors and distinction in my major; and the American University's Washington College of Law, here, from which I graduated *Magna Cum Laude*. I live in Ward Three with my wife and two children.

I believe that my local government expertise, legal training and practice, knowledge of the District of Columbia, and relationships from that experience will serve me in very good stead on the MWAA Board. I think also that my broad current and former Board and ethics experience will help me with ensuring good governance at the Authority and continuing the MWAA Board's progress in dealing with some of the ethics challenges it has faced in the past.

As for my view of my role on the MWAA Board, I have already reached out to the current members of the District's MWAA Board delegation, and received a briefing on Authority issues from MWAA staff. Through those conversations and my additional research, I see the role and purpose of the Board as properly overseeing the management of the Authority. My vision for the Board is supporting the District of Columbia's interests in the operations of the Authority and working to ensure the Authority is smooth running and adheres to the highest organizational ethics standards.

Specifically, I have five main priorities for my Board service:

- Ensuring that the interests of the District of Columbia are fully represented;
- Ensuring Authority procurement and hiring are fully open and transparent and appropriately available to D.C. businesses and D.C. residents;
- Continuing the progress the Authority and the Board have made on ethics reform;
- Ensuring appropriate management oversight; and,
- Working toward sustainable and steady growth in passenger load, cargo handling, and business activity at both airports, so the Authority can continue to be an economic driver for the District of Columbia.
