### I. BACKGROUND AND NEED

Proposed Resolution 21-366, the "Interagency Council on Homelessness Nechama Masliansky Confirmation Resolution of 2015," was introduced by Chairman Mendelson at the request of the Mayor on October 5, 2015 and referred to the Committee of the Whole. The purpose of PR 21-366 is to confirm the Mayor's nomination of Nechama Masliansky for appointment as a member of the District's Interagency Council on Homelessness as a representative from an organization that provides services within the Continuum of Care.

The Interagency Council on Homelessness ("ICH") was established by the Homeless Services Reform Act of 2005 "for the purpose of facilitating interagency, cabinet-level leadership in planning, policymaking, program development, provider monitoring, and budgeting for the Continuum of Care of homeless services."<sup>1</sup> In addition to agency heads from relevant District agencies, members of the ICH include representatives of organizations that provide services within the Continuum of Care, homeless or formerly homeless individuals, and advocates for the District's homeless population, among others.<sup>2</sup> Annually, the ICH develops and publishes the District's "Winter Plan" detailing how and where the District will provide hypothermia shelter for individuals and families.<sup>3</sup> In March 2015, the ICH published its 5-year "strategic plan," *Homeward DC*, which describes the District's plan to end chronic homelessness in the District by 2020.<sup>4</sup> Going forward, members will work to ensure the plan's implementation and execution.

Ms. Masliansky is currently a resident of Ward 3 and the Senior Advocacy Advisor at So Others Might Eat ("SOME"), a District-based service provider. She is a graduate of Hofstra University, where she earned a Juris Doctor. Ms. Masliansky also holds a Bachelor of Arts in English Literature from Pace University. For over a decade, Ms. Masliansky has focused her work on homeless services, affordable housing, family services, and access to food. In addition, she has nearly a decade of work experience focused on domestic violence. Ms. Masliansky can lend her expertise in this broad range of areas to contribute to the ICH's ongoing work.

The Committee of the Whole recommends her reappointment.

November 4, 2015	The Committee of the Whole holds a roundtable on PR 21-361 through PR 21-372, which is recessed until November 10, 2015 to hear testimony on PR 21-370.
November 10, 2015	The Committee of the Whole reconvenes the public hearing on PR 21-361 through PR 21-372.

Ms. Masliansky emphasized the overlap between her work at SOME and the work of the ICH and her commitment to continued service.

*Eric J. Sheptock, Nominee,* summarized his background and qualifications for appointment to the ICH.

*Donald L. Brooks, Nominee,* summarized his background and qualifications for reappointment to the ICH.

*Albert Townsend, Nominee,* summarized his background and qualifications for appointment to the ICH.

*Margaret A. Hacskaylo, Nominee,* summarized her background and qualifications for appointment to the ICH.

*Margaret Riden, Nominee,* summarized her background and qualifications for reappointment to the ICH.

*Jill Carmichael, Nominee,* summarized her background and qualifications for appointment to the ICH.

Adam Maier, Housing Director, Pathways to Housing DC, testified that that each of the 12 nominees possesses knowledge and experience in the areas of homeless services policy and service delivery. Mr. Maier recommends approval of all nominees.

The Committee received no testimony or comments in opposition to PR 21-366.

## VI. IMPACT ON EXISTING LAW

Members of the Interagency Council on Homelessness are appointed pursuant to section 4 of the Homeless Services Reform Act of 2005, effective October 22, 2005 (D.C. Law 16-35; D.C. Official Code § 4-751.01 *et seq.*), which established the ICH.

### VII. FISCAL IMPACT

The approval of PR 21-366 will have no fiscal impact. Members are not compensated by the District government and the operations of the Interagency Council on Homelessness are funded through the office of the Deputy Mayor for Health and Human Services.

Dear Chairman Mendelson,

Thank you for your letter of October 22, 2015, requesting information relating to my nomination for appointment to serve as a member of the District's Interagency Council on Homelessness. If approved, I will be honored to serve.

Below are replies to the questions posed in your letter:

- 1. Answers regarding Financial Disclosure are found below in items 2-8.
- 2. None. To the best of my knowledge and understanding, I do not have a beneficial interest valued in excess of \$5,000 in any business entity transacting any business with the District Government.
- 3. I am employed in the Advocacy & Social Justice Department of SOME, Inc. (So Others Might Eat). Several departments in SOME—but not the department I work in-- have contracts from time to time with various agencies within the District Government. These are for such services as mental health (DBH), addiction recovery (DBH-APRA), senior services (DCOA) and employment training (OSSE and DHS). SOME also produces supportive housing for extremely low-income persons, and some of its housing has been produced with assistance through the Housing Production Trust Fund (administered by DHCD), Local Rent Supplement Program (administered by DCHA), and bonds or Low-Income Housing Tax Credits (administered by DCHFA). One housing site has an ACC contract with DCHA and a contract with TCP to house families that are exiting D.C. General Shelter.
- 4. None. To the best of my knowledge, neither I nor members of my immediate family serve as an officer, director, partner, or agent of any business entity transacting business with the District Government.
- 5. My liabilities are a mortgage with BB&T Bank for my co-op unit (outstanding balance \$ 170,137) and an auto loan with Hyundai Finance (outstanding balance \$ 4,307).
- I own shares in the Van Ness North Cooperative located at 3001 Veazey Terrace, N.W., Washington, DC 20008.

- I am an Associate Member of the Virginia State Bar and a Retired Member of the New York State Bar. I was also admitted to federal practice in the 4<sup>th</sup> Circuit and in the Eastern and Southern Districts of New York.
- 8. See item 7. SOME is a member of numerous organizations, and I participate in those.
- 9. None. I have not previously served on a board or commission connected with the District Government.
- 10. I am a member of the Board of Directors of Adas Israel Congregation, Washington, DC.
- 11. None. To the best of my knowledge, I have no outstanding liability for taxes, fees, or other payments to any government.
- 12. None. To the best of my knowledge and understanding, neither I nor immediate family has any interest of any kind that may directly or indirectly poses a conflict of interest for me in performance of my duties as a member of the DC Interagency Council on Homelessness.
- 13. I believe the purpose of the DC Interagency Council on Homelessness and its members is to serve the needs of the residents of the District of Columbia who are homeless or at risk of homelessness, and to marshal the resources of District Government, together with the private sectors, to address those needs in a responsible manner.
- I am now functioning as co-Chair of the Family Services Work Group of the Coalition for Nonprofit Housing and Economic Development (CNHED), which began meeting in October 2015.
  I am also participating in the Housing Committee of CNHED.

15. My top five priorities as a member of the DC Interagency Council on Homelessness will likely be:a. Support DHS in implementing the year-round right to shelter for families; work to ensure adequate annual budget allocation for Homeless Services.

b. Continue to encourage implementation of additional resources for unaccompanied homeless adults (singles).

c. Examine shelter conditions, with input from the new Shelter Conditions Work Group.

d. Explore prevention strategies that could be implemented months or years before a family or individual applies directly to the District-funded system for homeless shelter, so that they do not become at risk for homelessness.

e. Explore affordable housing as a prevention tool.

Testimony of Nechama Masliansky Senior Advocacy Advisor SOME, Inc. (So Others Might Eat) To the Committee of the Whole, on PR 21-366, "Interagency Council on Homelessness Nechama Masliansky Confirmation Resolution of 2015" November 4, 2015

Good morning, Chairman Mendelson and members of the Council. My name is Nechama Masliansky, and I am the Senior Advocacy Advisor at SOME, Inc. also known as So Others Might Eat. On behalf of the 340 employees of SOME and our 11,000 clients each year, I want to thank the Mayor and you for advancing my nomination for membership on the D.C. Interagency Council on Homelessness. Many staff and clients of SOME submitted my name for this membership, and I thank them wholeheartedly.

For the past 10 ½ years, I have worked at SOME. SOME is a community-based nonprofit organization that for 45 years has provided comprehensive services to District residents who are homeless or at risk of homelessness. We provide a hot breakfast and hot lunch daily—approximately 850 meals a day-- plus clothing and showers. We offer social services, a primary medical care clinic, a state-of-the-art oral health clinic, behavioral and mental health services, substance abuse recovery services, a Center for Employment Training, family services, and senior services including shelter, permanent housing, and a day program. We develop and run our own housing sites. At this time, we have in operation or in development long-term supportive housing for 746 single adults and 216 families. We also are operating 119 units of transitional supportive housing.

Mr. Chairman, I would be proud to represent SOME on the Interagency Council on Homelessness.

I have been working for 40 years on many causes of homelessness. In the 1970s I helped design one of the first domestic violence programs in the United States. In the 1980s and 1990s I trained more than 2,000 professionals and laypersons, drafted legislation, and provided case consultations in literally thousands of cases of domestic or sexual abuse.

In the mid-1990s I was the Executive Director of the National Center on Women & Family Law, which provided support for all the Legal Aid and domestic violence programs in the country. After that, I was a Staff Attorney at the Virginia Poverty Law Center.

My advocacy over the decades has included work on poverty, child support, and income supports.

Since early 2005, I have been honored to work at SOME. SOME's Advocacy & Social Justice Department in which I work provides policy analysis, advocacy, and community education on all the above issues. We also engage our own staff, clients and residents to speak for themselves on issues they are concerned about. My areas of focus currently are homeless services, affordable housing and family services.

As part of my work at SOME, for about nine years, I facilitated the local Coalition of Housing and Homeless Organizations known as COHHO. In the first years after passage of the Homeless Services Reform Act in 2005, COHHO was a stalwart supporter of the nascent Interagency Council on Homelessness. We encouraged the ICH to meet regularly and to have a formalized and open nomination process. We provided public forums for the ICH to meet its HSRA requirements. In addition, COHHO was a safe place where providers, government officials, and community members explored cutting-edge issues and recommended solutions.

Similarly, SOME has provided hospitality to the ICH for plenary meetings and for regular meetings of the Shelter Capacity Workgroup and the Shelter Conditions Workgroup.

For nine years, SOME and COHHO provided detailed feedback about the implementation of the HSRA, specifically about the calling of Extreme Weather Alerts and about shelter usage. This written analysis and feedback was given to the Chair of the Council's Committee on Human Services in addition to the City Administrator and the Director of the Department of Human Services. SOME and COHHO also provided data analysis that contributed to acceptance of the data-driven process that now informs the development of the annual Winter Plans.

I am a voting member on the ICH Emergency Response & Shelter Operations Committee and a regular participant in the Shelter Capacity Workgroup. I frequently attend meetings of the Executive Committee, Strategic Planning Committee, and Medicaid Workgroup of the Housing Solutions Committee. I also attended meetings leading up to the introduction of the ICH Strategic Plan. I coordinate implementation of the annual Point in Time enumeration in 22 of SOME's programs.

My work at SOME includes understanding the issues that drive people into homelessness, with an emphasis on the crisis in affordable housing and the need to sustain supportive services to prevent homelessness and to prevent recidivism back into homelessness. These include job training, literacy, and financial education.

Thank you for holding this Public Roundtable, and thanks again to all the persons who recommended my nomination. I will be pleased to provide further information and to answer any questions.
