## I. BACKGROUND AND NEED

Proposed Resolution 21-370, the "Interagency Council on Homelessness Margaret A. Hacskaylo Confirmation Resolution of 2015," was introduced by Chairman Mendelson at the request of the Mayor on October 5, 2015 and referred to the Committee of the Whole. The purpose of PR 21-370 is to confirm the Mayor's nomination of Margaret A. Hacskaylo for appointment as a member of the District's Interagency Council on Homelessness as an advocate for the District's homeless population.

The Interagency Council on Homelessness ("ICH") was established by the Homeless Services Reform Act of 2005 "for the purpose of facilitating interagency, cabinet-level leadership in planning, policymaking, program development, provider monitoring, and budgeting for the

Continuum of Care of homeless services." In addition to agency heads from relevant District agencies, members of the ICH include representatives of organizations that provide services within the Continuum of Care, homeless or formerly homeless individuals, and advocates for the District's homeless population, among others. Annually, the ICH develops and publishes the District's "Winter Plan" detailing how and where the District will provide hypothermia shelter for individuals and families. In March 2015, the ICH published its 5-year "strategic plan," *Homeward DC*, which describes the District's plan to end chronic homelessness in the District by 2020. Going forward, members will work to ensure the plan's implementation and execution.

Ms. Hacskaylo is currently a resident of Ward 2 and the Executive Director of the District Alliance for Safe Housing, a District-based service provider for survivors of domestic violence and their families. Ms. Hacskaylo is currently a candidate for a Master of Business Administration at Georgetown University. She is a graduate of the University of Pennsylvania, where she earned a Master of Social Work. She also holds a Bachelor of Arts in Psychology from the University of Massachusetts, Amherst. For over 25 years, Ms. Hacskaylo has focused her work on service to and advocacy on behalf of survivors of domestic violence. Her expertise will be of great value to inform the ICH's ongoing work regarding the specific needs of survivors of domestic violence and their families.

The Committee of the Whole recommends her reappointment.

**Donald L. Brooks, Nominee,** summarized his background and qualifications for reappointment to the ICH.

*Albert Townsend, Nominee*, summarized his background and qualifications for appointment to the ICH.

*Margaret A. Hacskaylo, Nominee*, summarized her background and described the special challenges of survivors of domestic violence experiencing homelessness in finding safe housing options. She noted the need to include these needs in the development of strategies to end homelessness created through the ICH. Ms. Hacskaylo emphasized her desire to bring her expertise to bear in her service with the ICH.

*Margaret Riden, Nominee*, summarized her background and qualifications for reappointment to the ICH.

*Jill Carmichael*, *Nominee*, summarized her background and qualifications for appointment to the ICH.

Adam Maier, Housing Director, Pathways to Housing DC, testified that that each of the 12 nominees possesses knowledge and experience in the areas of homeless services policy and service delivery. Mr. Maier recommends approval of all nominees.

The Committee received no testimony or comments in opposition to PR 21-370.

#### VI. IMPACT ON EXISTING LAW

Members of the Interagency Council on Homelessness are appointed pursuant to section 4 of the Homeless Services Reform Act of 2005, effective October 22, 2005 (D.C. Law 16-35; D.C. Official Code § 4-751.01 *et seq.*), which established the ICH.

## VII. FISCAL IMPACT

The approval of PR 21-370 will have no fiscal impact. Members are not compensated by the District government and the operations of the Interagency Council on Homelessness are funded through the office of the Deputy Mayor for Health and Human Services.

Dear Chairman Mendelson,

I am honored to have been nominated for appointment to serve as a member of the District's Interagency Council on Homelessness (ICH). As a native Washingtonian and lifetime resident of the area, I am committed to ensuring that all of our residents, particularly those who have suffered domestic or sexual violence, can avoid homelessness as the only alternative to living free from abuse. I hope that I will be able to support this through the work of the ICH.

I regret to inform you that I will be unable to attend the hearing scheduled for Wednesday, Nov. 4 as I will be out of the country attending and presenting at the 3<sup>rd</sup> World Conference of Women's Shelters in the Hague, Netherlands. I have prepared responses to your questions concerning the appointment below.

- 1. As this is a new appointment for me and I have not been on any boards or commissions until recently, I have not filed a Financial Disclosure Statement with the Office of Campaign Finance or the Board of Ethics and Government Accountability.
- 2. I am the registered agent for the District Alliance for Alliance for Safe Housing, Inc. (DASH), and for DASH Properties, LLC. Both organizations are valued at more than \$5,000. Neither is publicly traded.
- 3. I am the registered agent and Executive Director for the District Alliance for Safe Housing, Inc. (DASH), a Washington, DC based nonprofit organization that receives grant funding from various District agencies, including the Office of Victim Services and the Department of Human Services, in excess of \$1,000. I receive an annual salary of \$110,000/year.
- 4. I serve as an ex-officio member of the board of directors for DASH, a nonprofit organization providing housing and housing resources to victims of domestic and sexual violence in the District of Columbia. I also serve as a member of the board of directors for the DC Coalition Against Domestic Violence. Both organizations do business with the District Government.
- 5. I have no loans through non-federally or state insured institutions.
- 6. I am the co-owner of a condominium unit at 1325 13<sup>th</sup> Street, NW, #47, Washington, DC, as well as parking space at the same address. DASH Properties, LLC and DASH are deed holders of a building at 1835 3<sup>rd</sup> Street, NE, Washington, DC 20002 which serves as our

residential program for survivors of domestic violence.

- 8. I am a member of the National Association of Social Workers, the National Association of Professional Women, and the Association of Community Organization and Social Administration.
- 9. I was recently appointed and confirmed as a commissioner to the DC Commission for Women. My three year term runs from Oct. 2015 to Sept. 2018. I was a member of this same commission from July 2004 to January 2006.
- 10. As stated above, I serve as an ex-officio member of the board of directors for DASH, a nonprofit organization providing housing and housing resources to victims of domestic and sexual violence in the District of Columbia. I also serve as a member of the board of directors for the DC Coalition Against Domestic Violence, an advocacy and research organization focused on issues concerning domestic violence in the District.

**Interagency Council on Homelessness Confirmation Resolution 2015**

Testimony of: Margaret (Peg) Hacskaylo Executive Director District Alliance for Safe Housing (DASH) 202-462-DASH (3274) x110 Thank you for the opportunity to testify today. I appreciate the Council's time and consideration of my nomination to the District's Interagency Council on Homelessness, and apologize for my absence at last week's hearing. I was attending and presenting at the 3<sup>rd</sup> World Conference of Women's Shelters in the Hague, Netherlands. This was a gathering of shelter programs from around the world to address the urgent need for safe housing for victims of domestic violence and to share strategies for ending violence against women. As a representative of DASH's programs at this conference, I was able to share our model and learn from other advocates about ways to ensure that survivors of abuse don't face homelessness or worse when escaping violent homes.

The District Alliance for Safe Housing's mission is to be an innovator in providing access to safe housing and services for survivors of domestic violence and their families as they rebuild their lives on their own terms. Since our founding in 2006, DASH has facilitated a continuum of housing services for primarily low-income women and their children in need of support finding, and keeping, a range of housing options in order to become safe from violence. We are now Washington, DC's largest dedicated safe housing program for survivors.

Survivors of abuse face enormous barriers to safety and independence in the District. In 2013, there were almost 33,000 domestic violence-related calls made to the Metropolitan Police Department and the number of civil protection orders sought by victims increased seven percent that same year. But despite this growing need, the number of safe places for victims to find safe housing cannot keep pace. On a one-day census count in 2014, 847 victims were served by local domestic violence service providers, but another 77 requests for services went unmet, with 36% of those being for housing (2014 Domestic Violence Counts, National Network to End Domestic Violence). In fact, domestic violence is consistently cited as a major cause of homelessness

among women in the U.S. (National Alliance to End Homelessness 2014).
