#### I. BACKGROUND AND NEED

On October 6, 2015, Bill 21-421, the "Theodore 'Ted' Williams Alley Designation Act of 2015," was introduced by Councilmember Brianne Nadeau to designate the alleyway that runs north-south between Irving Street, N.W., Columbia Road, N.W., 11<sup>th</sup> Street, N.W., and Sherman Avenue, N.W., in Square 2851, in Ward 1, as Theodore "Ted" Williams Alley.

Square 2851 contains an alleyway that runs north through south, with 15' and 10' entrances on Irving Street, N.W., and Columbia Road, N.W., respectively. Surrounded by residential townhomes, the alley contains a lot that is planned to be developed in to a mixed-use condominium and office building, currently the site of an abandoned auto body shop. The plans have been approved by the Board of Zoning Adjustment and alley designation legislation is needed to divide the land in to plots to be developed and addresses assigned for the development.

#### Background on the Alley and Proposed Name

The development, led by Seven Five Three Development, is hoping to construct the Thompson Lofts on the site. Planned as a five-unit condominium building with office and artist space, the development is planned to bring daytime foot traffic to the site and surrounding neighborhood. As part of the development, several public improvements have been agreed to, including upgraded alley lighting, new sidewalks and crosswalks, and improved traffic signage in the alley.

Mr. Theodore "Ted" Williams was a resident of Pleasant Plains, in Ward 1. A dedicated community leader, Mr. Williams was fondly remembered in the community for both his personal accomplishments and outreach efforts to bring the community together. In his professional life, Mr. Williams was the first and only African-American to work in the Contagious Disease Department at Garfield Hospital, located on Florida Avenue, N.W., between 10<sup>th</sup> and 11<sup>th</sup> Streets, N.W., that later merged with two other hospitals to form the Washington Hospital Center.<sup>1</sup> Additionally, Mr. Williams was also the first African American person employed above the position of laborer at the Hygienic Laboratory, the precursor to the National Institutes of Health.

In his personal life, Mr. Williams was a devoted member of his community, organizing some of the first integrated basketball games in the District to promote inclusion, in addition to starting the Banneker Softball League. He was married to Ms. Gladys W. Martin, an elementary school teacher that was similarly known for her volunteer work in the community. Together they raised two accomplished children, Theodore Williams, Jr. and Dolores Williams Tucker, who both broke through racial barriers in their own careers.

## Effect of the Proposed Designation

Pursuant to District law, the Council has the authority to designate an official (as opposed to ceremonial) name of any public alley so long as the alley provides the only access to a residential or commercial property. Currently, the alley in Square 2851 houses an abandoned auto body shop that is planned to become a five-unit condominium space. Current law provides that an alley may only be symbolically ceremonially designated. However, because the alley provides the primary access to the future redevelopment, and requires an address to divide the land in to plots for addresses to be assigned, the Committee believes that designating an official name for the alley, notwithstanding the current restriction generally limiting alleys to symbolic names, is prudent for way-finding, address, public safety, and future development of the site.

Therefore, the Committee print recommends designating the alley in Square 2851 with an official name: Theodore "Ted" Williams Alley. The Committee expects that by this action the Mayor will update relevant District records including Fire and Emergency Services systems, Homeland Security and Emergency Management systems, District of Columbia maps, and any other records of the District used for way-finding or address purposes. In addition, the Mayor should notify the United States Postal Service, other relevant government agencies, and relevant

private sector entities of the official name of the alley. Finally, the Committee expects that the District Department of Transportation will install appropriate signage denoting the designation of the alley.

The two issues of assigning addresses on the alley for development to proceed and memorializing Mr. Williams' legacy can both be achieved through this legislation. For these mutually-agreeable reasons, the Committee of the Whole recommends the approval of Bill 21-341, the "Theodore 'Ted' Williams Alley Designation Act of 2016."

## III. POSITION OF THE EXECUTIVE

Alice Kelly, Office of Policy and Governmental Affairs Manager of the District Department of Transportation, testified on behalf of the Executive in support of Bill 21-421.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

Advisory Neighborhood Commission (ANC) 1A, in which the proposed designation is located, voted to pass a resolution at its November 12, 2015 meeting stating "not only will the naming of this alley result in removing a roadblock to the construction of an alley building on the property...but it is also an excellent opportunity to recognize one of Ward 1's own." The ANC resolution is attached.

## V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on Bill 21-421 on Thursday, November 19, 2015. The testimony summarized below is from that hearing. Copies of written testimony are attached to this report.

Alice Kelly, Office of Policy and Governmental Affairs Manager, District Department of Transportation, testified that the Executive supports Bill 21-421.

The Committee received no testimony or comments in opposition to Bill 21-421.

#### VI. IMPACT ON EXISTING LAW

Bill 21-421 has no impact on existing law. D.C. Official Code § 9-204.01 authorizes the Council to designate any public space and D.C. Official Code § 9-204.03 authorizes the Council to designate a public alley when the alley provides the only access to a residential or commercial property. The Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor or any person deceased less than two years. Mr. Williams passed away over two years ago.

#### VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2016 through fiscal year 2019 budget and financial plan to implement the provisions of the proposed legislation. The cost to the District Department of Transportation (DDOT) is an estimated \$38 per ceremonial sign for fabrication and \$144 for installation.

Good morning, Chairman Mendelson and members of the Committee of the Whole. I am Alice Kelly, Manager of the Office of Policy and Governmental Affairs of the District Department of Transportation (DDOT). I am here today to testify regarding Bill 21-134, Tip's Way Designation Act of 2015; Bill 21-228, Fieldstone Lane Alley Designation Act of 2015; Bill 21-229, Maverick Room Way Designation Act of 2015; Bill 21-341, Carry's Way Designation Act of, 2015; Bill 21-342, Guethler's Court Designation Act of 2015; and B 21-421, Theodore "Ted" Williams Alley Designation Act of 2015.

Bill 21-134, Tip's Way Designation Act of 2015 as currently proposed would designate the alleyway behind 7th Street, N.E., and 8th Street, N.E., and between A Street, N.E., and East Capitol Street, N.E., located in Ward 6, as Tip's Way in acknowledgment of Tip Tipton's dedication to the improvement of this alley.

Bill 21-228, Fieldstone Lane Alley Designation Act of 2015 as currently proposed would designate the alley that is entirely within Square 2258, running parallel to the 4600 block of Broad Branch Road N.W., located in Ward 3, as "Fieldstone Lane".

Bill 21-229, Maverick Room Way Designation Act of 2015 as currently proposed would symbolically designate the 2300 block of 4<sup>th</sup> Street, N.E., between

Rhode Island, N.E. and Bryant Street, N.E., located in Ward 5, as "Maverick Room Way".

Bill 21-341, Carry's Way Designation Act of 2015, as currently proposed would designate the alleyway that runs north and south between D Street, S.E. and E Street, S.E., located in Ward 6, as Carry's Way in recognition of the Carry Ice Cream Company, located on this site in the 1900's.

Bill 21-342, Guethler's Court Designation Act of 2015, as currently proposed would designate the alleyway that runs east and west, perpendicular to the north-south alley that runs between D Street, S.E. and E Street, S.E. in Ward 6 as Guethler's Court, named for John E. Guether, who owned and operated a brewery on this site in the late 1800s.

B 21-421, Theodore "Ted" Williams Alley Designation Act of 2015, as currently proposed would designate the alley bounded by Irving Street, N.W., and Columbia Road, N.W., and 11<sup>th</sup> Street, N.W., and Sherman Avenue, N.W. in Ward 1, as Theodore "Ted" Williams Alley.

DDOT does not foresee any operational impact that these designations would have on the District-wide transportation network. Therefore, DDOT supports each of these symbolic designations and the department stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of these Bills being enacted.

#### Conclusion

Funds are sufficient in the fiscal year 2016 and the proposed fiscal year 2017 through fiscal year 2020 budget and financial plan to implement the bill.

#### Background

The bill designates the north-south alley located in the block bordered by Irving Street, N.W. on the north, Sherman Avenue, N.W. on the east, Columbia Road, N.W. on the south, and 11<sup>th</sup> Street, N.W. on the west as Theodore "Ted" Williams Alley.<sup>1</sup> Ted Williams was a Ward 1 resident and community leader. A planned mixed-used condominium and office building will use the new designation as its address.<sup>2</sup>

#### **Financial Plan Impact**

Funds are sufficient in the fiscal year 2016 and the proposed fiscal year 2017 through fiscal year 2020 budget and financial plan to implement the bill. The designation requires two installed signs and two ceremonial signs. The sign installations and ceremonial signs will cost approximately \$360, which the District Department of Transportation can absorb within its existing resources.
