I. BACKGROUND AND NEED

On May 2, 2017, Bill 22-272, the "Richard Rausch Way Designation Act of 2017" was introduced by Councilmember Bonds to symbolically designate the 200 block of 2nd Street S.E., in Ward 6, as "Richard Rausch Way." A symbolic naming typically involves designating and posting a name for a street or alley that shall be in addition to and subordinate to any name that is an official name.

¹ As introduced, Bill 22-272 officially designated the 200 block of 2nd Street S.W. as "Richard Rausch Way." However, the Committee Print of Bill 22-272 has been changed to reflect that the designation is a symbolic designation, as the initiator originally intended. The bill has also been modified to designate the 200 block of 2nd Street S.E., not S.W., as "Richard Rausch Way," which is in line with what the initiator and community supporters envisioned for this naming.

Background and Need

Richard Rausch was a longtime congressional aide who was active in national and D.C. Democratic Politics for 50 years.² Mr. Rausch was a native Iowan and served in the U.S. Army during the Korean War. He started calling the District of Columbia home in the 1950s when he moved here to begin his lifelong career in public service. Mr. Rausch served as the National Director of the Young Democrats during the John F. Kennedy Administration, championing the participation of young people in the democratic process. He then worked for former Iowa Democratic Representatives Neal Smith and Phil Burton³ and later as the Doorkeeper of the United States House of Representatives until his retirement in 1995.⁴ Additionally, Mr. Rausch served as an employee of VISTA (now known as AmeriCorps) to help other Americans help themselves.

Mr. Rausch served as Chair of the Ward 6 Democrats, Vice Chair of the DC Democratic State Committee, a member of the Democratic National Committee, and a national board member of Americans for Democratic Action. He was present at every Democratic National Convention during his lifetime, beginning with the Stevenson-Kefauver Convention of 1956. Mr. Rausch was a founding member of the Gertrude Stein Democratic Club that was established in 1976. The Gertrude Stein Democratic Club is "the voice of lesbian, gay, bisexual, and transgender (LGBT) Democrats in the District" and the one of the oldest Democratic clubs in the city." Mr. Rausch was honored as one of only three persons to be named as an "Honorary Life Member" of the club.

Mr. Rausch was a long-standing supporter and activist for DC Statehood and Voting Rights and served as a delegate to the DC Constitutional Conventions.⁶ He was an early and open advocate for LGBTQ rights, women's rights, worker's rights, immigrants' rights, and human rights through leadership actions and donations to these causes. Mr. Rausch passed on May 29, 2007 and is remembered as "a friend, advocate, and leader for many progressive issues, both at home in the District, and across the nation."⁷

Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including

streets and alleys.⁸ In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.⁹

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes, ¹⁰ whereas a "symbolic name" for a street or alley shall be in addition to and subordinate to any name that is an official name. ¹¹ An official name of an alley shall contain the suffix "Alley" or "Court." A symbolic name of a street or alley shall contain only the suffix "Way" or "Plaza." As established by Bill 22-272, "Richard Rausch Way" is a symbolic street designation for the 200 block of 2nd Street S.E., in Ward 6.

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming. ¹⁴ On August 14, 2017, ANC 2C was put on notice of the public hearing based on the location of the designation as introduced in Bill 22-272, "the 200 block of 2nd Street S.W." However, at the September 20, 2017 public hearing, it was clarified that the initiator's intent was to designate the 200 block of 2nd Street S.E., not S.W., where Mr. Rausch resided. After the hearing, Councilmember Bonds' office put the correct ANC, ANC 6B on notice of the designation and the ANC was given an opportunity to comment. The correct location of the designation is reflected in the committee print. Lastly, prior to consideration of a designation by the Council, the Mayor shall provide to the Council a surveyor's plat of the alley or street and adjacent properties. ¹⁵

After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation ("DDOT") shall install signage indicating the symbolic name of the alley or street, or portion thereof. Additionally, the Surveyor of the District of Columbia shall record a copy of such act and the Surveyor's plat in the Office of the Surveyor.¹⁶

Symbolically designating the 200 block of 2nd Street S.E., in Ward 6, where Mr. Rausch once lived, will recognize, honor, and celebrate his memory, passion, and service to Democratic politics and unwavering efforts to advance full voting representation and self-determination for the District of Columbia. Thus, the Committee of the Whole recommends the approval of Bill 22-272, the "Richard Rausch Way Designation Act of 2017."

III. POSITION OF THE EXECUTIVE

November 21, 2017 The Committee of the Whole marks up Bill 22-272.

Todd McIntyre, Chief of Staff, District Department of Transportation, testified on behalf of the Executive in support of the street designation. His testimony is summarized below.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

On October 11, 2017, ANC 1A unanimously passed a resolution in support of "Richard Rausch Way" to honor Mr. Rausch's contributions to the District. A copy of the resolution is attached to this report.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on Bill 22-272 on Wednesday, September 20, 2017. The testimony summarized below is from that hearing. Copies of written testimony are attached to this report.

Todd McIntyre, Chief of Staff, District Department of Transportation, testified that the Executive supports Bill 22-272. He stated that DDOT will install signage indicating the designation and stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize.

The Committee received a statement from Chuck Burger in support of the "Richard Rausch Way" designation. The Gertrude Stein Democrats also approved and submitted a resolution in support of the designation. Copies of the statement and resolution are attached to this report. The Committee received no testimony or comments in opposition to Bill 22-272.

VI. IMPACT ON EXISTING LAW

Bill 22-272 has no impact on existing law. D.C. Official Code § 9-204.01¹⁷ authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley "that shall be in addition to and subordinate to any name that is an official name." Bill 22-272 symbolically designates the 800 block of G Street N.W., in Ward 6, as "Richard Rausch Way." Additionally, "a symbolic name of a street or alley shall contain only the suffix Way or Plaza," such as the name proposed by Bill 22-272. ¹⁹

Lastly, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years.²⁰ Mr. Rausch passed away in 2007, ten years ago.

VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2018 through fiscal year 2021 budget and financial plan to implement the provisions of the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is an estimated \$60 per official sign for fabrication and \$110 for installation, the cost of Bill 22-272 can be absorbed, as noted in the Fiscal Impact Statement (attached).

Good afternoon, Chairman Mendelson, councilmembers, staff, and District residents. My name is Todd McIntyre, Chief of Staff at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Interim Director Jeff Marootian regarding the following three alley designation bills:

- Bill 22-219, Paul S. Devrouax, Jr. Way Designation Act of 2017
- Bill 22-272, Richard Rausch Way Designation Act of 2017
- Bill 22-336, Lincoln Court Designation Act of 2017

The stated purpose of Bill 22-219 is to officially designate the 800 block of G Street N.W., in Ward 2, as Paul S. Devrouax, Jr. Way. As per the requirements of DC Act 21-489, Section 421(g), I have attached to this testimony a copy of the surveyor's plat showing the 800 block of G Street N.W to be designated as Paul S. Devrouax, Jr. Way.

The cost of each installed sign is approximately \$170 (\$60 for sign fabrication and \$110 for sign installation). DDOT is able to absorb the costs of these signs within its current budget, and does not foresee any operational impact this designation would have on the District's transportation network.

Therefore, the Administration supports this official designation. Upon approval by the Council, and following the effective date of the act, DDOT will install signage indicating the official name of the alley. DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of this bill's passage.

The next bill I would like to testify on is Bill 22-272, Richard Rausch Way Designation Act of 2017. The stated purpose of this bill is to officially designate the 200 block of 2nd Street, S.W., in Ward 6, between the blocks of Independent Ave S.W. and C Street S.W., as Richard Rausch Way. As per the requirements of DC Act 21-489, Section 421(g), attached to this testimony please find a copy of the surveyor's plat showing the portions of the alley network to be officially designated as Richard Rausch Way.

The cost of each installed sign is approximately \$170 (\$60 for sign fabrication and \$110 for sign installation). DDOT is able to absorb the costs of these signs within its current budget, and does not foresee any operational impact this designation would have on the District's transportation network.

Therefore, the Administration supports this official designation. Upon approval by the Council, and following the effective date of the act, DDOT will install signage indicating the official name of the alley. Again, DDOT will assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of this bill's passage.

And finally, the last bill I would like to testify on is Bill 22-336 Lincoln Court Designation Act of 2017. The stated purpose of this bill is to officially designate the alley in Square 762, bounded by the 200 blocks of 2nd and 3rd Streets, S.E., and the 200 blocks of C Street and Pennsylvania Avenue, S.E., in Ward 6, as Lincoln Court. An official naming typically involves the designation of postal addresses and the primary entrance for residences or offices. As per the requirements of DC Act 21-489, Section 421(g), attached to this testimony please find a copy of the surveyor's plat showing the portions of the alley network to be officially designated as Lincoln Court.

DDOT is able to absorb the costs of these signs within its current budget.

The cost of each installed sign is approximately \$170 (\$60 for sign fabrication and \$110 for sign installation). DDOT does not foresee any operational impact this designation would have on the District's transportation network.

Therefore, the Administration supports this official designation. Upon approval by the Council, and following the effective date of the act, DDOT will install signage indicating the official name of the alley and will assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of this bill's passage. DDOT will also work with the appropriate District agencies -- including Fire and Emergency Medical Service, Homeland Security and Emergency Management Agency, and the Office of the Chief Technology Officer -- to update the relevant records used for way-finding or address purposes to reflect the official name of the alley.

This concludes my testimony. Thank you for allowing me the opportunity to testify before you today, and I am available to answer any questions that you may have.
