I. BACKGROUND AND NEED

On February 20, 2018, PR 22-759, the "District of Columbia Corrections Information Council Governing Board Katharine Aiken Huffman Reappointment Resolution of 2018" was introduced by Chairman Mendelson. PR 22-759 was referred to the Committee of the Whole on March 6, 2018. The purpose of PR 22-759 is to reappoint Ms. Huffman as a member of the District of Columbia Corrections Information Council Governing Board ("Board") for a 2-year term to end May 4, 2020.

Ms. Huffman is a Ward 3 resident of the District of Columbia. Ms. Huffman received her Bachelors of Arts in psychology from Emory University and her Juris Doctorate from Yale Law School. After completing her law degree, Ms. Huffman clerked for the Honorable Martha Craig Daughtrey and then served as Soros Justice Fellow at the Southern Center for Human Rights in Atlanta, Georgia. During her fellowship, Ms. Huffman represented inmates in civil rights litigation, challenging lack of access to medical and mental health services, inhumane conditions

of confinement, and unconstitutional criminal justice practices. Following her fellowship, Ms. Huffman worked for the Drug Policy Alliance, where she established the first state-level office of the Drug Policy Alliance and served as National Director and lead strategist on all state-level initiatives for the Alliance. Additionally, Ms. Huffman has served as a consultant to the National Prison Rape Elimination Commission. Currently Ms. Huffman is a Principal at the Raben Group, LLC, where she assists clients, generally non-profit advocacy organizations, in identifying policy goals, creating strategic plans, building organizational programming, expanding coalition partnerships, and implementing public policy educational and lobbying campaigns. In addition, she serves on the board of directors of the Justice Policy Institute and the Southern Center for Human Rights.

The District of Columbia Corrections Information Council ("CIC") was created by Congress in the 1997 National Capital Revitalization and Self-Government Improvement Act ("Revitalization Act") for the purpose of investigating generally the conditions of the District of Columbia sentenced felon population scattered throughout the Bureau of Prisons ("BOP") facilities following the closing of the Lorton Correctional Complex. The CIC's role was expanded by the Jail Improvement Act of 2003¹, which requires the CIC to conduct inspections of local correctional facilities and mandates that the Department of Corrections ("DOC") provide access to members of the CIC, its staff, designees, and agents for this purpose, including unmonitored interviews of inmates.

As the Revitalization Act transferred the District's sentenced felon population to the BOP, a large number of District residents formally housed at the Lorton Correction Complex were dispersed to penal institutions throughout the county. Thus the District is unlike any other state in that its state-sentenced felons are not incarcerated within (and many are not even near) its borders. Over 4,700 District residents are incarcerated in over 116 BOP facilities in 33 states. Approximately 2,100 District residents are in the custody of DOC.² Having an effective, well-funded mechanism to monitor the treatment of District prisoners is essential so that this population receives proper treatment and necessary resources and programs.

In 2010, the Council approved the Corrections Information Council Amendment Act of 2010³ ("2010 Act"), which restructured the CIC by creating the Board and an independent Executive Director position, and provided subordinate personnel. The 2010 Act vested in the Executive Director several responsibilities that had been with the appointed members of the former CIC.⁴ The Executive Director acts as the investigator as well as ombudsman, looking at conditions, responding to complaints, and making recommendations to the Board.⁵

The role of the Board is to provide advice and information to the Director of the Bureau of Prisons and the Director of the Department of Corrections regarding matters affecting District of

Columbia inmates.⁶ In addition, the Board is tasked with reviewing the findings of the Executive Director and making recommendations, where appropriate, regarding the conditions of confinement of District of Columbia inmates in both BOP and DOC custody.⁷ The Board is also tasked with giving final approval of the Executive Director's annual report to the Director of the BOP, the Director of the DOC, the Council, and the Mayor regarding the conditions of confinement of District of Columbia inmates.⁸

The Board consists of five members: three appointed by the Mayor and two by the Council of the District of Columbia. He Mayor designates the Chairperson of the Board. Members of the Board shall serve for terms of two years. All members of the Board serve without compensation. He

Ms. Huffman was first appointed to the Board on May 4, 2012. ¹³ The Council reappointed her to the Board on December 22, 2017 for a term to end on May 4, 2018. ¹⁴ Due to Ms. Huffman's term ending on May 4, 2018, Chairman Mendelson filed PR 22-759 to extend her term to May 4, 2020. Because the Committee held a public roundtable on Ms. Huffman's previous reappointment resolution (PR 22-563) this past November, the Committee believes that another public another roundtable would be unecessary. However, the Committee did send Ms. Huffman questions regarding her reappointment and her responses are attached to this Report.

If reappointed Ms. Huffman plans to continue to work to ensure the wellbeing of incarcerated District residents. Ms. Huffman believes one of the greatest challenges confronting the Board is being able to get a complete accounting of the conditions of the facilities were District

residents are incarcerated since they are located throughout the country. 15 She indicated because of the challenges she will recommend that the CIC develop a series of thematic reports which will allow the Board to gather District residents experiences in the different facilities to better assist the Board in making recommendations on how to improve the conditions of confinement for District residents. 16 Further, she added that these reports could lead to better coordination of services for District residents who not only are incarcerated but are also preparing to be released from confinement. 17

Since being first appointed in 2012 Ms. Huffman has helped the CIC establish and maintain good relationships with the BOP and DOC and was instrumental in guiding the CIC when it was restructured. Based on her impressive credentials and dedication to public service, the Committee recommends the reappointment of Ms. Huffman to the District of Columbia Corrections Information Council Governing Board. Not only does Ms. Huffman have a keen awareness regarding inmate confinement, conditions, and treatment, but her policy background will be instrumental in continuing to aid the CIC. The Committee recommends adoption of PR 22-759.

VII. FISCAL IMPACT

PR 22-759 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 24-101.01(b)(2)(E), members of the Board are not entitled to compensation.

Thank you to you and the Council for nominating me for reappointment to the Corrections Information Council (CIC). I am looking forward to serving in this capacity. In preparation for the upcoming public hearing on my reappointment, I am happy to provide the following responses to the questions provided.

- 1. I have not previously filed a Financial Disclosure Statement with the Office of Campaign Finance.
- 2. I do not have a beneficial interest valued in excess of \$5000 with any business entity transacting business with the District Government.
- 3. Neither anyone in my family nor I has received (or is receiving) any income for services rendered in excess of \$1000 during the past two years from any business entity transacting any business with the District Government.
- 4. Neither anyone in my family nor I serves as an officer, director, partner, or agent of any business entity transacting business with the District Government.
- 5. Neither anyone in my family nor I have any outstanding liabilities in excess of \$5000 other than loans from federal or state insured financial institutions (i.e., mortgages through banks).
- 6. My husband John Rusciolelli and I are the owners of real property in the District of Columbia at 2635 Woodley Place NW, Washington, DC 20008 (residence).
- 7. I am a member of the Tennessee Bar Association, the Georgia Bar Association, and the Alabama Bar Association, and have professional licenses with each one.
- 8. See #7.
- The only board or commission connected with the District government on which I have served is the Corrections Information Council (the position for which I have been nominated for reappointment).
- 10. I am a member of the board of directors for two nonprofit organizations: the Justice Policy Institute (based in D.C.) and the Southern Center for Human Rights (based in Atlanta, GA).
- 11. I do not have any outstanding liability for taxes, fees, or any other payments to the District, federal, or other state or local governments.
- 12. Neither any member of my family nor I have any interest, financial or otherwise, that may directly or indirectly pose a conflict of interest for me in the performance of my duties on the CIC.
- 13. Over the past five years, I have made political contributions to a local candidate totaling \$150 (\$100 in June 2014, \$50 in October 2014) to "Friends of Courtney R. Snowden."
- 14. I am registered to lobby with the federal government. I am in full compliance with all applicable lobby registration and reporting obligations.

15. The CIC plays an important role in improving the wellbeing of District residents who are incarcerated. Since the CIC was reconstituted in 2012, the work of the agency (such as gathering information about the treatment of D.C. residents; conducting inspections of facilities; and reporting out to the public, the Council, the Mayor, and other stakeholders) has provided much-needed support to and information for incarcerated residents and their families, and can play a key role in contributing to improved treatment and services for incarcerated D.C. residents as well as to improved public safety for all District citizens. Thanks to the leadership and support of the Council and the Mayor's office, our staff capacity and other resources have increased; and, combined with the recent authorization of an additional two board members (bringing us from three to five in total), we are better able to fulfill our mandate. We are extremely grateful to the Council and Mayor for this support.

Since the CIC was reconstituted in 2012, we have been able to establish ourselves as a resource to our D.C. community. That said, we continue to face challenges primarily related to the large number of District residents who are incarcerated, and to the incredibly diverse settings in which they are held. D.C. residents are held in the many facilities of the federal Bureau of Prisons, the D.C. Department of Corrections, and numerous halfway houses and other facilities. It is a challenge to visit all these facilities with any regularity; and even more of a challenge to gather all the necessary documents, reports, and information needed to prepare our reports on them.

Because of these challenges, my current priorities for service on the Board will focus on shortand long-term planning, and on identifying the priorities for our work that will be most
impactful for the District community. I anticipate that a key component of that prioritization
will be the development of a series of "thematic reports," which will allow us to gather
information about District residents' experiences in a number of different facilities and identify
recommendations that could serve to improve conditions of confinement for many people in
multiple locations. These reports could address topics such as the health and safety of, and the
services provided to, particularly vulnerable populations (such as children and young people,
people with disabilities, people with mental health needs, etc.); or the provision and
coordination of services provided to District citizens both during their incarceration and in
preparation for reentry.

Thank you again for the opportunity to serve as a CIC board member, and for nominating me for reappointment. Please let me know if you need any further information from me. I look forward to continuing to work with the Council, the Executive branch, and the D.C. community on these important issues.
