#### I. BACKGROUND AND NEED

On March 28, 2018, PR 22-815, the "Citizen Review Panel Elizabeth Corson Mohler Appointment Resolution of 2018" was introduced by Chairman Mendelson. PR 22-815 was referred to the Committee of the Whole on April 10, 2018. The purpose of PR 22-815 is to appoint Ms. Mohler as a member of the Citizen Review Panel for a three-year term.

Ms. Mohler is a Ward 3 resident. Ms. Mohler received her Bachelor of Arts from Yale University and her Master of Social Welfare from the University of California, Los Angeles. Currently, she serves as the Director of Social Services at the Latin American Youth Center (LAYC). In this position she provides leadership for LAYC's mental health and substance use disorders treatment program. Previously, she served as the clinical supervisor at LAYC. In addition, Ms. Mohler previously was employed as a senior supervisory social worker at Foundations for Home and Community and as a social worker in the adult behavioral clinic at

Walter Reed Medical Center. Furthermore, she served as Treasurer of the Board of Directors of the National of Association of Social Workers, Metro DC Chapter.

In 2004, the Council approved the Child in Need of Protection Amendment Act (2004 Act). The purpose of the 2004 Act was to reform the District's child protection law. More importantly, the goal of the Council was to create a seamless and effective system for responding to any type of child mistreatment, whether it was child abandonment, abuse, or neglect. One of the outcomes of the 2004 Act was to codify the establishment of the Citizen Review Panel (Panel). The Panel serves as an independent oversight body for the District's child welfare system and to evaluate the District government agencies involved in child protection as well as services provided by vendors.

Prior to the 2004 Act, the Panel was created administratively because Congress mandated that states and other jurisdictions establish such Panels by July 1999 pursuant to the Child Abuse Prevention and Treatment Act (CAPTA).<sup>4</sup> The requirement to establish a Panel was necessary to continue to receive CAPTA funds.<sup>5</sup> As required by CAPTA, the Panel evaluates the District's child protection standards pursuant to a state plan required by the federal government and pursuant to child protection standards set by federal law.

The Panel consists of 15 members, all of whom must be District residents.<sup>6</sup> The Mayor is required to appoint eight members of the Panel and must designate the Chairperson. The Council shall appoint seven members to the Panel and is required to designate the Vice Chairperson.<sup>7</sup> Furthermore, the Panel is required to be broadly representative of the community and must include members that have expertise in the prevention and treatment of child abuse and neglect.<sup>8</sup> In addition, the appointments to the Panel should have a diversity of professional backgrounds and must be familiar with the child welfare system.<sup>9</sup>

Ms. Mohler wants to serve on the Panel because she is committed to its mission and wants to be of assistance in evaluating the strengths and weaknesses of those organizations involved in child protection and child welfare. Moreover, she wants to serve on the Panel because she has an interest in the health and well-being of District residents. Ms. Mohler believes her experience working with District youth who are at risk of becoming involved in the foster care system will allow her to contribute to the work of the Panel. She testified at the April 12<sup>th</sup> roundtable that the Child and Family Services Agency (CFSA) has gotten better, but they still need improvement. As a member of the Panel she would like to help improve the services provided by CFSA.

The Committee believes Ms. Mohler's significant experience as a social worker and her direct experience with CFSA will make her an invaluable addition to the Panel. Ms. Mohler's knowledge of CFSA and with District youth who have been subject to abuse and neglect would help guide the Panel to provide greater oversight over the District's child welfare system. Mr. Mohler' extensive working knowledge of the District's current child welfare system makes her a perfect addition to the Panel and for those reasons the Committee recommends adoption of PR 22-815.

*Ms. Elizabeth Corson Mohler, Appointee*, testified and answered questions from Chairman Mendelson regarding her background and experience as it pertains to the Citizen Review Panel and her interest in serving on the Panel.

The Committee received no testimony or comments in opposition to Ms. Mohler's appointment.

#### VI. IMPACT ON EXISTING LAW

Members of the Citizen Review Panel are appointed pursuant to section 351 of the Prevention of Child Abuse and Neglect Act of 1977, effective April 12, 2005 (D.C. Law 15-341; D.C. Official Code § 4-1303.51), which establishes the Panel.

### VII. FISCAL IMPACT

PR 22-815 will have no fiscal impact on the District of Columbia budget or financial plan. Members of the Citizen Review Panel are not entitled to compensation.
