27	act may be cited as the "Office of Public-Private Partnerships Delegation of Authority

29	Sec. 2. Section 201(f) of the Procurement Practices Reform Act of 2010, effective April
30	8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-352.01(f)), is amended by striking the phrase
31	"requirements of this act" and inserting the phrase "requirements of this act, except as provided
32	in section 201(e) of the Public-Private Partnership Act of 2014, effective March 11, 2015 (D.C.
33	Law 20-228, D.C. Official Code § 2-272.01(e))".
34	Sec. 3. Section 102 of the Public-Private Partnership Act of 2014, effective March 11,
35	2015 (D.C. Law 20-228, D.C. Official Code § 2-272.01) is amended by adding a new subsection
36	(e) to read as follows:

37	"(e)(1) The Office may delegate to the Office of Contracting and Procurement ("OCP"),
38	at the discretion of OCP, the authority to serve as the contracting officer for the Office for
39	public-private partnership agreements entered into pursuant to this act and to carry out other
40	contracting functions related to public-private partnerships on behalf of the Office.
41	"(2) Any OCP employee exercising authority delegated pursuant to this
42	subsection shall comply with the provisions of this act and any rules and regulations promulgated
43	to effectuate this act.
44	Sec. 4. Applicability.
45	This act shall apply as of June 1, 2017.
46	Sec. 5. Fiscal impact statement.
47	The Council adopts the fiscal impact statement of the Council Budget Director as the fiscal
48	impact statement required by section 4a of the General Legislative Procedures Act of 1975
49	approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
50	Sec. 6. Effective date.
51	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
52	the Mayor, action by the Council to override the veto), a 30-day period of congressional review
53	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
54	24, 1973 (87 Stat. 813; D.C. Official Code § 1-602.02(c)(1)), and publication in the District of
55	Columbia Register.
56	(b) This act shall expire after 225 days of its having taken effect.
