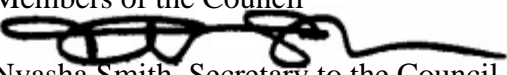



A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To symbolically designate the 200 block of 10th Street, N.E., bounded by C Street, N.E., and Constitution Avenue, N.E., in Ward 6, as Outlaw Way.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Outlaw Way Designation Act of 2018".

Sec. 2. Designation.

Pursuant to sections 401, 403a, and 423 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code §§ 9-204.01, 9-204.03, and 9-204.21) ("Act"), the Council symbolically designate the 200 block of 10th Street, N.E., bounded by C Street, N.E., and Constitution Avenue, N.E., in Ward 6, as "Outlaw Way" in recognition of Mrs. Pocahontas Outlaw, and the long-term contributions that she and her family created in their community. Mrs. Outlaw played a strong role in supporting her community by volunteering to help improve the lives of low-income families, feeding and caring for those in the greatest of need. Her unique role in promoting social capital and community spirit in Capitol Hill serves as an inspiration for all.

Sec. 3. Transmittal.

37 The Council shall transmit a copy of this act, upon its effective date, to the Mayor,
38 the District Department of Transportation, and the Office of the Surveyor.

39 Sec. 4. Fiscal impact statement.

40 The Council adopts the fiscal impact statement in the committee report as the fiscal
41 impact statement required by section 4a of the General Legislative Procedures Act of 1975,
42 approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

43 Sec. 5. Effective date.

44 This act shall take effect following approval by the Mayor (or in the event of veto by
45 the Mayor, action by the Council to override the veto), a 30-day period of congressional
46 review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved
47 December 24, 1973 (87 Stat. 813; D.C. Official Code §1-206.02(c)(1)), and publication in
48 the District of Columbia Register.
