25	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
26	act may be cited as the "Office of Public-Private Partnerships Delegation of Authority
27	Congressional Review Emergency Amendment Act of 2018".
28	Sec. 2. Section 201(f) of the Procurement Practices Reform Act of 2010, effective April
29	8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-352.01(f)), is amended by striking the phrase
30	"requirements of this act" and inserting the phrase "requirements of this act, except as provided
31	in section 102(e) of the Public-Private Partnership Act of 2014, effective March 11, 2015 (D.C.
32	Law 20-228; D.C. Official Code § 2-272.01(e))" in its place.
33	Sec. 3. Section 102 of the Public-Private Partnership Act of 2014, effective March 11,
34	2015 (D.C. Law 20-228, D.C. Official Code § 2-272.01), is amended by adding a new subsection
35	(e) to read as follows:

36	"(e)(1) The Office may delegate to the Office of Contracting and Procurement ("OCP"),
37	at the discretion of OCP, the authority to serve as the contracting officer for the Office for
38	public-private partnership agreements entered into pursuant to this act and to carry out other
39	contracting functions related to public-private partnerships on behalf of the Office.
40	"(2) Any OCP employee exercising authority delegated pursuant to this
41	subsection shall comply with the provisions of this act and any rules and regulations promulgated
42	to effectuate this act.".

44	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
45	statement required by section 4a of the General Legislative Procedures Act of 1975, approved
46	October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
47	Sec. 5. Effective date.
48	This act shall take effect following approval by the Mayor (or in the event of veto by the

Mayor, action by the Council to override the veto), and shall remain in effect for no longer than

90 days, as provided for emergency acts of the Council of the District of Columbia in section

412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
