I. BACKGROUND AND NEED

On September 17, 2018 PR 22-996, the "Commission on Health Equity Alicia Wilson Reappointment Resolution of 2018" was introduced by Chairman Mendelson. The purpose of PR 22-996 is to reappoint Ms. Alicia Wilson as a Council appointee to the Commission on Health Equity ("Commission") for a three-year term to end on July 7, 2020.

Currently, Ms. Wilson is the Executive Director at La Clinica del Pueblo ("La Clinica"). As Executive Director, Ms. Wilson works to ensure that La Clinica provides "basic health services from a culturally competent perspective." In addition to her work at La Clinica, Ms. Wilson

serves as Treasurer for the Institute for Public Health Innovation and Vice-President for the DC Primary Care Association.

The Commission on Health Equity is the successor to the Commission on Health Disparities, established pursuant to the Commission on Health Disparities Establishment Act of 2014, effective March 10, 2015 (D.C. Law 20-192; D.C. Official Code § 7-755.01 *et seq.*). The Commission on Health Disparities was tasked with looking at ways to prevent chronic diseases, which "account for the huge disparities in health among residents in the city." The Committee on Health noted that chronic diseases account for 6 out of 10 deaths in the city, and that African-Americans and residents of Ward 5, 7, and 8 are most likely to be impacted by chronic diseases. Furthermore, the report on the bill indicates that even though chronic diseases are common they are preventable through proper health care. The Commission on Health Disparities was to look at ways to improve the health outcomes of all residents of the District. Unfortunately, no one was ever appointed to the Commission on Health Disparities.

In 2016, the Council approved a subtitle in the Fiscal Year 2017 Budget Support Act⁶ that repealed the Commission on Health Disparities and re-established the Commission as the Commission on Health Equity. The purpose of the re-established Commission is to examine health equity issues in the District and to advise the Department of Health, the Council, and the Mayor on solutions to address health inequities that exist in the District.⁷ The Commission is required to meet at least once a quarter to share findings regarding health disparities that exist in each ward of the District.⁸

The Commission consists of 17-members, 9 of whom are voting members. Six of the voting members are appointed by the Mayor, and three voting and three non-voting members are appointed by the Council of the District of Columbia. The three non-voting members appointed by the Council must be community advisory members, one each from Wards 5, 7, and 8. The other non-voting advisory members of the Commission are: the Chairperson of the Council committee with jurisdiction over the Department of Health; one patient organization representative; the presidents or chief executive officers of two District hospitals, or their designees; and a representative from an insurance company, or his or her designee. The Mayor is responsible for appointing the Chairperson of the Commission from among the voting members.

Appointed members of the Commission "shall have expertise in at least one of the following areas: (A) Health equity, social determinants, and health disparities; (B) Social and human services and vulnerable populations; (C) Early learning and education; (D) Minority communities and population health outcomes and improvement; (E) Economic and community development; and (F) Ecology and the natural and built environment."¹⁴

Ms. Wilson was first appointed to the Commission on July 7, 2017 for a one-year term. ¹⁶ Due to Ms. Wilson's term ending on July 7, 2018, Chairman Mendelson filed PR 22-996 to extend her term to July 7, 2020. Because the Committee held a public roundtable on Ms. Wilson's previous appointment resolution (PR 22-244) last year, the Committee believes that another public

roundtable is unecessary. However, the Committee did send Ms. Wilson questions regarding her reappointment and her responses are attached to this Report.

If reappointed, Ms. Wilson will continue to advise the Department of Health on programs and approaches to better advance health equity. She plans to use her experience working on cross-sector initiatives to address racial equity at the local level and immigrant inclusion issues to inform her work as a member of the Commission. Ms. Wilson is thrilled to be a member of the Commission, which she helped established, and wants to remain a member of the Commission to continue to improve the Department of Health by helping it apply an equity lens to focus on ways to improve the health of all District residents. 19

The Committee continues to support Ms. Wilson's perspective to address health equity issues in the District. Further, the Committee believes Ms. Wilson meets the statutory requirements to serve another term as a member of the Commission pursuant to D.C. Official Code § 7-756.01(3)(A), (B), and (D) as she has an expertise in: health equity, social determinants, and health disparities; social and human services and vulnerable populations; and minority communities and population health outcomes and improvement.

Pursuant to Council Rule 277, all Council appointees must be District residents or shall become District residents within 180 days after the effective date of the appointment. Furthermore, Council Rule 277 provides that the appointees must reside in the District for the duration of their appointment. Ms. Wilson is not a District resident, as she resides in Hyattsville, Maryland. The proposed resolution proposes to waive Council Rule 277 to appoint Ms. Wilson to the Commission. The Committee believes the expertise Ms. Wilson brings to the Commission necessitates that Council Rule 277 be waived in order to allow Ms. Wilson to serve on the Commission. The Committee recommends waiving Council Rule 277 and recommends adoption of PR-996.

III. POSITION OF THE EXECUTIVE

Ms. Wilson is the Council's appointee to the Board. The Executive provided no comment on Ms. Wilson's reappointment.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 22-996.

V. SUMMARY OF TESTIMONY

There was no public testimony since the Committee did not hold a public hearing on PR 22-996. However, a roundtable was held May 16, 2017 on Ms. Wilson's appointment to the term she is now serving. Pursuant to Council Rule 501, hearings are not required for resolutions before final adoption by the Council. The Committee received no comments in opposition to PR 22-996.

VI. IMPACT ON EXISTING LAW

Voting Members of the Commission on Health Equity appointed by the Council are appointed pursuant to section 5043(b)(2) of the Commission on Health Equity Amendment Act of 2016, effective October 8, 2016 (D.C. Law 21-160; D.C. Official Code § 7-756.01(b)(2)).

VII. FISCAL IMPACT

PR 22-996 will have no fiscal impact on the District of Columbia budget or financial plan. Members of the Commission on Health Equity are not entitled to compensation.

VIII. SECTION-BY-SECTION ANALYSIS
