# I. BACKGROUND AND NEED

On March 22, 2019, PR 23-201, the "Citizen Review Panel Emily Smith Goering Reappointment Resolution of 2019" was introduced by Chairman Mendelson. The purpose of PR 23-201 is to reappoint Dr. Goering as a member of the Citizen Review Panel for a three-year term to end on April 11, 2022.

Dr. Goering is a Ward 7 resident. Dr. Goering received her Bachelor of Science in social work from Bethel College, a Master of Social Work from the University of Texas, School of Social Work, and Doctor of Social Work from the University of Maryland, School of Social Work. Currently, Dr. Goering serves as an implementation specialist for the National Adoption Competency Mental Health Training Initiative. In this role, Dr. Goering provides support to states, tribes, and child welfare organizations to help them effectively support children, youth, and their foster, adoptive, and guardianship families. Dr. Goering's research includes child welfare

workforce issues, organizational culture and climate in child welfare systems, and foster care reentry. In addition, she is a member of the Society for Social Work Researchers and is the Board Treasurer for the Mennonite Central Committee-East Coast.

In 2004, the Council approved the Child in Need of Protection Amendment Act (2004 Act). The purpose of the 2004 Act was to reform the District's child protection law. More importantly, the goal of the Council was to create a seamless and effective system for responding to any type of child mistreatment, whether child abandonment, abuse, or neglect. An outcome of the 2004 Act was to codify the establishment of the Citizen Review Panel (Panel). The Panel serves as an independent oversight body for the District's child welfare system, to evaluate the District government agencies involved in child protection as well as services provided by vendors.

Prior to the 2004 Act, the Panel was created administratively because Congress mandated that states and other jurisdictions establish such Panels by July 1999 pursuant to the Child Abuse Prevention and Treatment Act (CAPTA).<sup>4</sup> The requirement to establish a Panel was necessary to continue to receive CAPTA funds.<sup>5</sup> As required by CAPTA, the Panel evaluates the District's child protection standards pursuant to a state plan required by the federal government and pursuant to child protection standards set by federal law.

The Panel consists of 15 members, all of whom must be District residents.<sup>6</sup> The Mayor is required to appoint eight members of the Panel and must designate the Chairperson. The Council shall appoint seven members to the Panel and is required to designate the Vice Chairperson.<sup>7</sup>

Further, the Panel is required to be broadly representative of the community and must include members who have expertise in the prevention and treatment of child abuse and neglect.<sup>8</sup> In addition, the appointees to the Panel should have a diversity of professional backgrounds and must be familiar with the child welfare system.<sup>9</sup>

Dr. Goering was first appointed as a member and Vice Chairperson of the Panel in 2016.<sup>10</sup> Since first being appointed Dr. Goering has been involved with the Panel's In-Home Services Work Group. The Work Group evaluates the quality of services provided to some of the highest risk families served by the Child and Family Services Agency (CFSA).<sup>11</sup> Dr. Goering believes that building the capacity of the Panel is essential to provide the proper oversight and accountability to properly monitor the quality of services provided to CFSA clients.<sup>12</sup> She testified at the May 23<sup>rd</sup> roundtable that she wants to serve a new term as a member of the Panel, but not as Vice Chairperson.

The Committee believes that Dr. Goering, as a foster parent and an experienced social worker, will continue to bring a unique perspective to the Panel. She can draw on her own experiences to help the Panel conduct its oversight responsibilities to ensure that CFSA better serves children who have been subject to abuse or neglect. The Committee also supports Dr. Goering's ongoing efforts to ensure that the CFSA is not just offering services to a multitude of families, but the services that are provided are of high-quality and will help families get the support they need to exit the CFSA system. For all of these reasons, the Committee recommends adoption of PR 23-201.

*Emily Smith Goering, Appointee*, testified and answered questions from Chairman Mendelson regarding her background and experience as it pertains to the Citizen Review Panel and her interest in serving another term on the Panel.

The Committee received no testimony or comments in opposition to Dr. Goering's reappointment.

#### VI. IMPACT ON EXISTING LAW

Members of the Citizen Review Panel are appointed pursuant to section 351 of the Prevention of Child Abuse and Neglect Act of 1977, effective April 12, 2005 (D.C. Law 15-341; D.C. Official Code § 4-1303.51), which establishes the Panel.

#### VII. FISCAL IMPACT

PR 23-201 will have no fiscal impact on the District of Columbia budget or financial plan. Members of the Citizen Review Panel are not entitled to compensation.

#### VIII. SECTION-BY-SECTION ANALYSIS

Section 1 States the short title of PR 23-201.

Section 2 Confirms the reappointment of Dr. Emily Smith Goering as a member of the Citizen Review Panel to serve for a three-year term to end on April 11, 2022.

Section 3 Requires that a copy of the resolution, upon adoption, be transmitted to the appointee, the chairperson of the Panel, and to the Mayor.

<u>Section 4</u> Provides that PR 23-201 shall take effect immediately upon the first date of publication in the District of Columbia Register.

During the time I have been involved on the CRP (over 4 years) panel has struggled to maintain consistent leadership and membership. MOTA and Council have struggled to make timely appointments of membership and the panel has often gone long periods of time with only partial fulfillment of positions, including key chair and vice chair roles. Despite this low capacity the panel has continue achieve some of its goals. I have been involved in the CRP In-Home Services Work Group, a group committed to assessing the quality of services provided to 'In-Home' families. This population is a priority for the panel as these families constitute around 60% of CFSA clients and are some of the highest risk families served by the agency. In addition, building the capacity of leadership and increasing membership on the panel is a priority in order to be able to review other important elements of CFSA, such as foster care and intake programs. We cannot just be focused on improvements in CFSA 'numbers' we must also assess the quality of services being provided to families and children. Through CRP we have the opportunity to provide this type of accountability.
