Law 23-1; 18 66 DCR 5539), the Council approves the multiyear award of the five (5) year base period of 19 Contract No. CFOPD-19-C-041 with Intralot, Inc. for Sports Wagering, Lottery Gaming Systems 20 and Related Services to the Office of the Chief Financial Officer, Office of Lottery and Gaming. 21 (b) The award of the contract is for one (1), five (5) year base term in the not-to-exceed 22 amount of \$215,000,000. 23 Sec. 3. The Council adopts the fiscal impact statement as required by section 4a of the 24 General Legislative Procedures Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. 25 Official Code § 1-301.47a). 26 Sec. 4.
