#### I. BACKGROUND AND NEED

Proposed Resolution 23-334, the "Board of Industrial Trades Shawn Ellis Confirmation Resolution of 2019," was introduced by Chairman Mendelson at the request of the Mayor on May 21, 2019 and referred to the Committee of the Whole. The purpose of PR 23-334 is to confirm the Mayor's nomination of Ms. Tanya Lewis for appointment to the Board of Industrial Trades, replacing Robert Louis Smith, to serve the remainder of an unexpired term to end June 26, 2021.

The Board of Industrial Trades was established to protect the public health, safety, and welfare of the citizens of the District by ensuring that individuals engaged in industrial trades have the specialized skills and training required to perform such activities for the public. The Board governs asbestos workers, plumbers, electricians, refrigeration and air conditioning mechanics, steam and operating engineers, and those in the elevator trades. The Board may establish bonding and insurance requirements, subcategories of licensure, education and experience requirements for licensure, and impose other requirements.

The Board is comprised of 15 tradespersons who are appointed by the Mayor and licensed in the District: three plumbers, two electricians, two refrigeration and air conditioning mechanics, two steam engineers, two asbestos workers, one elevator mechanic, one elevator inspector, one elevator contractor, and one consumer member.

Ms. Lewis currently works at American University where she is a Master Electrician within the Energy and Engineering Department. Previously, she worked at the District of Columbia Housing Authority, and the Department of Consumer and Regulatory Affairs. Additionally, Ms. Lewis is President and owner of TRULITE Electrical Services, LLC, a full-service electrical contracting firm with a Certified Business Enterprise (CBE) certification in the District. Ms. Lewis currently holds a Master Electrician license in the District and is a member of the International Brotherhood of Electrical Workers (IBEW) Local #26. Ms. Lewis meets the qualifications for appointment, and he has expressed a commitment to serve. Accordingly, the Committee recommends confirmation.

- May 28, 2019 PR 23-334 is "read" at a Committee of the Whole meeting; on this date the referral of the PR to the Committee of the Whole is official and the 90-day period for Council review begins. If this measure is not acted upon by the Council before July 13, PR 23-334 will be deemed approved.
- May 31, 2019 Notice of Intent to Act on PR 23-334 is published in the *DC Register*.
- June 14, 2019 Notice of the public roundtable is published in the *DC Register*.

#### June 25, 2019 The Committee of the Whole holds a public roundtable on PR 23-334.

July 9, 2019 The Committee of the Whole marks-up PR 23-334.

#### **III. POSITION OF THE EXECUTIVE**

Ms. Lewis is the Mayor's nominee for appointment to the Board of Industrial Trades.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on PR 23-334 on Tuesday, June 25, 2019. The testimony summarized below is from that hearing. Submitted copies of testimony are attached to this report.

*Tanya Lewis* testified before the Committee that she would like to help create more opportunities for women to enter the trades through her service on the Board.

#### VI. IMPACT ON EXISTING LAW

The Board of Industrial Trades is established pursuant to D.C. Code § 47-2853.06(d). PR 23-334 is an exercise of the Council's discretion to approve or disapprove Mayoral nominations to Boards and Commissions, pursuant to the Confirmation Act of 1978 (D.C. Law 2-142; D.C. Code § 1-523.01).

#### VII. FISCAL IMPACT

The Office of the Chief Financial Officer indicates that a Fiscal Impact Statement is not needed for a confirmation. Board members are not compensated for their service.
