### I. BACKGROUND AND NEED

On May 17, 2019, Bill 23-303, the "Al and Mary Arrighi Way Designation Act of 2019" was introduced by Councilmember Allen to symbolically designate the alley in Square 965, in Ward 6, as Al and Mary Arrighi Way. Typically, a symbolic naming is for ceremonial purposes and shall be in addition to and subordinate to any name that is an official name.

Al Arrighi was born in Pawtucket, Rhode Island but spent most of his adult life in the District of Columbia. He taught in District of Columbia Public Schools and also had a 30-year career with the Department of Defense working on education policy for the armed services. However, he was probably best known for his commitment to his Capitol Hill neighborhood where he was sometimes referred to as the Mayor of the 100 block of 10<sup>th</sup> Street, N.E. Mr. Arrighi died on December 20, 1998 and the Council subsequently acted to symbolically name the alley in the square where his home stood as "Al Arrighi Way." <sup>1</sup>

The Committee Report for that legislation stated: "In memory of Al Arrighi, who with his wife Mary, contributed greatly to the improvement and unity of their neighborhood, the residents of the 100 blocks of 10<sup>th</sup> and 11<sup>th</sup> streets, N.E., and the 1000 block of Massachusetts and Constitution Avenues, N.E., petitioned the Council to designate the alley in that square in his honor."

After her husband's passing, Mary Arrighi carried on her and Al's leadership in the community. She continued to greet new arrivals on the block and organize neighborhood gatherings. Mary Arrighi was also born in Pawtucket, Rhode Island. She and Al met while she was a teenager and they were married in 1966. Before coming to the District, Mary studied nights to complete her Bachelor's degree and then earned her Master's in Public Policy, all while raising two children and working at the University of New Hampshire.<sup>2</sup>

Mary Arrighi passed away on September 1, 2017. Shortly thereafter, many of her and Al's neighbors who had been the beneficiaries of her continued leadership in the neighborhood petitioned the Council to add her name to the symbolic designation of the alley named for her late husband. As was testified to extensively at a public hearing on the proposal, the couple were unified in their leadership in the neighborhood and the community is very much supportive of updating the symbolic name to include her. The attached testimony speaks directly from those who knew Mary Arrighi of her contributions to the community.

### Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys.<sup>3</sup> In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.<sup>4</sup>

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes,<sup>5</sup> whereas a "symbolic name" for a street or alley shall be in addition to and subordinate to any name that is an official name.<sup>6</sup> An official name of an alley shall contain the suffix "Alley" or "Court." A symbolic name of a street or alley shall contain only the suffix "Way" or "Plaza." As established by Bill 23-303, "Al and Mary Arrighi Way" is a symbolic street designation for the alley located in Square 965.

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming. On November 7, 2017 ANC 6A was put on notice by the office of Ward 6 Councilmember Charles Allen who introduced Bill 22-586. In addition, the ANC had already voted to support such a naming on October 12, 2017.

Prior to consideration of a designation by the Council, the Mayor shall provide to the Council a surveyor's plat of the alley or street and adjacent properties. <sup>10</sup> This has been done, and the plat is attached to this report. After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation ("DDOT") shall install signage indicating the symbolic name of the alley or street, or portion thereof. Additionally, the Surveyor of the District of Columbia shall record a copy of such act and the Surveyor's plat in the Office of the Surveyor. <sup>11</sup>

Symbolically designating the alley in Square 965 as Al and Mary Arrighi Way will honor the legacy of Al and Mary Arrighi. Thus, the Committee of the Whole recommends the approval of Bill 23-303, the "Al and Mary Arrighi Way Designation Act of 2019."

### III. POSITION OF THE EXECUTIVE

Todd McIntyre, Chief of Staff, Office of the Director, District Department of Transportation, testified that the Executive has "no objection" to the street designation. His testimony is attached as well as summarized below.

### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

Advisory Neighborhood Commission 6A voted 6-0 in support of the symbolic designation contained in Bill 23-303. A letter memorializing that vote is attached.

### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 22-586 on Monday, February 26, 2018. The testimony summarized below pertains to Bill 22-586 (reintroduced as Bill 23-303). Pursuant to Council Period 23 rule 501(a)(2), an additional hearing on Bill 23-303 is not required.

Copies of written testimony are attached to this report.

*Mike Soderman, Commissioner, ANC 6A03*, testified in support of Bill 23-586 and noted that ANC 6A was supportive of the symbolic designation for both Al and Mary Arrighi.

*Jeff Fletcher, Public Witness*, testified in support of Bill 23-586 and described Ms. Arrighi's commitment to the neighborhood.

*Mark J. Ugoretz, Public Witness*, testified in support of Bill 23-586 and his desire to commemorate both Al and Mary Arrighi with the designation.

The Committee received written testimony which is attached to this report. The Committee received no testimony or comments in opposition to Bill 23-303.

### VI. IMPACT ON EXISTING LAW

Bill 23-303 has no impact on existing law. D.C. Official Code § 9-204.01<sup>12</sup> authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley "that shall be in addition to and subordinate to any name that is an official name." Bill 23-303 symbolically designates the 1300 Block of W Street, N.W. as "Al and Mary Arrighi Way." Additionally, "a symbolic name of a street or alley shall contain only the suffix Way or Plaza," such as proposed by Bill 23-303. Lastly, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. Mr. Arrighi died in 1998 and Ms. Arrighi died in September 2017.

### V. VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2019 through fiscal year 2022 budget and financial plan to implement the provisions of the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is an estimated \$60 per official sign for fabrication and \$110 for installation, the cost of Bill 23-303 can be absorbed, as noted in the Fiscal Impact Statement (attached).

### VIII. SECTION-BY-SECTION ANALYSIS

Section 1	States the short title of Bill 23-303.
Section 2	Symbolically designates the alley in Square 965 as "Al and Mary Arrighi Way."
Section 3	Adopts the Fiscal Impact Statement.
Section 4	Establishes the effective date by stating the standard 30-day congressional review language.

To symbolically designate the alley located in Square 965 located between 10th Street N.E. and 11th Street, N.E., and Constitution Avenue, N.E., in Ward 6, as Al and Mary

Arrighi Way.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That

this act may be cited as the "Al and Mary Arrighi Way Designation Act of 2017".

Sec. 2. Designation.

Pursuant to sections 401, 403a, and 423 of the Street and Alley Closing and

Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official

Code §§ 9-204.01, 9-204.03a, and 9-204.23), the Council symbolically designates the alley

located in Square 965, between 10th Street, N.E., and 11th Street, N.E., and Constitution

Avenue, N.E., in Ward 6, as "Al and Mary Arrighi Way".

Sec. 3. Transmittal.

The Council shall transmit a copy of this act, upon its effective date, to the Mayor,

Testimony of Jeff Fletcher on B22-0586, Al and Mary Arrighi Designation Act of 2017 February 26, 2018

My name is Jeff Fletcher, and I have lived in the 100 block of 10<sup>th</sup> Street, NE, for the past 37 years. I am pleased to appear before you today to support the Al and Mary Arrighi Designation Act of 2017.

Mary Arrighi was the kindest, most generous, and most caring neighbor anyone could wish for. For more than 25 years, Mary welcomed new neighbors to the block, was actively involved in establishing and maintaining our neighborhood traditions, and was always available to help a neighbor in need.

Mary was the keeper of our neighborhood list, which has now become a listserv. She was the driving force behind our annual neighborhood events—a spring picnic, a fall Italian dinner, and a January progressive dinner.

As former ANC Commissioner Holmes will note, Mary cared deeply about the physical infrastructure of the neighborhood as well as its people.

Mary also was a person of strong faith. For decades she attended St. Joseph's Catholic church, and she also worked there for several years after her retirement helping to lead the church through a major capital development campaign. She often had church officials over to her house for a home-cooked meal.

Mary's husband, Al, died unexpectedly just after Christmas in 1998. Like Mary, Al was a friend to all. We called him the mayor of the block. We and the council honored him by designating the alley where we had so many neighborhood events in his name. After Al's death Mary continued to take the lead on our neighborhood activities, right up until her untimely death in early September of last year.

It seems fitting that we honor and commemorate Mary Arrighi by including her in the alley name. Mary and Al Arrighi represent what makes our city and its neighborhoods true communities that we all want to live in and support.

On behalf of the many neighbors who signed a petition requesting this re-naming, I urged the Committee of the Whole and the Council to adopt this legislation.

Mr Chairman, members of the Council, thank you for the opportunity to testify.

My name is Mark Ugoretz and I live at 1000 Massachusetts Ave NE, on the same block that Al and Mary Arrighi lived for so long.

When my wife and I moved into my present home, Mary and Al Arrighi were the first to welcome us to the neighborhood. We were very pleased, of course, but taken somewhat aback since we had merely moved from across Massachusetts Avenue, a distance of about 100 feet, where we had lived the previous 20 years.

But, it was clear that this was Al and Mary's block and we were in a new village.

Mary was the neighborhood's powerhouse, organizer, a greeter, and welcomer. She made new and old welcome, and she was the leader in our community.

She pushed hard, as former ANC Commissioner David Holmes would testify, for safer intersections, alley repairs, tree trimming and safer sidewalks.

Arrighi Alley was named originally for Mary's husband, Al, the "mayor" of our little village. He and Mary made everyone feel a part of our community. Al was a gregarious story teller, and a great cook, feeding 50 of us at a time with his homemade lasagna for the alley parties he and Mary worked on.

Al and Mary started the alley parties as a way of keeping us together, so that we all would know our neighbors. She started the listserv that still keeps us in touch with one another.

After Al died, Mary became even more active in the community, focusing on the elegant restoration of nearby St. Joseph's Catholic Church.

All of us in the neighborhood miss Mary very much. Her sudden passing was a shock and something of the heart of the neighborhood is gone.

We want to commemorate and remember her life and spirit by adding her name to the alley on her block. It may seem like a small thing for a busy Council, but we very much want new neighbors to ask about the name of the alley, tell her story, and ensure the continuation of the sense of neighborhood for newcomers as well as us old timers.

On behalf of her neighbors who have signed a petition, we ask that her life and spirit be commemorated by adding her name to that of Al's on our alley.

Mary was our neighborhood's motive power, our organizer. In addition to her taking the lead on our communal activities, she was always pushing for efforts to improve the safety and welfare of our area. When I was her Commissioner, she pushed for safer intersections, alley repairs, tree trimming, and better sidewalks. These are all things a good Commissioner pays attention to, but Mary made sure I was on top of the safety issues.

Arrighi Alley was named for Mary's husband AI, who had been affectionately known as the Mayor of our community, our greeter and our humorist. He tried to know everyone and to introduce everyone. Mary was very unhappy the alley's drainage was poor to non-existent. Twice a year we gather in the alley for shared food and camaraderie, bringing food and families, enjoying fun together, and welcoming newcomers. But water often often filled the center gathering area - so bad that it was named Lake Arrighi. I could do no wrong after I arranged a Mayoral visit and fix for the problem.

Mary was strongly active in the wider community, focusing on the restoration of St. Joseph's Catholic Church. She spent much time during her last years caring for her grandchildren who had lost their mother to disease.

We miss her. Her sudden death was a shock. And, something of the heart of our neighborhood is gone.

We wish to commemorate her life and spirit by adding her name to the Alley on her block. I ask the Committee of the Whole and the Council, on behalf of the many neighbors who signed a petition requesting this renaming, to adopt this Bill.

Good morning Chairman Mendelson, members of the Council, staff, and District residents. My name is Todd McIntyre, and I am Chief of Staff at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Director Jeff Marootian regarding Bill 22-586, the "Al and Mary Arrighi Way Designation Act of 2017."

The stated purpose of Bill 22-586 is to symbolically designate the alley located between 10th Street NE and 11th Street NE and Constitution Avenue NE in Ward 6 as *Al and Mary Arrighi Way*. As per the requirements of DC Act 21-489, Section 421(g), I have attached to this testimony a copy of the surveyor's plat showing square public alley located in square 965.


In fiscal terms, the cost of each installed sign for this designation is approximately \$170 (\$60 for sign fabrication and \$110 for sign installation). This installation will require three signs. DDOT is able to absorb the costs of these signs within its current budget and does not foresee any operational impact this designation would have on the District's transportation network.

The Historic Preservation Office within the Office of Planning has indicated that the alley within Square 965 was historically known as Tenth Alley and is so designated on historic maps. Alternatively, it was also known as Everyley's Alley and Getts Alley, as indicated in a 1912 Inventory of Inhabited Alleys in the District

Testimony of Todd McIntyre on Bill 22-586, the Al and Mary Arrighi Way Designation Act of 2017 of Columbia. The Committee might consider recording that this designation would change the historical name in honor of Al and Mary Arrighi.

The Administration has no objection to these designations, and DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of this Bill being passed.
