# I. BACKGROUND AND NEED

On June 24, 2019, PR 23-398, the "Mayor's Council on Physical Fitness, Health, and Nutrition Katrina Owens Appointment Resolution of 2019" was introduced by Chairman Mendelson. The purpose of PR 23-398 is to appoint Ms. Katrina Owens as a Council appointee to the Mayor's Council on Physical Fitness, Health, and Nutrition ("Mayor's Council") for a three-year term.

Ms. Owens is a Ward 4 resident of the District of Columbia. Ms. Owens received her Bachelor of Science from Eastern Mennonite University and her Master of Science from George Mason University. She currently serves as the Chief of Staff for DC Scores. In this role, Ms. Owens oversees, develops, and manages partnerships that supports over 3,000 participants. In addition, she is responsible for all finances and budget developments for DC Scores. Before joining DC Scores, Ms. Owens was a District of Columbia Public School Teacher. Ms. Owens is also a member of the Healthy Youth and School Committee and the Ward 4 Arts, Humanities, and Creative Economy Committee.

The Mayor's Council was established as an advisory body in 2011 with the goal of promoting physical fitness and good nutrition in order to improve the health and wellness of District residents.<sup>1</sup> The legislation was necessary to address the high obesity rates in the District which translated into higher rates of chronic diseases and posed a significant financial strain on the health care infrastructure.<sup>2</sup> According to the Department of Health in 2007, 15 percent of deaths in the District were linked to excess weight, poor nutrition, and physical inactivity, and more District residents die each year due to obesity-related chronic disease than from AIDS, cancer, and homicide combined.<sup>3</sup>

The Department of Health still considers obesity to be a local epidemic. More than half of the adults living in the District are obese, and 72 percent of residents living in Wards 7 and 8 are considered obese.<sup>4</sup> The Mayor's Council is essential to address these issues. Even though the District has the second lowest adult obesity rate in the country, the obesity rate has increased approximately 10 percent in the past 20 years.<sup>5</sup> Further, the District's obesity rate for children aged 10 to 17 years old is the 18<sup>th</sup> highest in the nation.<sup>6</sup> The Mayor's Council provides advice on ways the District can lower the obesity rate especially with regards to the obesity rate of youth residing in the District.

The Mayor's Council consists of 25-members, five of whom are appointed by the Council and 14 of whom are appointed by the Mayor.<sup>7</sup> Appointed members of the Mayor's Council serve 3-year terms and shall have experience related to physical fitness, health, or nutrition.<sup>8</sup> The Mayor of the District of Columbia, the Chancellor of the District of Columbia Public Schools, the Chair of the Public Charter School Board, and the Directors of the Department of Parks and Recreation, the Department of Aging, and the Department of Health or their designees also serves as members of the Mayor's Council.<sup>9</sup> The Mayor is responsible for designating one of the members to serve as the Chairperson.

As a member of the Mayor's Council Ms. Owens plans to work with other members to improve the health and wellness of all District residents through the promotion of physical activity and healthy eating.<sup>10</sup> She believes that her unique background as a former teacher, a current District of Columbia Public School parent, and as Chief of Staff of DC Scores will help prepare her to support the mission of the Mayor's Council.<sup>11</sup> Ms. Owens testified that during her entire professional career she has worked with families to create opportunities for young people to participate in organized sports to get physically fit.<sup>12</sup>

The Committee believes that Ms. Owens' extensive experience working with youth to ensure that they have the proper resources to lead a healthy and fit life would be a positive addition to the Mayor's Council. Furthermore, the Committee supports Ms. Owens' belief that creating a

system for young people to learn and find success requires them to make healthy lifestyle decisions.<sup>13</sup> Moreover, Ms. Owens meets the statutory requirements to serve as a member of the Mayor's Council pursuant to D.C. Official Code § 7-121(b)(2)(ii)), as she has experience related to physical fitness. The Committee recommends adoption of PR 23-398.

Ms. Owens is the Council's appointee to the Mayor's Council. The Executive provided no comment on Ms. Owens' appointment.
