# I. BACKGROUND AND NEED

On May 21, 2019, Proposed Resolution 23-330, the "Washington Convention and Sports Authority Board of Directors Alan Bubes Confirmation Resolution of 2019" was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 23-330 would confirm the Mayor's nomination of Mr. Alan Bubes for reappointment as a member to the Washington Convention and Sports Authority Board of Directors for a four-year term to end May 16, 2023.

Mr. Bubes is a Ward 3 resident. He earned a Bachelor of Science in Industrial Management from the Georgia Institute of Technology. Mr. Bubes served as President and CEO of Linens of the Week from 1986 to until 2012 when the company was sold. Linens of the Week was one of the largest Linen Suppliers to the Food Service Industry in the country. Prior to working at Linens of the Week, Mr. Bubes served as General Manager for the Northeast Region for the Aramark Corporation and as General Manager of the Unifirst Corporation. In addition, he serves as a member of the Board of Directors for First Tee of Washington DC, the Youth Baseball Academy, and the Adas Israel Congregation.

The Washington Convention and Sports Authority (Events DC) was established as an independent authority of the District government pursuant to the Washington Convention Sports Authority and Sports and Entertainment Commission Merger Amendment Act of 2009, effective March 3, 2010 (D.C Law 18-111; D.C. Official Code § 10-1201.01 *et seq.*) (the Act). The Act merged the DC Sports and Entertainment Commission with the Washington Convention Center Authority, which was established in 2004, to create one organization to promote the District as a key sports, entertainment, and special events destination.

The mission of Events DC is two-fold: (1) generate economic and community benefits for the District by creating the premier event experience; and (2) promote Washington, D.C. as a world-class tourist destination. Events DC owns, operates, and serves as the landlord for the Walter E. Washington Convention Center (Convention Center), the Historic Carnegie Library at Mount Vernon Square (Carnegie Library), the Robert F. Kennedy Memorial Stadium (RFK) including the RFK Festival Grounds and the Skate Park at RFK, the DC Armory, the Entertainment and Sports Arena (ESA), the Gateway DC and R.I.S.E. Demonstration Center, and Nationals Park.

Events DC is governed by the Washington Convention and Sports Authority Board of Directors (Board), which is comprised of 12 members. The purpose of the Board is not only to

govern Events DC, but to develop policies for the management, maintenance, and operation of the convention center and District sports and entertainment facilities.<sup>1</sup>

Of the 12 members, three members which include the Chief Financial Officer of the District of Columbia, the President of the Hotel of Washington, DC, and an individual designated by the Mayor serve as ex-officio voting members.<sup>2</sup> The Mayor is required to appoint nine public members, all of whom shall be District residents, to the Board with the advice and consent of the Council.<sup>3</sup> Public members of the Board are appointed to four-year terms.<sup>4</sup> Of the nine public members, one shall be from the hotel industry, one shall be from the restaurant industry, one shall be from organized labor, and the remaining six shall have proven expertise in municipal finance, business finance, economic development, construction, sports, entertainment, or tourism.<sup>5</sup>

Mr. Bubes was first appointed to the Board in 2015 for a term to end May 16, 2019.<sup>6</sup> As a member of the Board, Mr. Bubes has endeavored to ensure that Events DC is fiscally prudent, continues to fulfill its role to bring business to the District, and creates a great environment for District residents.<sup>7</sup> If reappointed, Mr. Bubes will advocate that the Board continue to work closely with the Chief Financial Officer, the Executive, and the Council to address some of the challenges facing the Board and Events DC.<sup>8</sup> He also believes that his experiences that include owning a business in the District and his 30 plus years as a resident of the District gives him the necessary tools to help Events DC contribute to making the District one of the greatest cities.<sup>9</sup>

The Committee believes Mr. Bubes meets the requirements to serve as a member of the Board pursuant to D.C. Official Code § 10-1202.05(a)(3) as he has an expertise in business finance. Furthermore, his extensive background in the hospitality industry and his passion for sports, restaurants, and finance will continue to bring a useful perspective to the Board. The Committee recommends adoption of PR 23-330.

90-day period for Council review begins. If this measure is not acted upon by the Council before October 28, 2019, PR 23-330 will be deemed disapproved.

- May 31, 2019 Notice of Intent to Act on PR 23-330 is published in the *District of Columbia Register*.
- September 17, 2019 The Committee of the Whole marks-up PR 23-330.

# III. POSITION OF THE EXECUTIVE

Mr. Alan Bubes is the Mayor's nomination for reappointment to the Washington Convention and Sports Authority Board of Directors.

# V. SUMMARY OF TESTIMONY

Members of the Washington Convention and Sports Authority Board of Directors are appointed pursuant to Section 205 of the Washington Convention Center Authority Act of 1994, effective September 28, 1994 (D.C. Law 10-188; D.C. Official Code § 10-1202.05).

# VII. FISCAL IMPACT

PR 23-330 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 10-1202.05(k), members of the Washington Convention and Sports Authority Board of Directors are not entitled to compensation.
