# I. BACKGROUND AND NEED

On June 24, 2019, PR 23-400, the "Mayor's Council on Physical Fitness, Health, and Nutrition Rosalyn Overstreet Gonzalez Appointment Resolution of 2019" was introduced by Chairman Mendelson. The purpose of PR 23-400 is to appoint Ms. Rosalyn Overstreet Gonzalez as a Council appointee to the Mayor's Council on Physical Fitness, Health, and Nutrition ("Mayor's Council") for a three-year term.

Ms. Gonzalez is a Ward 1 resident of the District of Columbia. Ms. Gonzalez received her Bachelor of Arts from Howard University and her Juris Doctor from the University of the District of Columbia David A. Clarke School of Law. She is a member of the DC Bar, the Pennsylvania Bar, and the Black Public Defender Association. Ms. Gonzalez currently serves as a Staff Attorney and Recruitment and Training Coordinator for the Public Defender Service for the District of

Columbia. Her work for the Public Defender Service includes representing indigent clients before the U.S. Parole Commission and the Superior Court of the District of Columbia, and developing training courses and materials for attorneys and law students in conjunction with the DC Bar. In addition, she serves as the Chairwoman of the DC State Athletics Commission and Chair of the Board of Directors of the College Trunk. She is also a Board member for the Multicultural Career Internship Program, the Light the Way Foundation, CentroNia, and the Educational Foundation of the Whittemore House.

The Mayor's Council was established as an advisory body in 2011 with the goal of promoting physical fitness and good nutrition in order to improve the health and wellness of District residents.<sup>1</sup> The legislation was necessary to address the high obesity rates in the District which translated into higher rates of chronic diseases and posed a significant financial strain on the health care infrastructure.<sup>2</sup> According to the Department of Health in 2007, 15 percent of deaths in the District were linked to excess weight, poor nutrition, and physical inactivity, and more District residents die each year due to obesity-related chronic disease than from AIDS, cancer, and homicide combined.<sup>3</sup>

The Department of Health still considers obesity to be a local epidemic. More than half of the adults living in the District are obese, and 72 percent of residents living in Wards 7 and 8 are considered obese.<sup>4</sup> The Mayor's Council is essential to address these issues. Even though the District has the second lowest adult obesity rate in the country, the obesity rate has increased approximately 10 percent in the past 20 years.<sup>5</sup> Further, the District's obesity rate for children aged 10 to 17 years old is the 18<sup>th</sup> highest in the nation.<sup>6</sup> The Mayor's Council provides advice on ways the District can lower the obesity rate especially with regards to the obesity rate of youth residing in the District.

The Mayor's Council consists of 25-members, five of whom are appointed by the Council and 14 of whom are appointed by the Mayor.<sup>7</sup> Appointed members of the Mayor's Council serve 3-year terms and shall have experience related to physical fitness, health, or nutrition.<sup>8</sup> The Mayor of the District of Columbia, the Chancellor of the District of Columbia Public Schools, the Chair of the Public Charter School Board, and the Directors of the Department of Parks and Recreation, the Department of Aging, and the Department of Health or their designees also serves as members of the Mayor's Council.<sup>9</sup> The Mayor is responsible for designating one of the members to serve as the Chairperson.

If appointed, Ms. Gonzalez will work with the Mayor's Council on creating strategies and meaningful tools that will allow District residents to focus on their own health, nutrition physical fitness, and wellness. <sup>10</sup> Ms. Gonzalez wants to serve because she believes in the Mayor Council's mission to improve the health, physical fitness, and nutrition for all District residents. <sup>11</sup> As a public defender she has seen the detrimental impact outcomes for individuals who lack adequate information regarding health and nutrition and she plans to address this issue as a member of the Mayor's Council. <sup>12</sup>

The Committee believes that Ms. Gonzalez's experience as a supporter of athletics and health education will be a welcomed addition to the Mayor's Council. Moreover, Ms. Gonzalez's role on the DC State Athletics Commission which requires her to focus on the academics, health, and wellness of DC student-athletes will translate well to the work she will complete on the Mayor's Council. Also, Ms. Gonzalez meets the statutory requirements to serve as a member of the Mayor's Council pursuant to D.C. Official Code § 7-121(b)(2)(ii)), as she has experience related to physical fitness and health. For the reasons stated above, the Committee recommends adoption of PR 23-400.

I have a deep connection to the Washington, DC community and am committed to further educating and enlightening myself and the citizens of the District of Columbia on the benefits of health, wellness and physical fitness.

One year ago – I suffered a catastrophic illness – resulting in emergency, life saving surgery and a months long recovery. My illness was a direct result of not being in tune with my body, my family history and my health needs. I have connected with a health and wellness coach and nutritionist – and I intend to chronical my progress, struggles and ultimately my victories. I intend to lead by example.

Professionally, I am a practicing public defender and not surprisingly, I have seen first hand, the detrimental outcomes of the lives of those, who lack adequate information on nutrition and fitness. The end result is a community of people, who do not live their best and most healthy lives. I want to be part of the efforts to change this trajectory.

As I noted earlier, I am very connected to the Washington, DC community. I currently serve as Chair of the DC State Athletics Commission and I work diligently with other concerned citizens to support the academics, health, athletics and wellness of DC student athletes. I would like to do the same in a broader context that considers every resident of the city and if confirmed as a member of the Commission, that will be my primary focus.

Again, I thank you for considering me as a member of the Commission. If t would be a privilege to serve along side others to help to create strategies and meaningful tools that will allow all residents of the District of Columbia to better focus on their own health, nutrition literacy, physical fitness and wellness.
