I. BACKGROUND AND NEED

On June 4, 2019, Bill 23-327, the "James E. Bunn Amphitheater Designation Act of 2019," was introduced by Councilmembers Trayon White, Evans, McDuffie, Todd, Silverman, Bonds, Grosso, Gray, and R. White, to officially designate the amphitheater at Oxon Run Park located at 13th Street and Mississippi Avenue, S.E., in Ward 8, as the James as James E. Bunn Amphitheater. An official naming of a public space typically enables installation of signage.

James Edward Bunn was born on March 1, 1942 in Baltimore, Maryland to James "Jimmy" Bunn and Ethel Rose Bunn. When Mr. Bunn was three years old, he moved in with his grandmother in Battleboro, North Carolina while his parents worked to support their family, and he spent the rest of his childhood years there. After graduating from high school, Mr. Bunn joined the United States Air Force, serving for four years before being honorably discharged in 1964 after sustaining an injury at which point, he came to the Walter Reed Army Medical Center in the District to recuperate. He fell in love with the nation's capital, eventually deciding to call the District his home. On one of his several visits to North Carolina, he met his wife, Linda Cherry and they were married in 1971. They went on to have three children: James II, Sheila, and Rodney.

In 1970, Mr. Bunn purchased what became known as the "Bunn Building" at 3127 Martin Luther King, Jr. Avenue, S.E., in Congress Heights, thereby officially declaring Ward 8 as his home. With his entrepreneurial spirit, Mr. Bunn became a masterful barber. He opened his own barber shop, a barber and beauty supply store, a grocery store, and a carry out at the Bunn Building. Not wanting to keep his keen business sense to himself, Mr. Bunn recruited many people in the neighborhood, particularly seniors from Ballou High School, to work in his shops and teach them how to be skilled employees.

After settling in Ward 8, Mr. Bunn was quick to notice the numerous disparities and inequalities present in the community. He decided to change them, becoming a well-known advocate and activist for neighborhoods in Wards 7 and 8. People in the community knew that he could get things done and many in the neighborhood depended on his business acumen or his extensive list of contacts to bring much-needed and deserved services, amenities, and development to neighborhoods east of the river.

Mr. Bunn's selfless activism prepared him well for leadership roles, including as Chairman of the Board and later Executive Director of the Far Southeast Community Organization (FSECO), Executive Director of the Ward 8 Business Council, board member of the Anacostia Economic Development Corporation, ANC Commissioner for 8D02 for three terms, and member of the Anacostia Coordinating Council for over 15 years. At the time of his death, Mr. Bunn was an appointed member of the DC Retirement Board and Vice Chair of the Board's Strategic Planning Committee, serving as a trustee since being appointed by former Council Chairman John A. Wilson in 1991. At the time of his death, Mr. Bunn had been nominated for a position on the D.C. Water and Sewer Authority Board of Directors (PR 20-185).

Mr. Bunn passed away on August 1, 2013 at the age of 71, leaving behind an enduring legacy in his community and throughout the District of Columbia.

Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, and the naming of public spaces. Specifically, the Act authorizes the Council to designate or change the name of any public space in the District of Columbia.¹ Public spaces include "any public street, alley, circle, bridge, building, park, other public place or property owned by or under the administrative control or jurisdiction of the District of Columbia."²

The Act establishes a notice requirement for the official designation of public spaces; at least 30 days prior to the scheduled public hearing, the initiator of the proposed designation shall submit a copy of the legislation for review and comment to each Advisory Neighborhood

Commission ("ANC") in which the public space is located. Regarding Bill 23-327, ANC 5E was notified of the proposed name on October 28, 2019. On November 4, 2019, the Committee received a letter from ANC 8E expressing support for the James E. Bunn Amphitheater Designation.

The Act also promulgates requirements that the Mayor must meet prior to consideration of a public space designation by the Council. First, the Mayor shall provide the Council with comments on the proposed designation submitted by any District agency with jurisdiction over the public space to be designated.³ DPR, which will have jurisdiction over the park when completed, attended the November 26, 2019 hearing on Bill 23-327 and submitted comments as part of its testimony, thus meeting this requirement. Second, prior to consideration of a designation by the Council, the Mayor shall provide to the Council a surveyor's plat showing the public space to be designated, including any adjacent and abutting squares to the designation.⁴ The Office of the Surveyor provided the Council with a plat of the designation prior to the hearing of the Committee of the Whole and subsequently provided an updated plat reflecting the amphitheater itself rather than the whole square. That updated plat is attached to this report.

In addition, the Act requires that "No public space in the District of Columbia shall be given the same name as that given another public space in the District." In 2015, the Council adopted the "James Bunn Way Designation Act of 2015" which symbolically designated the 3100 block of Esther Place, S.E. as James Bunn Way. That designation predated the 2016 amendments to the Act, and there are other cases of pre-2016 designations that designated more than one public space for the same person. The designation also received support from other Ward 8 ANCs. In this case, given those limited precedents, and because Bill 23-327 provides for an official designation where the previous designation was symbolic, the Committee recommends waiving this requirement based on the individual circumstances.

After the legislation becomes law and all conditions required by the Council and the Act have been satisfied, the Mayor will install signage denoting the public space name.⁵ The signage shall conform to the policies of the agency with jurisdiction over the public space, in this case DPR.⁶ Additionally, the Surveyor of the District of Columbia shall record a copy of the act and the Surveyor's plat in the Office of the Surveyor.⁷

Officially designating this amphitheater as James E. Bunn Amphitheater will honor Mr. Bunn's dedication to service in the District. Thus, the Committee of the Whole recommends the approval of Bill 23-327, the "James E. Bunn Amphitheater Designation Act of 2019."

II. LEGISLATIVE CHRONOLOGY

June 4, 2019	Bill 22-327, the "James E. Bunn Amphitheater Designation Act of 2019" is co-introduced at a legislative meeting by Councilmember Gray, Bonds, Evans, Grosso, McDuffie, Silverman, Todd, R. White, and T. White and is referred to the Committee of the Whole.

January 17, 2020	The Committee of the Whole marks up Bill 23-327.

III. POSITION OF THE EXECUTIVE

Ella Faulkner, Deputy Director of Administrative Services, Department of Parks and Recreation, testified that the Executive supports the proposed designation. Her testimony is attached as well as summarized below.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

Advisory Neighborhood Commission 8E submitted a letter on behalf of the entire ANC expressing community support for the proposed naming by a vote of 3-0-1. ANC 8A adopted a resolution at its November 21, 2019 meeting supporting the proposed naming with a quorum present by unanimous vote. ANC 8C submitted a letter on behalf of the entire ANC expressing community support for the proposed naming by a unanimous vote. ANC 8D adopted a resolution at its November 21, 2019 meeting supporting the proposed naming with a quorum present by unanimous vote. ANC 8C submitted a letter on behalf of the entire ANC expressing community support for the proposed naming by a unanimous vote. ANC 8D adopted a resolution at its November 21, 2019 meeting supporting the proposed naming with a quorum present by majority vote.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 23-327 on Thursday, November 26, 2019. The testimony summarized below pertains to Bill 23-327.

Copies of written testimony are attached to this report.

Sheila Bunn, Daughter of James Bunn, testified in support of the proposed designation and described Mr. Bunn's integral role in bringing the second largest collection of Cherry Blossom trees to the District in Oxon Run Park near the amphitheater.

Charlie Whitaker, Public Witness, testified in support of the proposed designation.

Cornelia Harris, Public Witness, testified in support of the proposed designation.

Ella Faulkner, Deputy Director for Administrative Services, Department of Parks and Recreation, testified that the Executive supports the designation.

The Committee received no testimony or comments in opposition to Bill 23-327.

VI. IMPACT ON EXISTING LAW

Bill 23-327 has no impact on existing law. D.C. Official Code § 9-204.01 authorizes the Council to designate (i.e. name) any public space, including facilities.⁸ Further, the Act generally provides that no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years.⁹ Mr. Bunn passed away in 2013.

VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2020 through fiscal year 2023 budget and financial plan to implement the provisions of the proposed legislation. DPR testified that fabrication of signage for the new park can be absorbed, as noted in the Fiscal Impact Statement (attached).

VIII. SECTION-BY-SECTION ANALYSIS

Testimony of Sheila E. Bunn in Support of Bill 23-327, the "James E. Bunn Amphitheater Designation Act of 2019"

Good Morning Chairman Mendelson and other members of the Committee. 1 am Sheila Bunn, daughter of the late James E. Bunn. 1 am here to testify in support of Bill 23-327, the "James E. Bunn Amphitheater Designation Act of 2019," introduced on June 4, 2019 by Ward 8 Councilmember Trayon White, Sr.

Before I begin my testimony, I'd like to thank Councilmember White for introducing this bill, the Friends of Oxon Run Park, specifically, Mr. Absalom Jordan and Brenda Richardson, for their continued work with the park and honoring of my father with this tribute, and the DC Building Industry Association for recently upgrading and beautifying the amphitheater and surrounding area. Additionally, the Bunn family is grateful to ANCs 8A, 8B, 8C, 8D, and 8E for passing resolutions in support of this bill.

James E. Bunn unexpectedly departed this life on Thursday, August 1, 2013, in Southwest, Washington, DC. He was born on March 1, 1942 to the late James "Jimmie" Bunn and Ethel Mills Bunn in Baltimore, Maryland. Educated in North Carolina, James admirably joined the US Air Force upon graduation from high school. James sacrificed four years of his young life to serve his country until he was honorably discharged in 1964 as a result of a medical injury. While receiving treatment for his injury at Walter Reed Army Medical Center, James fell in love with the District of Columbia and decided to plant roots in the Nation's Capital. Soon thereafter, his first child, Dionne Byers, was born.

Although James would call the District his new home, he never lost touch with his North Carolina roots, traveling frequently to the Tar Heel State. Good fate would place Linda Cherry in North Carolina for a weekend visit to cross paths with James. Their love blossomed into marriage and they became one in 1971. From this precious union, three children were born, Sheila, James II, and Rodney Bunn.

The year before, in 1970, James made Ward 8 his home and he set his sights on purchasing what is now the Bunn Building. James always had an entrepreneurial spirit and that translated into a long history of business endeavors in both the District and North Carolina. After the military, he decided that barbering was his next career choice. Subsequently, James became a licensed master barber and eventually opened and operated his own beauty and barber supply store. Over the years, his keen business sense also motivated him to operate a grocery store and carryout, along with a barber shop in the heart of Congress Heights.

Bunn – as many affectionately called him – quickly recognized and sought to resolve the disparities in his beloved Ward 8 community. He became a well-known advocate for Ward 8 residents and the good news about his commitment to bringing services, business and economic development east of the Anacostia River was spread across the city. Bunn's selfless activism propelled him into many leadership roles.

As Chairman of the Board of the Far Southeast Community Organization (FSECO), Bunn highlighted the need for affordable housing and homeownership in Ward 8. And because of his level of commitment, Bunn was later named Executive Director of FSECO. Even as he focused on the lack of affordable housing, Bunn still had his eyes on improving the business climate in Ward 8. From 2007 to 2010, he served as the Executive Director of the Ward 8 Business Council, working with Ward 8 businesses to get bonded and obtain the proper certifications in order to better position themselves for economic and business opportunities. The Ward 8 Business Council eventually folded into the Ward 8 Contractors Business Council, and Bunn continued, as chairman, to serve as an advocate and voice for Ward 8 businesses and CBEs. In addition, he shared his time and talents with the Anacostia Economic Development Corporation as a board member and was a member of the Anacostia Coordinating Council for 15-plus years.

Because he also had his ear to the ground to hear neighbors' concerns, the Bellevue community elected Bunn as an ANC Commissioner. Bunn so believed in helping fellow businessmen, that in 2009 he founded Congress Heights Main Streets (CHMS). As Chairman of the Board, Bunn worked to retain and expand existing businesses and recruit new businesses to set up shop along the Martin Luther King, Jr. Avenue corridor from 4th Street to Milwaukee Place, SE. He was determined to position the organization as a vehicle for creating a thriving economic center on the King corridor.

The impending redevelopment of the west and east campuses at St. Elizabeths promised to spark an economic revitalization and renaissance in Ward 8. James worked closely with the US Department of Homeland Security as a community liaison to resolve any issues surrounding the federal government's consolidation of one of its largest agencies at the historic St. Elizabeths campus. God would have Bunn live to see the fruit of his labors with the opening of the first federal building east of the Anacostia River a few days prior to his death. Bunn also worked tirelessly to ensure that his community was a safe place to live and that residents had a good and cooperative relationship with the police. During his four-year tenure as president of the 7th District Citizens Advisory Council, Bunn provided a forum for dialogue for the community to share its ideas and concerns about crime, violence and other public safety issues.

At the time of his passing, James was a Mayor-appointed Trustee of the District of Columbia Retirement Board (DCRB) and served as Vice Chairman of the Board's Strategic Planning Committee. He had been a DCRB Trustee over the years since he was appointed to the Board in 1991 by John A. Wilson, the late Chairman of the Council of the District of Columbia. He was also set to be sworn in as an alternate member of the District of Columbia Water and Sewer Authority Board.

Whatever you called him – Mr. Bunn, Bunn, James or Jim – everyone knew that this champion for Ward 8 and dedicated advocate for the underserved residents of the District of Columbia got things done! He knew the right people to call to solve any problem. Thus, it is fitting that the amphitheater in Oxon Run Park, home of the second largest cherry blossom tree grove in DC, which he helped to cultivate, bear his name. Chairman Mendelson, I urge you and the entire Council to pass Bill 23-327, the "James E. Bunn Amphitheater Designation Act of 2019." Thank you.

WHEREAS, Mr. Bunn served on many community boards in Ward 8, including the Anacostia Economic Development Corporation and was a 15-year member of the Anacostia Coordinating Council; and

WHEREAS, Mr. Bunn called the Bellevue neighborhood home and served as an Advisory Neighborhood Commissioner where he represented that community.


