Dear Chairman Mendelson:

Pursuant to DC Code §2-352.02 enclosed for consideration and approval by the Council of the District of Columbia is the "University of the District of Columbia (UDC), Contract No. GF-2020-C-0008 Approval Resolution of 2020" and accompanying resolution to approve the award of the proposed contract with Jaggaer, LLC. The contract period of performance will be seven (7) years. The amount of the contract is Two million Four hundred and Sixty-Five Thousand Forty-one Dollars (\$2,465,041). The proposed period of performance is from the date of the award not to exceed December of 2026.

The purpose of this contract is for Jaggaer, LLC to automate UDC's source-to-settle business processes, including integration with Banner and other related systems. Since the system is a single platform, all of UDC's data will be housed in one place, thus eliminating the need to use multiple systems, and avoid high costs associated with manual tracking.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the "University of the District of Columbia, Contract No. GF-2020-C-0008 Approval Resolution of 2020". Sec. 2. Pursuant to §451 of the District of Columbia Government Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Code § 1-204.51(c)(3) and section 202(c) of the Procurement Practices Reform Act of 2010, as amended, D.C. Official Code § 2-352.02(c), the Council approves Contract No. GF-2020-C-C-0008 for the installation and implementation an E-Procurement technology software system that is designated as compatible with the operational parameters of the SunGard/ Banner student information system (SIS) currently implemented at the University.
