I. BACKGROUND AND NEED

On November 26, 2019, Proposed Resolution 23-576, the "Commission on the Arts and Humanities Alma Gates Confirmation Resolution of 2020," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 23-576 would confirm the Mayor's nomination of Ms. Alma Gates for reappointment as a member of the Commission on the Arts and Humanities for a three-year term to end June 30, 2022.

Ms. Gates is a Ward 3 resident. She received her Bachelor of Arts from Maryville University, and a teaching certificate from the Washington Montessori Institute. Prior to retiring, Ms. Gates worked for the National Cultural Alliance where she was involved in conducting a three-

year public awareness campaign on the importance of the arts and humanities to the American public. Ms. Gates also worked for the American Alliance of Museums which is the national organization serving museums and museum professionals. In addition, Ms. Gates served as a Commissioner on ANC 3D from 2002 to 2008 - serving as Chair from 2004 to 2007 - and from 2014 to 2018. Further, she is a trustee of the Committee of 100 on the Federal City and a member of the Spring Valley Restoration Advisory Board.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 *et seq.*). The Commission is an independent agency within the District government and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and encourage programs and the development of programs which promote progress in the arts and humanities.²

The Commission consists of 18 members appointed by the Mayor for three-year terms, with the advice and consent of the Council.³ The Commission is tasked with appointing an Executive Director who serves as the chief administrative office of the Commission.⁴ In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.⁵

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities.⁶ Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the neighborhoods in the District when considering appointments to the Commission.⁷ Further, no employee of the District government can serve as a member of the Commission.⁸

In the Fiscal Year 2020 Budget Support Act of 2019,⁹ the Council approved additional qualification requirements for individuals to be eligible to serve as a member on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission were required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities education; and (3) two members with specific interest, ability, experience in theatre and performing arts.¹⁰ By July 1, 2020, four of the 18 members appointed to the Commission were required to meet the following requirements: (1) two members with specific interest, ability, or

Ms. Gates was first appointed to the Commission in 2012.¹² While serving on the Commission she has focused on finance and public art, and she currently serves as the Chair of the Public Art Committee.¹³ The Public Art Committee oversees the art bank program, the arts exhibitions grants, the public art building communities grants, the conservation of Commission public art installations, and Mural DC. Working with the Commission's Department of Public Art and the Marion S. Barry Bronze Statute Public Art Commission, Ms. Gates helped ensure that the sculpture of the former Mayor matched his every likeness and made sure the unveiling went off without an issue.¹⁴

Ms. Gates wants to be reappointed because she wants to continue to serve her community and believes that the power of the arts and humanities can bring enrichment to ordinary experiences. ¹⁵ She plans to assist the Commission's efforts to enhance the role of the arts and

humanities and the impact it has on District residents. ¹⁶ Ms. Gates will also use her experience as a former ANC Commissioner to create partnerships with developers in order for them to consider including arts and other new creative uses on development projects. ¹⁷ Finally, she believes that she has the necessary personal and professional experience to serve another term on the Commission. ¹⁸

The Committee believes Ms. Gates meets the requirements to continue to serve another term as a member of the Commission pursuant to D.C. Official Code § 30-203(a-1)(1)(D) as she has a specific interest, ability, and experience in public art. Ms. Gates dedication to the District as a community activist and in serving with non-profit organizations that help to promote arts and humanities to communities' nationwide attest to her ability to help the Commission promote the arts and humanities in the District. The Committee recommends adoption of PR 23-576.

This may have been previously mentioned, but I feel strongly concerning the power of the arts and humanities to bring enrichment to ordinary experiences.

Observing students at the Lab School of Washington grow and demonstrate excitement about their participation in creating a large sculpture for the school or learning to play a musical instrument or express their feelings through the annual poetry contest or participation in a Shakespeare production was very exciting. Having had this kind of rich experience makes the work the Commission does in the field of education have an even fuller meaning. You realize how different styles of learning result in different kinds of expression.

As the Commission moves forward, it is my hope that the current goal of the Commission to enhance the role of the arts and humanities and its influence of the everyday lives of individuals will be expanded as capacity for such growth increases with an increase in funding and funding opportunities. As a former ANC Commissioner and member of the Zoning Revision Task Force, I know there are opportunities to leverage public/private partnerships with developers as they meet their requirement options for public amenities. Not only can new development sites be enhanced and beautified, developers may experience exposure to the arts which has not been there previously. Also, the development of the McMillan Sand Filtration site will afford new opportunities for use of the historic elements on site for the Commission as new creative uses are explored.

Good afternoon, Chairman Mendelson, councilmembers, and staff of the Committee of the Whole. I am Alma Hardy Gates, and I am honored to be nominated by Mayor Bowser for reappointment to the DC Commission on the Arts and Humanities. Thank you, Chairman Mendelson for allowing me the opportunity to testify on my reappointment. I also want to thank the Commission's stalwart Chair, Kay Kendall. Kay's stellar leadership provided the guidance necessary to steer the Commission and its members where we are today. Through the most recent transition to an independent agency, we were able to remain focused because our leadership was forward thinking, strong, and committed.

First appointed to the DC Commission on the Arts and Humanities in 2012, I have focused my efforts in two areas: finance and public art. Those committees still remain areas of special interest, as I am currently chair of the Public Art Committee. The Commission's Public Art Department oversees the Art Bank Program; the Art Exhibitions Grant; City Commissioned Projects; the Public Art Building Communities Grant; Conservation of CAH public art installations; and Murals DC, a graffiti abatement project done in partnership with the Department of Public Works. The Public Art Department also partners with other District agencies on public art projects. Additionally, the Department works with civic and community organizations to provide subject matter expertise on the role of public art in place making. As chair of the Public Art Committee, I share the work of the Department through committee meetings with the staff and as a non-voting convener of selection panels.

The staff of the Public Art Department, under the able leadership of Lauren Dugas Glover, has been a joy to work with as projects move from the staff level to the selection panels and through the decision-making process. This extremely able staff has worked beyond capacity at times to ensure the right outcomes are achieved. The Marion S. Barry Bronze Statue is case

and point. Working with the Marion S. Barry Bronze Statute Public Art Commission to identify the right artist to sculpt the likeness, visiting the artist's studio to ensure every likeness was correct, and, finally, standing at the dedication in a brisk and chilly wind to make sure the drape fell at the right time brought home the meaning of staff dedication for me. This scenario is not unique or unusual, because it has become what is expected of Commission staff. It is a pleasure to work with this group of highly knowledgeable individuals.

My personal exposure and interest in the arts began at home. My mother was a concert pianist and my aunt was an arts patron and collector. They both shared their love and enthusiasm of art and music with me from a very early age. I am fortunate to have grown up in such a rich and stimulating environment and strive to incorporate this environment in today's youth.

At one point, I was a Montessori teacher and was taught the importance of incorporating different art forms—painting, music, and dance—into the daily curriculum of young students. I also spent five years at the Lab School of Washington where the curriculum is arts-based and enables students to learn and express themselves when they might not be able to do so in a more traditional classroom.

My professional positions included working with the founding director to establish the National Main Street Center at the National Trust for Historic Preservation; develop programs and policy for museum professionals at the American Alliance of Museums; and, conduct a national campaign with the National Cultural Alliance on the importance of the arts and humanities to the everyday lives of the American public. My personal and professional experiences have prepared me well for the work I do with the DC Commission on the Arts and Humanities. My community activist role on the ANC and membership in the Committee of 100 on the Federal City provide a more balanced and well-rounded experience.

It has been an honor to serve on the Commission on the Arts and Humanities, and if confirmed, I plan to continue to work hard and serve my community. This concludes my testimony, and I welcome any questions you may have.
