# I. BACKGROUND AND NEED

On November 26, 2019, Proposed Resolution 23-581, the "Commission on the Arts and Humanities Natalie Hopkinson Confirmation Resolution of 2020," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 23-581 would confirm the Mayor's nomination of Ms. Natalie Hopkinson for appointment as a member of the Commission on the Arts and Humanities for a term to end June 30, 2021.

Dr. Hopkinson is a Ward 5 resident. She received her Bachelor of Arts in Political Science from Howard University, a Master of Arts in Public Affairs Journalism from the University of Maryland-College Park, and a Doctor of Philosophy in Journalism and Public Communication

from the Philip Merrill College of Journalism at the University of Maryland-College Park. Dr. Hopkinson currently serves as an Assistant Professor in the Department of Communication, Culture, and Media Studies at Howard University, and is a fellow at the Interactivity Foundation where she directed a project called "The Future of the Arts & Society." In addition, she has spent the past 25 years writing about the arts, cultural history, and issues of race and gender and society. From 2012 to 2018 she served as a Contributing Scholar for the Humanities Council of Washington, DC where she researched and consulted on projects related to the history and culture of the District. Dr. Hopkinson is a member of the Caribbean Studies Association and the Association for Educators in Journalism and Mass Communication.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 *et seq.*). The Commission is an independent agency within the District government and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and encourage programs and the development of programs which promote progress in the arts and humanities.<sup>3</sup>

The Commission consists of 18 members appointed by the Mayor for three-year terms, with the advice and consent of the Council.<sup>4</sup> The Commission is tasked with appointing an Executive Director who serves as the chief administrative office of the Commission.<sup>5</sup> In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.<sup>6</sup>

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities. Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the neighborhoods in the District when considering appointments to the Commission. Further, no employee of the District government can serve as a member of the Commission.

In the Fiscal Year 2020 Budget Support Act of 2019, <sup>10</sup> the Council approved additional qualification requirements for individuals to be eligible to serve as a member on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission were required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities

education; and (3) two members with specific interest, ability, experience in theatre and performing arts.<sup>11</sup> By July 1, 2020, four of the 18 members appointed to the Commission were required to meet the following requirements: (1) two members with specific interest, ability, or experience in public art; and (2) two members with specific experience in arts or humanities organizational administration or governance.<sup>12</sup>

Dr. Hopkinson believes her experience travelling the world to write about art and artists of all kinds and about gallery exhibits would be useful for her service on the Commission. Also, her work as a staff writer, editor, and culture critic and columnist for the Washington Post, The Root, and Huffington Post has given her the necessary experience to serve on the Commission. Further, in 2012 Dr. Hopkinson wrote a book entitled *Go-Go Live: The Musical Life and Death of a Chocolate City*, an ethnography of the District's go-go music, political economy, and culture, and she has worked with the go-go community to protect and support its legacy. She is excited to serve on the Commission because the arts are a critical part of her life.

Dr. Hopkinson, if appointed, will look at what the Commission has done well and how to build upon that success. <sup>17</sup> She will advocate for the Commission to be a more inclusive institution that speaks to groups that have been left out of the conversation. <sup>18</sup> She plans to ensure that the Commission supports art that everyday people do in their lives, and to make sure the Commission is responsive to the needs of everyday people. <sup>19</sup>

The Committee believes Dr. Hopkinson meets the requirements to serve as a member of the Commission pursuant to D.C. Official Code § 39-203(a-1)(2)(A) as she a specific interest, ability, or experience in the humanities. The Committee believes Dr. Hopkinson's work with the Humanities Council, and her work with the go-go community to include being a co-founder of the #DontMuteDC movement makes her well-suited to serve on the Commission. Dr. Hopkinson's experiences will allow her to bring a new and unique perspective to the Commission. The Committee recommends adoption of PR 23-581.





My name is Natalie Hopkinson, and I am honored to be nominated by Mayor Muriel Bowser for this important appointment to serve on the Commission on the Arts and Humanities. Thank you, Chairman Mendelson, for convening this hearing today.

I have been a District resident since 1994, when I arrived as a college student. I hold a Bachelor of Arts degree in Political Science from Howard University and earned my Master's and PhD degrees from the University of Maryland-College Park. I have two beautiful children, Maverick and Maven, who are both teenagers born and raised in Ward 5, where I and my husband, Rudolph McGann Jr., have lived since 2000.

Currently, I am an assistant professor in the Department of Communication, Culture and Media Studies at Howard University; as well as, a fellow at the Interactivity Foundation, a nonprofit organization that works to engage citizens in the exploration and development of possibilities for public policy. As a fellow, I directed a project called "The Future of the Arts & Society." I have also spent the past 25 years writing about the arts, cultural history, and issues of race and gender and society. I have been a staff writer, editor, and culture critic and columnist at the *Washington Post*, *The Root*, and *Huffington Post*, and have academic publications with Duke University Press, *Communication, Culture and Critique*, and *Journalism Practice*.

I have written about gallery exhibits all over the world. I have facilitated discussions about the role of the arts in my mother's village on the Pomeroon River in Guyana, South America. I have had the absolute privilege of talking to the people who make go-go music: the artists, the promoters, the historians, journalists, the shopkeepers, the music traders, the sound engineers, graphic designers, clothing designers, deejays, and the thousands of fans that comprise a go-go performance.

I am excited about being nominated to the Commission because the arts are a critical part of everything I have done since I was born. My ancestors are from all over the world, but the largest chunk are from West Africa and the Indigenous parts of the Americas, where many languages do not have a word for "art." They don't have a specific word for "art" because it is not something that you pause to admire on a wall, but is a way of life.

Then there is the actual art that everyday people do in their lives.
