**I. BACKGROUND AND NEED**

On September 27, 2019, Bill 23-449, the “Kappa Alpha Psi Way Designation Act of 2020”<sup>1</sup> was introduced by Councilmember Brandon Todd to symbolically designate S Street, N.W. between 17<sup>th</sup> Street, N.W. and New Hampshire Avenue, N.W., as “Kappa Alpha Psi Way.” A symbolic naming is for ceremonial purposes and shall be in addition to and subordinate to any name that is an official name.

Kappa Alpha Psi Fraternity, Inc. is a Greek-lettered fraternity originally founded by ten African American students on the campus of Indiana University Bloomington on January 5, 1911. The fraternity was originally incorporated under the name Kappa Alpha Nu, but changed its name in 1915 to Kappa Alpha Psi.<sup>2</sup> While founded in the Midwest, the fraternity expanded with a number of undergraduate chapters extending to the Xi chapter chartered at Howard University in

the District in 1920. Today, worldwide, there are over 700 chapters and 160,000 collegiate members.

There are many prominent current and former members of Kappa Alpha Psi Fraternity including George E.C. Haynes and Frank D. Reeves who were attorneys and professors at Howard University who were members of the team that argued the landmark *Brown v. Board of Education* case; James “Biff” Carter, Jr., a DC native who taught in DC Schools and served as principal of Ballou High School and advisor to the US Department of Education; former Mayor Adrian Fenty; former Council Chairman Kwame Brown; former Ward 7 Councilmember Kevin P. Chavous; and Ward 4 Councilmember Brandon Todd.<sup>3</sup>

The DC Alumni Chapter of Kappa Alpha Psi was chartered on October 15, 1924. In 1949, the Alumni Chapter worked with local chapters at Howard University (Xi Chapter) and Miner Teachers College<sup>4</sup> (Beta Kappa Chapter) to purchase a Georgian-style home in the Dupont Circle Neighborhood at 1708 S Street, N.W. The house was designed by local architect Leon Dessez who also designed the Admiral’s residence at the Naval Observatory (now the Vice President’s residence). The Historic Kappa House was designated as a National Historic Landmark in 1985. “Kappa Castle” became a center of social activity, activism, and philanthropy for African Americans beginning during the era of racial segregation.<sup>5</sup>

### ***Legal Background***

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) (“Act”) establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys.<sup>6</sup> In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.<sup>7</sup>

An “official name” refers to the legal designation of an alley or a street for mailing address and other purposes,<sup>8</sup> whereas a “symbolic name” for a street or alley shall be in addition to and subordinate to any name that is an official name.<sup>9</sup> An official name of an alley shall contain the suffix “Alley” or “Court.”<sup>10</sup> A symbolic name of a street or alley shall contain only the suffix

“Way” or “Plaza.”<sup>11</sup> As established by Bill 23-449, “Kappa Alpha Psi Way” is a symbolic street designation for S Street, N.W. between 17<sup>th</sup> Street, N.W. and New Hampshire Avenue, N.W.

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming.<sup>12</sup> Regarding Bill 23-449, ANC 2B was notified directly of Bill 23-449 containing the proposed name on October 28, 2019.

After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation (“DDOT”) shall install signage indicating the symbolic name of the alley or street, or portion thereof. Such signage shall be uniform and distinct from signs for official names<sup>13</sup>

Symbolically designating the S Street fronting the Historic Kappa House will recognize the cultural significance and history of the Kappa Alpha Psi fraternity. Thus, the Committee of the Whole recommends the approval of Bill 23-449, the “Kappa Alpha Psi Way Designation Act of 2020.”

## II. LEGISLATIVE CHRONOLOGY

- September 24, 2019 Bill 23-449, the “Kappa Alpha Psi Way Designation Act of 2019” is introduced by Councilmember T. White.
- October 4, 2019 Notice of Intent to Act on Bill 23-449 is published in the *DC Register*.
- October 8, 2019 Bill 23-449 is officially read at the regularly scheduled Legislative Meeting and referred to the Committee of the Whole.
- October 25, 2019 Notice of a public hearing on Bill 23-449 is published in the *DC Register*.
- November 26, 2019 The Committee of the Whole holds a hearing on Bill 23-449.
- February 4, 2019 The Committee of the Whole marks up Bill 23-449.

## III. POSITION OF THE EXECUTIVE

Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation, testified on behalf of the Executive that it had “no objection” to the symbolic street naming in Bill 23-449. His testimony is attached and also summarized below.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

ANC 2B, in which the proposed official designation is located, voted unanimously on August 14, 2019 to support symbolically designating the subject portion of S Street, N.W. as Kappa Alpha Psi Way. A resolution memorializing the ANC's support is attached to this report.

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 23-449 on Thursday, November 26, 2019. The testimony summarized below pertains to Bill 23-449. Copies of written testimony are attached to this report.

*David Brewer, Member, Kapp Alpha Psi Fraternity, Inc.*, testified in support of the naming and described some of the history of the fraternity and prominent local members.

*Gordon Fletcher, Board Member, Washington Alumni Chapter, Kappa Alpha Psi Fraternity, Inc.*, testified in support of the naming and the important work of the alumni chapter.

*Presley Reed, Jr., 46<sup>th</sup> Polemarch, Washington Alumni Chapter, Kappa Alpha Psi Fraternity, Inc.*, testified in support of the naming and discussed the importance of the historic Kappa House to the fraternity and community.

*Anthony Agnew, Washington Alumni Chapter, Kappa Alpha Psi Fraternity, Inc.*, testified in support of the naming and the mentorship he received from the fraternity even before joining himself.

*Terry Brooks, President, Historic Kappa House Restoration Foundation*, testified in support of the naming and described the role of the Foundation in preserving the Historic Kappa House.

*David Hardrick, Past Polemarch, Washington Alumni Chapter, Kappa Alpha Psi Fraternity, Inc.*, testified in support of the naming and the impact of the alumni members on the District.

*John F. Cotten, First Vice-Polemarch, Washington Alumni Chapter, Kappa Alpha Psi Fraternity, Inc.*, testified in support of the naming and discussed the chapter's objective of inspiring public service and its philanthropic endeavors.

*Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation*, testified on behalf of the Executive that it had "no objection" to the designation.

The Committee received no testimony or comments in opposition to Bill 23-449.

## VI. IMPACT ON EXISTING LAW

Bill 23-449 has no impact on existing law. D.C. Official Code § 9-204.01<sup>14</sup> authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley “that shall be in addition to and subordinate to any name that is an official name.”<sup>15</sup> Bill 23-449 symbolically designates a portion of S Street, N.W. as “Kappa Alpha Psi Way.” Additionally, “a symbolic name of a street or alley shall contain only the suffix Way or Plaza,” such as proposed by Bill 23-449.<sup>16</sup>

## V. VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2020 through fiscal year 2023 budget and financial plan to implement the provisions of the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is estimated at \$190 (\$65 per sign for fabrication and \$125 for installation), the cost of Bill 23-449 can be absorbed, as noted in the Fiscal Impact Statement.

## VIII. SECTION-BY-SECTION ANALYSIS

<u>Section 1</u>	States the short title of Bill 23-449.
<u>Section 2</u>	Symbolically designates a portion of S Street, N.W. as “Kappa Alpha Psi Way.”
<u>Section 3</u>	Adopts the Fiscal Impact Statement.
<u>Section 4</u>	Establishes the effective date by stating the standard 30-day congressional review language.



A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To symbolically designate S Street, N.W., between New Hampshire Avenue, N.W., and 17th Street, N.W., as Kappa Alpha Psi Way.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Kappa Alpha Psi Way Designation Act of 2019".

Sec. 2. Pursuant to sections 401, 403a, and 423 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01), the Council renames the portion of S Street, N.W., between New Hampshire Avenue, N.W., and Seventeenth Street, N.W., in Ward 4, as "Kappa Alpha Psi Way."

Sec. 3. Transmittal.

The Secretary of the Council shall transmit a copy of this act, after it becomes effective, to the District Department of Transportation.

Sec. 4. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 4a of the General Legislative Procedures Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).



32           Sec. 5. Effective date.

33           This act shall take effect after approval by the Mayor (or in the event of veto by the  
34 Mayor, action by the Council to override the veto), a 30-day period of congressional review as  
35 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December

**Good Morning Mr. Chairman, and members of the D.C. City Council.**

For the record, My name is Terry Brooks and I am President of the Historic Kappa House Restoration Foundation (HKHRF). [www.dckappahouse.com](http://www.dckappahouse.com)

I am pleased to appear before you today in support of Bill # 23-449, the proposal to change the 1700 Block of S Street, N.W. to "Kappa Way".

As part of my testimony, I plan to take about 3-5 minutes to summarize why I support this honorary street renaming initiative.

I am a 32 year member of the fraternity;

I am also a native Washingtonian (who grew up in Crestwood (Ward 4); graduated from Western High School, now Duke Ellington School for the Arts(Ward 3); a graduate of Howard University( Ward 1); was the Ward 8 Planner for the DC Office of Planning when Councilmember Rolark was a councilmember; and currently live on Capitol Hill in (Ward 6).

I am also a Harvard University graduate architect & Urban Planner;

-the 1<sup>st</sup> Chief of Urban Design for the D.C. Office of Planning;

-the 1st author of the adopted Urban Design & Historic Preservation Elements of the Comprehensive Plan for the District of Columbia; and

-the current President of the Historic Kappa House Restoration Foundation([www.dckappahouse.com](http://www.dckappahouse.com))

The Historic Kappa House Restoration Foundation (Foundation) is a tax-exempt, 501 (c) (3) organization created in 2004.

The Foundation's role and mission is to identify and provide tax-exempt donations to fund the protection and preservation of the historic Kappa House.

**To date, the Foundation has funded over \$ 175,000 to fund needed renovations and historic preservation related improvements to the Historic Kappa House.**

**Our overall restoration funding goal is approximately**

**\$ 3.5M.**

**As part of this initiative, I believe it is important to remind everyone about the background and history of the historic Kappa House and it's contextual, cultural and architectural significance in the District of Columbia.**

**The Historic Kappa House; located at 1708 S Street, N.W. has been identified as a historically significant, contributing structure within the DuPont Circle Historic District by the U.S. Department of the Interior's National Trust for Historic Preservation and the D.C. Office of Historic Preservation.**

**The Kappa House is a 7,000 square foot Georgian style row house Mansion built in 1908. The Historic Kappa House was designed by Leon Dessez, FAIA (1858-1918), a famous local architect who designed several federal government buildings including the Admiral's Residence located at One Observatory Circle (known today as the official residence of the Vice President). The Historic Kappa House was purchased by the Washington, D.C. Alumni Chapter in 1949.**

**The naming of the 1700 block of S Street, N.W. to Kappa Way is significant not only because of the historic architectural significance of the building but also because of its cultural significance to the growth and influence on the overall cultural growth of the District of Columbia. The D.C. Kappa House is the only edifice dedicated to The Kappa Alpha Psi Fraternity in the Nation's Capital. The Kappa House was acquired by the Washington, D.C. Chapter of the Kappa Alpha Psi Fraternity at a time when African-Americans in Washington DC had very few places to go for any type of social activities.**

The DC Kappa House is also part of the DUPONT CIRCLE & STRIVERS' SECTION, AFRICAN AMERICAN HERITAGE Trail. The African American Heritage Trail in Washington DC identifies more than 200 sites that are important in local and national history and culture. The entire trail consists of over 200 sites. Of those sites, 100 are marked with plaques. The Historic Kappa House was awarded one of these plaques in recognition of its historic significance in Washington, D.C.

Plaques added recently mark:

- Engine Company No. 4, DC's first all-black fire company;
- Vermont Avenue Baptist Church, founded in 1866 by former slaves;
- The home of Howard D. Woodson, one of DC's influential architects and community leaders;
- Washington Conservatory of Music, one of DC's earliest arts institutions;

Good morning Chairman Mendelson, members of the Council, staff, and District residents. My name is Lee Goodall, and I am Chief of Staff at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Director Jeff Marootian regarding Bill 23-68, the “Bishop Sherman S. Howard Way Designation Act of 2019”; Bill 23-88, the “Downs Way Designation Act of 2019”; Bill 23-104, the “Tingey Square Designation Act of 2019”; Bill 23-366, the “Zaire Kelly Park Designation Act of 2019”; Bill 23-449, the “Kappa Alpha Psi Way Designation Act of 2019”; and Bill 23-455, the “Rev. Roy Settles Way Designation Act of 2019”.

The stated purpose of Bill 23-68 is to symbolically designate the 900 Block of Underwood Street, N.W., between Georgia Avenue, N.W., and Piney Branch Road, N.W. in Ward 4, as *Bishop Sherman S. Howard Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-88 is to symbolically designate the 800 Block of Decatur Street, N.E. in Ward 4, as *Downs Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation

is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation).

Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-104 is to officially designate the portions of Tingey Street, S.E., and N Street, S.E., between New Jersey Avenue, S.E., abutting Squares 770, 771 and W-771, in Ward 6, as *Tingey Square*. As per the requirements of DC Act 21-489, Section 421(g), I have attached to this testimony a copy of the surveyor's plat showing the public square and the aforementioned portions of Tingey Street, N Street and New Jersey Avenue in S.E. abutting Squares 770, 771 and W-771. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires four total signs, totaling \$760.

The stated purpose of Bill 23-366 is to officially designate the public right of way located at the corner of 13th Street, N.E., and Downing Street, N.E. in Ward 5 as the *Zaire Kelly Park*. As per the requirements of DC Act 21-489, Section 421(g), I have attached to this testimony a copy of the surveyor's plat showing the relevant right-of-way adjacent to Squares 3942, 3950, 3952 and 4107. In fiscal terms, Council funded \$150,000 to DDOT to improve the public space including adding lighting, benches, landscaping, and signage so DDOT does not require additional dollars for sign fabrication or installation. I should note, DDOT will maintain its right-of-way in this public space in case a future W Street, N.E. connection is necessary. If so, the agency will engage the Brentwood residents in a

public process for the redesign of W Street, N.E. and any design or siting of a Zaire Kelly Park.

The stated purpose of Bill 23-449 is to symbolically designate S Street, N.W., between New Hampshire, N.W., and 17<sup>th</sup> Street, N.W. in Ward 2 as *Kappa Alpha Psi Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-455 is to symbolically designate the 1400 Block of Minnesota Avenue, S.E. in Square 5605 in Ward 8 as *Rev. Roy Settles Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires two total signs, totaling \$380.

Sufficient signage requires 12 total signs, totaling \$2,280. DDOT is able to absorb the costs of these signs within its current budget and does not foresee any operational impact these designations would have on the District's transportation network.

Therefore, the Administration has no objection to these designations, and DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of these Bills being passed.

WHEREAS, the Historic Kappa House received the designation of a National Historic Landmark in 1985 by the U.S. Department of Interior, is a visiting station along the neighborhood tourism trail, and has been memorialized as the hub for the gathering of black social life during segregation,

WHEREAS, the Washington, DC Alumni Chapter of Kappa Alpha Psi, Fraternity Inc. is celebrating its 95<sup>th</sup> anniversary as an organization,

WHEREAS, the Washington, DC Alumni Chapter, through its Kappa Scholarship Endowment Fund, awarded approximately \$3 million in college scholarships to seven hundred graduating high school seniors since 1984, enabling these students to pursue their dreams of higher education, and

WHEREAS, the Washington, DC Alumni Chapter has always been intimately involved in the improvement of its community and the residents therein with its myriad of community service programs and activities, support of the DC Voter Participation Drive, annual school supplies drives, and annual community holiday drives.

THEREFORE, BE IT RESOLVED that ANC 2B supports the renaming of S Street from New Hampshire Avenue to 17th Street NW to “Kappa Alpha Psi Way NW.”

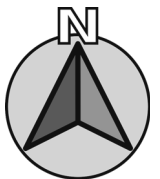
