19 To extend, on an emergency basis, the Mayor’s authority to declare a public health emergency.
20

21 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
22 act may be cited as the “Public Space Maintenance Temporary Act of 2020”.

23 Sec. 2. BID public space maintenance agreements.

24 (a) Notwithstanding the Procurement Practices Reform Act of 2010, effective April 8,
25 2011 (D.C. Law 18-371; D.C. Official Code § 2-351.01 et seq.) and subsection (c) of An Act
26 Making appropriations to provide for the expenses of the government of the District of Columbia
27 for fiscal year ending June thirtieth, eighteen hundred and ninety-five, and for other purposes,
28 approved August 7, 1894 (28 Stat. 247; D.C. Official Code § 9-401.06), the Mayor may enter
29 into an agreement, excluding grant agreements, with a BID corporation, as defined in section
30 2(4) of the Business Improvement Districts Act of 1996, effective May 29, 1996 (D.C. Law 11-
31 134; D.C. Official Code § 2-1215.02(4)), to maintain or improve public space, including
32 sidewalks, streets, parks, plazas, signage, and public art, within the boundaries of the BID, as
33 defined in section 2(7) of the Business Improvement District Act of 1996, effective May 29,
34 1996 (D.C. Law 11-134; D.C. Official Code § 2-1215.02(7)).

35 (b) The Mayor shall pay or reimburse to a BID corporation the reasonably incurred
36 expenses for maintaining or improving public space or for engaging in planning activity under
37 this section for services customarily provided by the District to any similar geographic area
38 pursuant to section 20(a) of the Business Improvement Districts Act of 1996, effective May 29,
39 1996 (D.C. Law 11-134; D.C. Official Code § 2-1215.20(a)).

40 (c) An agreement with a BID corporation made pursuant to this section to complete work
41 in public space shall contain provisions requiring adequate insurance and indemnification, and
42 such work in public space shall be subject to applicable permits.

43 (d) An agreement with a BID corporation made pursuant to this section shall not exceed
44 \$800,000 for a single fiscal year; provided, that a multiyear agreement shall be allowed, subject
45 to annual appropriation.

46 (e) This section shall apply during a period of time for which the Mayor has declared a
47 public health emergency pursuant to section 5a of the District of Columbia Public Emergency
48 Act of 1980, effective October 17, 2002 (D.C. Law 14-194; D.C. Official Code § 7-2304.01) and
49 for 30 days thereafter.

50 Sec. 3. Fiscal impact statement.

51 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
52 statement required by section 4a of the General Legislative Procedures Act of 1975, approved
53 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

54 Sec. 4. Effective date.

55 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
56 the Mayor, action by the Council to override the veto), a 30-day period of congressional review
57 as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December

58 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
59 Columbia Register.

60 (b) This act shall expire after 225 days of its having taken effect.
