





28 To symbolically designate the 2400 block of 4th Street, N.W., in Ward 1, as Lucy Diggs Slowe

30 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this  
31 act may be cited as the "Lucy Diggs Slowe Way Designation Act of 2019".

32 Sec. 2. Pursuant to sections 401, 403a, and 423 of the Street and Alley Closing and  
33 Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official  
34 Code §§ 9-204.01, 9-204.03a, and 9-204.23), the Council symbolically designates the 2400 block  
35 of 4th Street, N.W., in Ward 1, as "Lucy Diggs Slowe Way".

2 Mayor, action by the Council to override the veto), a 30-day period of congressional review as

4 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of  
5 Columbia Register.
