I. BACKGROUND AND NEED

On November 5, 2019, Bill 23-532, the "Dr. Montague Cobb Way Designation Act of 2020" was introduced by Councilmember Brianne K. Nadeau and Councilmembers Allen, Bonds, Cheh, Gray, Grosso, McDuffie, Nadeau, R. White, and T. White to symbolically designate the 600 block of W Street, N.W., as "Dr. Montague Cobb Way." This area is on the campus of Howard University. A symbolic naming is for ceremonial purposes and shall be in addition to and subordinate to any name that is an official name.

Dr. William Montague Cobb was born on October 12, 1904 in Washington, DC. He graduated from Dunbar High School in 1921, received his bachelor's degree from Amherst College in 1925, an MD from Howard University in 1929, and a PhD from Western Reserve

University in 1932.² He was the first African American to earn a PhD in anthropology.³ After graduating from Western Reserve, he returned to Howard University as a professor of anatomy. By 1942, Dr. Montague Cobb was chair of the Department of anatomy, serving in that role for 27 years. In 1970, he was appointed as Howard University's first Distinguished University Professor.

Dr. Cobb was renowned nationally, serving as president of the National Medical Association, and from 1949 to 1977, editor of the Journal of the National Medical Association. He was renowned for his work on medical history and physical anthropology with a focus on the relevance of these fields for African Americans, publishing over 600 scientific works. Perhaps because Cobb was also athletically gifted, he was interested in the relationship between race and athletics. After the 1936 Olympic triumph of Jesse Owens, a black man, many came to believe that African Americans had certain biological characteristics that explained why they may be better at sports than other races. Cobb disagreed with this view and used his medical training to undertake objective research that found insufficient evidence for any such conclusion. At the same time, Dr. Cobb also served as an advocate against racial disparities in the practice of medicine. He led the fight for the admission of African American physicians into the District's predominantly White hospitals and into the Medical Society of the District of Columbia. He organized a number of annual national conferences on hospital discrimination and integration and advocated for equal access to the medical field for African Americans.

Dr. Cobb played an important role in dismantling unfounded views on physical racial disparities, but he also contributed greatly to the larger field of medicine. He conducted important research on the aging of skeletons and dental anatomy. He also is credited for his contribution to the physical representation of the heart used by medical students, scientists, and doctors around the world. Dr. Cobb believed in using his work to implement social change, and he served in many civil rights organizations including president of the Medico-Chirurgical Society of the District of Columbia (the oldest black medical society). After a distinguished career in medicine, Dr. Cobb served as executive president of the National Association for the Advancement of Colored People (NAACP) from 1976 to 1983.⁷

Dr. Montague Cobb passed away on November 20, 1990. However, his legacy lives on reflecting his contributions to both medicine and civil rights. Howard University now houses the W. Montague Cobb Research Laboratory which is the only academic institution in the world with 400 years of genomic samples of peoples of African descent. The Cobb Collection is the only skeletal collection residing at an historically black college or university.⁸

Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys. In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming. ¹⁰

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes, 11 whereas a "symbolic name" for a street or alley shall be in addition to and subordinate to any name that is an official name. 12 An official name of an alley shall contain the suffix "Alley" or "Court." A symbolic name of a street or alley shall contain the suffix "Way" or "Plaza." As established by Bill 23-532, "Dr. Montague Cobb Way" is a symbolic street designation for the 600 block of W Street, N.W.

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming. ¹⁵ Regarding Bill 23-532, ANC 1B was notified directly of Bill 23-532 and the proposed name on August 6, 2020.

After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation ("DDOT") shall install signage indicating the symbolic name of the alley or street, or portion thereof. Such signage shall be uniform and distinct from signs for official names¹⁶

Symbolically designating the 600 block of W Street, N.W. as Dr. Montague Cobb Way, adjacent to the W. Montague Cobb Research Laboratory on the campus of Howard University, will honor the accomplishments and legacy of Dr. Montague Cobb. Thus, the Committee of the Whole recommends the approval of Bill 23-532, the "Dr. Montague Cobb Way Designation Act of 2020."

II. LEGISLATIVE CHRONOLOGY

November 5, 2019 Bill 23-532, the "Dr. Montague Cobb Way Designation Act of 2019" is introduced by Councilmember Brianne Nadeau, co-introduced by Councilmembers Allen, Bonds, Cheh, Gray, Grosso, McDuffie, Nadeau, R. White, and T. White, and referred to the Committee of the Whole.

November 15, 2019 Notice of Intent to Act on Bill 23-532 is published in the *DC Register*.

August 7, 2020 Notice of a public hearing on Bill 23-532 is published in the *DC Register*.

September 15, 2020 The Committee of the Whole holds a hearing on Bill 23-532.

October 20, 2020 The Committee of the Whole marks up Bill 23-532.

III. POSITION OF THE EXECUTIVE

Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the symbolic street naming in Bill 23-532. His testimony is attached and also summarized below.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from Advisory Neighborhood Commissions.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 23-532 on Thursday, September 15, 2020. The testimony summarized below pertains to Bill 23-532. Copies of written testimony are attached to this report.

- *Dr. Fatimah Jackson, Director, W. Montague Cobb Research Laboratory, Howard University,* testified in support of Bill 23-532 and described Dr. Montague Cobb's mentorship and his contributions to the field of anthropology.
- *Dr. Dana Williams, Interim Dean, Howard University Graduate School,* testified in support of Bill 23-532, noting the importance of highlighting Dr. Montague Cobb's work in the current climate of advancing social justice.

Susanne Bathgate, MD, Chair of the Board of Directors of the Medical Society of DC, testified in support of Bill 23-532, and emphasized Dr. Cobb's background training medical students and his work regarding race-based health disparities.

Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the designation.

The Committee received no testimony or comments in opposition to Bill 23-532.

VI. IMPACT ON EXISTING LAW

Bill 23-532 has no impact on existing law. D.C. Official Code § 9-204.01¹⁷ authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley "that shall be in addition to and subordinate to any name that is an official name." Bill 23-532 symbolically designates the 600 block of W Street, N.W. as "Dr. Montague Cobb Way." Additionally, "a symbolic name of a street or alley shall contain only the suffix Way or Plaza," such as proposed by Bill 23-532. Lastly, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. Dr. Montague Cobb died in 1990.

VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2021 through fiscal year 2024 budget and financial plan to implement the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is estimated at \$380 (\$65 per sign for fabrication and \$125 for installation), the cost of Bill 23-532 can be absorbed, as noted in the October 16, 2020 Fiscal Impact Statement.

Howard University supports The Dr. Montague Cobb lab's petition to designate 600 block of W Street, N.W in Ward 1, as "Dr. Montague Cobb Way."

Washington native son William Montague Cobb (1904-1990) was a luminary. As a board-certified physician and a biological anthropologist, he was the first African American to earn a Ph.D in anthropology, and the only one until after the Korean War. Cobb's focus was anatomically studying the idea of race and its negative impact on communities of color. To address these issues, Dr. Cobb assembled the Cobb Collection, the largest collection of African American skeletal and dental remains in the world and the third largest human skeletal collection in the United States. Dr. Cobb was an outstanding Howard University faculty member and his visionary insights spanned a large and diverse array of disciplines. Cobb was a scholar activist, lobbying for the medical rights of African American physicians, challenging the racism and bias in Washington DC and the nation, and translating medical and scientific innovations into advances in community and public health. A gradute of Howard University's Medical school, his career both as a physician and a professor at Howard University was dedicated to the advancement of African American researchers and he was heavily involved in civil rights activism. Cobb wrote prolifically and contributed both popular and scholarly articles during the course of his career. His work has been noted as a significant contribution to the development of the sub-discipline of biocultural anthropology during the first half of the 20th Century. Cobb was also an accomplished educator and taught over 5000 students in the social and health sciences during his lifetime.

I look forward to support in honoring the pioneer and son of Howard.

Thank you Chair Mendelson and Councilmembers for the opportunity to testify today. My name is Dr. Susanne Bathgate. During the day, I serve as Maternal-Fetal Medicine specialist at the GW Medical Faculty Associations and Associate Professor in the GW School of Medicine Department of Obstetrics and Gynecology. Outside of my work capacity, and in the capacity I am testifying today, I am the Chair of the Board of Directors for the Medical Society of the District of Columbia.

MSDC supports the effort to symbolically name the 600 block of W Street NW "Dr. Montague Cobb Way". Others will list the numerous reasons why Dr. Cobb is worthy of this honorific, but I wanted to highlight a few important ones from a medical perspective:

- By his own estimates, Dr. Cobb trained 6,000 health professionals at Howard University.
- His work in anthropology plus medicine showed that Black and White children's brains developed the same way, dispelling a horrible myth that Black children were intellectually inferior by birth.
- He was a leader in the National Medical Association and Medico-Chirurgical Society of DC (MedChi DC).
- He was a child of the District, born here and educated at Dunbar High School.

The District's medical history is incredibly rich and underrepresented in honorifics throughout the city. For example, Dr. Charles Drew – pioneer of effective blood transfusion and blood banks – was a District native. The American Medical Association itself was founded with the assistance of District physicians, three of whom served as presidents of the association.

MSDC urges the District government to include physicians and medical professionals in the lists of native Washingtonians to recognize throughout the city in new ways. We especially urge the Council and Bowser Administration to consult with our MedChi colleagues to ensure the history of Black medicine in the District is appropriately recognized.

Good morning Chairman Mendelson, members of the Council, staff, and District residents. My name is Lee Goodall, and I am the Chief of Staff at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Director Jeff Marootian regarding seven bills, which are Bill 23-532, the "Dr. Montague Cobb Way Designation Act of 2019," Bill 23-533, the "Lucy Diggs Slowe Way Designation Act of 2019," Bill 23-538, the "Elaine M. Carter Way Designation Act of 2019," Bill 23-609, the "Gail Cobb Way Designation Act of 2020," Bill 23-680, the "Cecelia's Way Designation Act of 2020," Bill 23-787, the "Black Lives Matter Plaza Designation Act of 2020," and Bill 23-839, the "Earl Wright, Jr. Way Designation Act of 2020."

The stated purpose of Bill 23-532 is to symbolically designate the 600 block of W Street N.W., in Ward 1, as *Dr. Montague Cobb Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-533 is to symbolically designate the 2400 block of 4th Street N.W., in Ward 1, as *Lucy Diggs Slowe Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map

Testimony of Lee Goodall on Bills 23-532, 23-533, 23-538, 23-609, 23-680, 23-787, and 23-839 highlighting the designated street. Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-538 is to symbolically designate the Frederick Douglass Court, SE in Square 5880, in Ward 8, as *Elaine M. Carter Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires one total sign, totaling \$190.

The stated purpose of Bill 23-609 is to symbolically designate the 300 block of 14th Place, N.E., in Ward 6, as *Gail Cobb Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 23-680 is to symbolically designate Wiltberger Street, N.W., between S Street, N.W., and T Street, N.W., on the border of Wards 1 and 6, as *Cecelia's Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires one total sign, totaling \$190.

The stated purpose of Bill 23-839 is to symbolically designate the 3800 block of 10th street NW, between Quincy, Randolph, and 10th Streets, N.W., in Ward 4, as *Earl Wright, Jr. Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires two total signs, totaling \$380.

Sufficient signage requires 11 total signs, totaling \$2,090. DDOT is able to absorb the costs of these signs within its current budget and does not foresee any operational impact these designations would have on the District's transportation network.

The stated purpose of Bill 23-787 is to symbolically designate 16th Street, N.W., between H Street, N.W., and K Street N.W., in Ward 2, as *Black Lives* Matter Plaza. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Signs have already been installed, pursuant to emergency and temporary legislation that effectuated this symbolic designation. On behalf of Mayor Muriel Bowser, I want to take a moment to reflect on the special significance of this designation. Black Lives Matter has been at the forefront of advocating for racial justice, including organizing protests, rallies, and other actions in response to the deaths of Eric Garner, Michael Brown, Tamir Rice, Freddie Gray, Sandra Bland, Alton Sterling, Philando Castile, and other Black men and women at the hands of police. In 2020, the deaths of George Floyd, Breonna Taylor, and several other Black men and women sparked new outrage, leading to a wave of protests across the country against racism and police brutality. In response to the protests in the District and across the country, and in recognition of the work that still needs to be done to ensure that Black lives do matter, Mayor Muriel Bowser stated publicly on June 5, 2020, that the portion of 16th Street N.W., between H Street N.W., and K Street

N.W., should be designated as Black Lives Matter Plaza. This designation reaffirms the value of the lives and legacy of the District's Black community and reaffirms our commitment to racial justice and equity.

Therefore, the Administration has no objection to these designations, and DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of these Bills being passed.

This concludes my testimony. Thank you for allowing me the opportunity to testify before you today. I am available to answer any questions that you may have.

Pursuant to D.C. Official Code § 9-204.22(b), this communication puts ANC 1B and its Commissioners on notice of an upcoming Committee of the Whole Public Hearing on Bill 23-532 the "Dr. Montague Cobb Way Designation Act of 2019." 
