I. BACKGROUND AND NEED

On February 27, 2020, Bill 23-680, the "Cecelia's Way Designation Act of 2020" was introduced by Councilmembers Charles Allen and Brianne Nadeau to symbolically designate Wiltberger Street, N.W. between S Street, N.W. and T Street, N.W., as "Cecelia's Way." A symbolic naming is for ceremonial purposes and shall be in addition to and subordinate to any name that is an official name.

Cecelia Penny Scott was a renowned business entrepreneur and philanthropist in Washington's African American community. She moved to the District when she was young and attended Armstrong Manual Training School and Dunbar High School. She then attended Howard University. In 1953, Ms. Scott opened a nightclub called Cecelia's on 12th Street, N.W., and in 1958 she moved the business to 618 T Street NW after buying the former Stage Door restaurant across Wiltberger Street from the Howard Theater. In a 1988 Washington Post Magazine feature on Ms. Scott and the history of nightlife on U Street, Ms. Scott said this of Cecelia's:

"At Cecelia's we served home-cooked food. Beef stew, lima beans, ham hocks and chitterlings. I had chops and steaks, too. The big drink was scotch -- Johnny Walker Black.

Jackie Wilson, Redd Foxx, Dinah Washington, Billie Holiday, all of them came in. Peg Leg Bates, all of those people. Cab Calloway, Jimmy Lunceford's band, the Count Basie band, we had them all. Joe Louis, Sugar Ray Robinson, some of the baseball players. On the second floor of my restaurant on T Street, I had a rooming house, like a little hotel. It was where the performers stayed. It was set up as a rooming house. Just about everybody stayed there." ¹

Mrs. Scott served in the District government under the Walter Washington and Marion Barry administrations. She founded CRM Development Corporation, the first African American woman-owned real estate development company in the District. She had a number of other real estate and business ventures including Banneker Plaza, Inc. Cecelia Scott also spearheaded philanthropic initiatives to help the less fortunate. Among those were Hospitality House, a home for needy families, and School Shoes, a shoe and sweater fund for children in the Shaw community.²

Cecelia's closed in 1969, a year after the riots following the assassination of Dr. Martin Luther King, Jr. devastated the U Street corridor.³ Over the past decade, the Shaw and U Street areas have been in the midst of substantial re-development. In 2019, most of the building that housed Cecelia's was razed to make way for a new mixed-use development called The Shaw. The north and west facades of 618 T Street were largely retained and integrated into the new building. The street proposed for designation runs between the Howard Theater and the façade of the former Cecelia's nightclub. Cecelia Scott died on April 23, 2004 after a short illness.⁴

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys. In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes,⁷ whereas a "symbolic name" for a street or alley shall be in addition to and subordinate to any name that is an official name.⁸ An official name of an alley shall contain the suffix "Alley" or "Court." A symbolic name of a street or alley shall contain the suffix "Way" or "Plaza." As established by Bill 23-680, "Cecelia's Way" is a symbolic street designation for Wiltberger Street, N.W. between S Street, N.W. and T Street, N.W.,

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming. Regarding Bill 23-680, ANCs 1B and 6E were notified directly of Bill 23-680 containing the proposed name on August 6, 2020. ANC 6E had already expressed support by letter dated February 23, 2020.

After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation ("DDOT") shall install signage indicating the symbolic name of the alley or street, or portion thereof. Such signage shall be uniform and distinct from signs for official names¹²

Symbolically designating the Wiltberger Street, N.W. between S Street, N.W. and T Street, N.W., as Cecelia's Way will memorialize Cecelia's nightclub and help preserve the important history of African American culture on U Street. Thus, the Committee of the Whole recommends the approval of Bill 23-680, the "Cecelia's Way Designation Act of 2020."

II. LEGISLATIVE CHRONOLOGY

February 27, 2020	Bill 23-680, the "Cecelia's Way Designation Act of 2020" is introduced by Councilmember Allen with co-introducer Councilmember Nadeau.
March 3, 2020	Bill 23-680 is "read" at a regular legislative meeting and the referral to the Committee of the Whole is official.
March 6, 2020	Notice of Intent to Act on Bill 23-680 is published in the <i>DC Register</i> .
August 7, 2020	Notice of a public hearing on Bill 23-680 is published in the <i>DC Register</i> .
September 15, 2020	The Committee of the Whole holds a hearing on Bill 23-680.
October 20, 2020	The Committee of the Whole marks up Bill 23-680.

III. POSITION OF THE EXECUTIVE

Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the symbolic street naming in Bill 23-680. His testimony is attached and also summarized below.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

ANC 6E, in which the eastern portion of the symbolic designation is located, voted unanimously on February 4, 2020 to request the symbolic designation of the subject portion of Wilteberger Street NW. A letter memorializing the ANC's support is attached to this report.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 23-680 on Thursday, September 15, 2020. The testimony summarized below pertains to Bill 23-680. Copies of written testimony are attached to this report.

Lee Goodall, Chief of Staff, Office of the Director, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the designation.

The Committee received letters in support of the designation (attached). The Committee received no testimony or comments in opposition to Bill 23-680.

VI. IMPACT ON EXISTING LAW

Bill 23-680 has no impact on existing law. D.C. Official Code § 9-204.01¹³ authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley "that shall be in addition to and subordinate to any name that is an official name." Bill 23-680 symbolically designates Wiltberger Street, N.W. between S Street, N.W. and T Street, N.W., as "Cecelia's Way." Additionally, "a symbolic name of a street or alley shall contain only the suffix Way or Plaza," such as proposed by Bill 23-680. Lastly, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. Mrs. Scott died in 2004.

VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2021 through fiscal year 2024 budget and financial plan to implement the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is estimated at \$190 (\$65 per sign for fabrication and \$125 for installation), the cost of Bill 23-680 can be absorbed, as noted in the October 19, 2020 Fiscal Impact Statement.

VIII. SECTION-BY-SECTION ANALYSIS

Section 1	States the short title of Bill 23-680.
Section 2	Symbolically designates Wiltberger Street, N.W. between S Street, N.W. and T Street, N.W., as "Cecelia's Way."
Section 3	Adopts the Fiscal Impact Statement.
Section 4	Establishes the effective date by stating the standard 30-day congressional review language.

Cecelia's Way Designation Act background and legislative history

During the renaissance of Historic U Street also known as "Black Broadway" and specifically the renovation of the Howard Theatre many DC residents began to discuss the contributions made to DC and America by the many luminaries of the Shaw community including Robert Gould Shaw for which the community is named, Duke Ellington, the International Sweethearts of Rhythm, Jimi Smooth, just to name a few. There was a refreshing enthusiasm about the new energy returning to the area after the long shadow of the 1968 riots. There was a feeling of nostalgia about the nightlife of the Shaw Community and many reminisced about their experiences at the very popular Cecelia's named for its founder Cecelia Penny Scott.

Ms. Scott a graduate of Dunbar High School attended Howard University. With a strong entrepreneurial spirit Ms. Scott purchased the Stage Door Restaurant across from the Howard Theatre in 1958 it was later renamed Cecelia's. Cecelia's was a very popular nightspot frequented by Washington's diverse political, artistic, social, and athletic communities. Cecelia's provided excellent food and housing for the many entertainers performing at the historic Howard Theatre and is an integral part and extension of its great history.

In addition to being the proprietor of Cecelia's Ms. Scott and Nadine Winters founded Hospitality House, a home for needy families, she worked tirelessly for her favorite project School Shoes, providing shoes and sweaters for the children in Shaw. Additionally, she established the first African American woman-owned real-estate development company in D.C.

Her commitment to the African American business community was demonstrated by her hard work as the first female President of the Local United Licensee Beverage Association when she organized a boycott against Anheuser-Bush who refused to hire African American employees. For over fifty years Cecelia was a savvy businesswoman who worked hard and remained committed to improving the Shaw community.

With the excitement of the reopening of the Howard Theatre Ms. Scott's daughter Evelyn "Tina" Boyd Principle and founder of Tina Boyd & Associates began efforts to secure symbolic street renaming of Wiltberger Street NW to Cecelia's Way. Ms. Boyd secured support for the initiative from the Shaw Community as well as local businesses, she presented the idea to the late Councilman Jim Graham who was more than delighted to assist Ms. Boyd with her dream of honoring her mother's legacy.

On June 15, 2010 Councilman Jim Graham introduced Cecelia's Way Designation Act of 2010 B12-860 to the Committee of the Whole. There was never a hearing or any activity on the legislation until Ms. Boyd revisited the issue with Council members Allen and Nadeau who agreed to introduce a bill honoring Ms. Scott. On February 27, 2020 the Cecelia's Way Designation Act of 2020 was introduced and referred to the Committee of Whole. Once again Ms. Boyd secured community support including ANC6E, The Howard Theatre and Monumental Realty. The Committee of the Whole conducted a hearing on the bill on September 15, 2020 with Ms. Boyd testifying requesting passage of the bill and Councilman Charles Allen of Ward 6 speaking in support of the bill.

Advisory Neighborhood Commission 6E conducted a public meeting on Tuesday, February 4th, 2020 at the Shaw Library, 1630 7th St., NW, to consider the applicant's request for the symbolic street name designation of Wiltberger Street NW to Cecelia's Way in honor of Cecelia Penny Scott.

Cecelia Penny Scott was a Shaw entrepreneur. After moving to Washington, she was educated in the DC public schools, including Armstrong Manual Training School and Dunbar High School and attended Howard University. In 1953, Scott opened Cecelia's at 2002 12th Street. In 1958, she purchased the Stage Door restaurant at 618 T Street, NW, across Wiltberger Street from the Howard Theatre and renamed it Cecelia's. Scott was a founder of Banneker Plaza, Inc., Hospitality House, School Shoes, and CRM Development Corporation, the first African American woman-owned real estate development company in the city. The west wall of the building at 618 T Street, NW that housed Cecelia's restaurant faces Wiltberger Street, NW, a one block street that extends from S Street. NW to T Street, NW. The façade of the building has been incorporated into The Shaw, a mixed use building that is currently under construction. It is therefore fitting that this street should be ceremonially named in honor of Cecelia Penny Scott and Cecelia's restaurant.

At the Commission's meeting, duly noticed, with a quorum present (four out of seven Commissioners required to be in attendance to achieve a quorum), ANC 6E voted to support (7 in favor, 0 opposed, and 0 abstention) the applicant's request for symbolic street name designation of Wiltberger Street NW to Cecelia's Way.

Pursuant to D.C. 
