Pursuant to D.C. Official Code §2-352.02(a), enclosed for consideration and approval by the Council of the District of Columbia is the proposed emergency legislation, the "Aramark Sports and Entertainment Services LLC Option Year One Emergency Approval Act of 2020" and accompanying declaration resolution to approve funding for option year one of Contract No. SO-15-030-0001049 with Aramark Sports and Entertainment Services, LLC for janitorial and related services at the Walter E. Washington Convention Center and Carnegie Library. The proposed period of performance is from October 1, 2020 to September 30, 2021. The dollar value of the proposed option year is a not-to-exceed amount of \$4,415,654.

The purpose of this option year exercise is for Aramark to continue to provide janitorial and related services at the Walter E. Washington Convention Center and at Carnegie Library. A full Contract Option Year Summary is provided.

17 To declare the existence of an emergency with respect to the need to approve funding for option
18 year one of contract No. SO-15-030-0001049 between the Washington Convention and
19 Sports Authority t/a Events DC and Aramark Sports and Entertainment Services, LLC

21 RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
22 resolution may be cited as the "Aramark Sports and Entertainment Services LLC Option Year
23 One Emergency Declaration Resolution of 2020".

24 Sec. 2. Emergency circumstances.

25 (a) There exists an immediate need to approve funding for option year one of
26 contract No. SO-15-030-0001049 between the Washington Convention and Sports Authority
27 ("Authority") and Aramark Sports and Entertainment Services, LLC ("Aramark") to allow
28 Aramark to continue to provide janitorial and related services at the Walter E. Washington
29 Convention Center ("Convention Center") and Carnegie Library, including enhanced cleaning
30 requirements to combat the spread of COVID-19.

31 (b) Funding for option year one of the contract with Aramark for janitorial and
32 related services (October 1, 2020 through September 30, 2021) shall not exceed \$4,415,654.

33 (c) Prompt Council action is necessary to ensure there is no disruption in janitorial
34 services at the Convention Center and Carnegie Library, particularly given the enhanced cleaning
35 requirements that will be necessary to reduce the spread of COVID-19 and to maintain the
36 Authority's Global Biorisk Advisory Council (GBAC) certification.

1 Sec. 3. Emergency declaration.

2 The Council of the District of Columbia determines that the circumstances enumerated in
3 this resolution constitute emergency circumstances making it necessary that the “Aramark Sports
4 and Entertainment LLC Option Year One Emergency Declaration Resolution of 2020” be
5 adopted after a single reading.

6 Sec. 4. Effective date.

7 This resolution shall take effect immediately.
