I. BACKGROUND AND NEED

Proposed Resolution 24-253, the "Commission on Out of School Time Grants and Youth Outcomes Matthew Hanson Confirmation Resolution of 2021," was introduced by Chairman Mendelson at the request of the Mayor on May 20, 2021 and referred to the Committee of the Whole. The purpose of PR 24-253 is to confirm the Mayor's nomination of Mr. Matthew Hanson for appointment to the Commission on Out of School Time Grants and Youth Outcomes, to serve for a term to end on November 7, 2023.

The Commission is a public body composed of engaged residents and representatives from government agencies to support equitable access to high-quality OST programs for District of Columbia youth through coordination among government agencies, targeted grant-making, data collection and evaluation, and the provision of training, capacity building, and technical assistance to OST providers. The Commission will provide resources and support to ensure a citywide system of high-quality OST programs. The Commission shall consist of no more than 21 members who represent key community stakeholder constituencies or are District agency administrative heads or their designees. The Commission members are:

This is Mr. Hanson's first nomination to serve on this Commission. He is a political activist, organizer, policy analyst, and registered public interest lobbyist. He has over 15 years of experience in public activism. He has worked for labor unions and policy advocacy groups up and

down the East Coast – though primarily in DC – and in Mexico. In addition, he has led political campaigns for parties and individual candidates in the DMV area. In his spare time, he has volunteered with community groups and human rights organizations. He is a published columnist and previously served on the DC Fair Elections Commission. He is an expert in campaign management, organizing, executive strategy, and the labor movement. Should his nomination be confirmed, he hopes to contribute to students' academic success, and social and emotional learning through access to high-quality opportunities outside the classroom.

Based on his stated commitment to the mission of the Commission, his civic leadership, and his expertise regarding OST programs, the Committee recommends the appointment of Mr. Hanson to the Commission on Out of School Time Grants and Youth Outcomes. The Committee recommends adoption of PR 24-253.

III. POSITION OF THE EXECUTIVE

Mr. Hanson is the Mayor's nominee for appointment to the Commission on Out of School Time Grants and Youth Outcomes.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-253.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on four Commission on Out of School Time Grants and Youth Outcomes nominations, including PR 24-253, on Thursday, July 9, 2021. The testimony summarized below is from that hearing. Submitted copies of testimony are attached to this report.

Matthew Hanson, *Appointee*, testified and answered questions from Chairman Mendelson regarding his background and experience as it pertains to the Commission and his interest in serving a term on the Commission.

Mr. Hanson explained that he has worked for over a decade as a public advocate, and prior to that, served with AmeriCorps in the District. During his service with AmeriCorps, he saw firsthand the importance of OST programs. As the chief of staff at DC Action, he helps the organization use data, research, and a racial equity lens to break down barriers for youth of color throughout the District. DC Action is the home of the Under 3 DC Coalition, the DC OST Coalition, and the DC Kids Count Coalition. He coordinates the OST Coalition, which is made up of dozens of programs across all eight wards. The Coalition helps DC Action perform original policy research an analysis. In his view, the Coalition aligns perfectly with the Commission. He noted that families are counting on OST programs more than ever before, because of the pandemic, and he is eager to promote holistic solutions to these challenges so that children grow up safe, resilient, powerful, and heard. Similarly, the Coalition has grown substantially during the pandemic, and now has about 40 representatives from member organizations. The Coalition features guest speakers from across the District, such as councilmembers, Council staff, the Deputy Mayor for Education's office, DCPS, the Executive, and nonprofits, among others. One of the Coalition's more effective tools for promoting and documenting their work is their blog and vlog, which highlights stories of students involved in these programs, and how they help the students grow as people, help them succeed upon graduation, and increase their learning ability.

Mr. Hanson views his nomination as an opportunity to participate and make a difference in the community. He expanded on his desire to increase funds significantly for OST and repeated his gratitude to the Committee of the Whole for its public support for doing so as well. He expressed his view that the Commission plays an important role throughout the District and that he wishes to work collaboratively. As a first-time nominee, he explained that he has some logistical feedback about rollover dollars for grants, should he be confirmed, along with how to best rebound from the pandemic. He looks forward to working with the other Commissioners on needs-based assessments with an equity lens for grants, taking a data-driven approach. Finally, he stressed taking a holistic approach to program evaluation, to incorporate academics into non-academic OST programs (i.e., arts and athletics), to help mitigate pandemic-related learning loss.

Mr. Hanson reiterated that he is current on his taxes owed to all jurisdictions, has no conflicts of interest, anticipates no future conflicts of interest, and has time to serve.

VI. IMPACT ON EXISTING LAW

The Commission on Out of School Time Grants and Youth Outcomes is established pursuant to D.C. Code § 2-1555.02. PR 24-253 is an exercise of the Council's discretion to approve

or disapprove Mayoral nominations to Boards and Commissions, pursuant to the Confirmation Act of 1978 (D.C. Law 2-142; D.C. Code § 1-523.01).

VII. FISCAL IMPACT

The Office of the Chief Financial Officer indicates that a Fiscal Impact Statement is not needed for a confirmation. Commission members are not compensated for their service.

VIII. SECTION-BY-SECTION ANALYSIS

During my time at WFP, I worked on electoral and legislative campaigns, including Fair Elections, paid family and medical leave, ShareBetter (a housing campaign to reign in AirBnB), the Under 3 DC campaign for child care and others. I took a leave of absence from WFP in 2018 to manage Ed Lazere's campaign for Chair of the DC Council. In 2020, I volunteered on campaigns outside of work, including Janeese Lewis-George's campaign for Ward Four councilmember, Eboni-Rose Thompson's campaign for Ward Seven SBOE, and Ed Lazere's 2020 run for at-large councilmember. In addition to my paid and volunteer activity, I have also written about DC politics, including for the DC Line (calling for then councilmember Jack Evans resignation) and The Forge. Since joining DC Action in March of 2020, I have advocated and testified in support of issues before the council, ranging from the need to invest more in child care, the importance of restoring funding for child care, tax fairness for working families, how to improve our elections, and more.

Good morning, Chairman Mendelson and members of the Committee of the Whole. My name is Matthew Hanson, and I appreciate the opportunity to testify today regarding my confirmation to the Commission on Out of School Time Grants and Youth Outcomes. I would also like to thank the Mayor for nominating me to this position.

In addition to having spent more than a decade working as an advocate, from 2005 to 2007 I served as an AmeriCorps member in Washington, DC. During this time I worked in dozens of public and public charter schools and saw firsthand the importance and value of OST programming. This period helped shape my commitment to advancing just policies and practices that center the needs of children and families.

I currently serve as the Chief of Staff at DC Action, an organization that uses research, data, and a racial equity lens to break down barriers that stand in the way of all kids reaching their full potential. Our collaborative advocacy initiatives bring the power of young people and all residents to raise their voices to create change. We are also the home of the DC Out-of-School Time Coalition, the Under 3 DC Coalition, and DC KIDS COUNT—an online resource that tracks key indicators of child and youth well-being.

It would be an honor and a privilege to serve on the Commission on Out of School Time Grants and Youth Outcomes. As the Chief of Staff at DC Action, I facilitate the DC Out-of-School Time Coalition, along with our Policy Analyst Ryllie Danylko, to help ensure that out of school time ("OST") programs have a voice in shaping the decisions and policies that directly affect them and the young people they serve. Our coalition is made up of dozens of programs from across the District that serve all eight wards. Together we advocate for access to high-quality learning opportunities beyond the school day that prepare DC's youth for success in education, careers, and life. We also conduct original policy analysis and research to support our efforts. I believe our mission aligns perfectly with that of the OST Commission.

OST programs play a vital role in supporting students' academic success and social and emotional learning, and now more than ever, families are counting on these programs. The pandemic has put greater stress on communities and worsened education disparities more than anyone could have imagined a year ago, and we need to work together to make sure we promote holistic solutions to these challenges. If confirmed, I hope to bring our organizational and coalition support and knowledge to the table to advance our shared goals of ensuring every young person grows up safe, resilient, powerful, and heard.

Our coalition has grown from about a dozen member organizations to more than 50 members in the first six months of 2021 and has worked hard to advance the interests of young people and the programs that serve them. Each month, we hold virtual coalition meetings attended by up to 40 representatives from member organizations and meet weekly as a core team to plan our agenda and the issues we face. We invite guest speakers from groups such as the Washington Regional Association of Grantmakers, DC Fiscal Policy Institute, Learn24, and DCPS, and have organized meetings with Deputy Mayor for Education (DME) Paul Kihn, DCPS Chancellor Lewis Ferebee, all District lead education agencies, and Councilmembers and their staff. Because the difficult, yet rewarding and important work of OST programs is often overlooked, we've also worked to elevate our programs' labor and service. We have published 12 blog posts on the DC Action website featuring stories of OST organizations' continued efforts to provide vital services to District children and families during the COVID-19 pandemic, and how they are preparing students for a smooth and successful transition back to in-person learning. The blog series features organizations that stepped up to help students navigate distance learning at the beginning of the pandemic, went above and beyond to provide resources and referrals to families, and helped students deal with trauma and find a sense of belonging in a time of widespread isolation.

We also featured the voices of 12 youth OST participants in a video series where they shared what they love about their programs and how OST offerings have helped them with school and life. Some of the messages students shared were, "[t]he enrichment activities and lessons help me to grow as a person and prepare me for future experiences after graduating from high school," and "[h]having a program like this after school and during the summer means a lot because it will increase my learning ability when I enter the third grade."

We've done all of this and we're just getting started. If invited to join the Commission, I hope to serve as a partner in advancing equity within OST. Finally, this work is also personal to me. I first moved to the DC area in 2000, with a brief period away for school and work. My wife and I moved back into the District in 2013, and welcomed our child into the world in 2018. We live in Ward 7 and I am active in our community, volunteering with causes and organizations that align

with our values, and that promote anti-racist and just programs and policies so that we have a District that includes and works for everyone.
