I. BACKGROUND AND NEED

Proposed Resolution 24-254, the "Commission on Out of School Time Grants and Youth Outcomes Rev. Gary Hill Confirmation Resolution of 2021," was introduced by Chairman Mendelson at the request of the Mayor on May 20, 2021 and referred to the Committee of the Whole. The purpose of PR 24-254 is to confirm the Mayor's nomination of Rev. Gary Hill for reappointment to the Commission on Out of School Time Grants and Youth Outcomes, to serve for a term to end on November 7, 2023.

The Commission is a public body composed of engaged residents and representatives from government agencies to support equitable access to high-quality OST programs for District of Columbia youth through coordination among government agencies, targeted grant-making, data collection and evaluation, and the provision of training, capacity building, and technical assistance to OST providers. The Commission will provide resources and support to ensure a citywide system of high-quality OST programs. The Commission shall consist of no more than 21 members who represent key community stakeholder constituencies or are District agency administrative heads or their designees. The Commission members are:

Rev. Gary Hill has been serving on the Commission since 2017. He is an ordained and licensed minister with business and nonprofit management experience. He is a former public servant and government contractor, working for NIH for 18 years and contracting with various

federal agencies in managerial capacities for another decade. Currently, Rev. Hill is the founding executive director of Exodus Treatment Center, a nonprofit that provides drug education, substance abuse / addiction intervention, mental health services, and recovery support services to low- and moderate-income families in the DMV area. In his spare time, he serves as an advisor to the MPD Commander for the 7th District and the DC Housing Authority's executive office, and as a spiritual advisor to Ward 8 Councilman Trayon White, Sr. and several churches in the area. He is an expert in business development, customer service, marketing, and organizational leadership. Should his renomination be confirmed, Rev. Hill hopes to continue contributing to a district-wide strategy for equitable access to out of school time programs for District youth and resolving any geographic funding and distribution gaps for these programs.

Based on his continued commitment to the mission of the Commission, his civic leadership, and his expertise regarding nonprofits and youth mentorship, the Committee recommends the reappointment of Rev. Hill to the Commission on Out of School Time Grants and Youth Outcomes. The Committee recommends adoption of PR 24-254.

III. POSITION OF THE EXECUTIVE

Rev. Hill is the Mayor's nominee for appointment to the Commission on Out of School Time Grants and Youth Outcomes.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-254.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on four Commission on Out of School Time Grants and Youth Outcomes nominations, including PR 24-254, on Thursday, July 9, 2021. The testimony summarized below is from that hearing. Submitted copies of testimony are attached to this report.

Rev. Gary Hill, Appointee, testified and answered questions from Chairman Mendelson regarding his background and experience as it pertains to the Commission and his interest in serving another term on the Commission.

Rev. Hill explained that in addition to his work at Exodus Treatment Center, he is the senior pastor at its sister entity, Exodus Deliverance Ministry. Throughout the pandemic, his organizations ran COVID testing sites and managed PPE distribution throughout wards 7 and 8. He has also served on a faith-based leadership team focused on preventing gun violence. Throughout his career, he has focused on capacity-building and mentorship. He aims to help youth make better life choices through strategic planning to ensure their long-term success. Rev. Hill's approach to public and community service is grounded in ethics, integrity, and delivering equitable services.

Rev. Hill noted that, during his first term on the Commission, the challenges it faced was building up its momentum, especially in the early months of its existence. Certain specific challenges revolved around finalizing certain official information, especially as the Commission was not meeting weekly. The time lag caused by monthly, instead of weekly, meetings posed a hurdle to the Commission and its members. However, the Commission has since been doing a good job in communities east of the River, according to Rev. Hill, where there is an existing deficit of educational efforts. The Commission has established two committees in particular that he views as essential: the Needs Assessment Committee and the Funding & Capacity Committee. These committees complement individual commissioners' efforts, outside of regular Commission meetings, to obtain feedback from the community regarding OST programs. Rev. Hill explained that the output of these three efforts, when combined in full OST Commission meetings, leverage equity across all eight wards.

Rev. Hill reiterated that he is current on his taxes owed to all jurisdictions, has no conflicts of interest, anticipates no future conflicts of interest, has time to serve, and that the current time he dedicates to the Commission is reasonable.

VI. IMPACT ON EXISTING LAW

The Commission on Out of School Time Grants and Youth Outcomes is established pursuant to D.C. Code § 2-1555.02. PR 24-254 is an exercise of the Council's discretion to approve or disapprove Mayoral nominations to Boards and Commissions, pursuant to the Confirmation Act of 1978 (D.C. Law 2-142; D.C. Code § 1-523.01).

VII. FISCAL IMPACT

The Office of the Chief Financial Officer indicates that a Fiscal Impact Statement is not needed for a confirmation. Commission members are not compensated for their service.

VIII. SECTION-BY-SECTION ANALYSIS

Good morning Chairman Mendelson and Members of the Committee of the Whole. First, I want to express my sincerest thank you to Mayor Bowser for this nomination to the District's Commission on Out of School Time Grants and Youth Outcomes (Commission). Secondly, I would like to thank the Committee members for holding this hearing and the opportunity to address you today.

For my commitment to implement lasting change in the communities I serve, I received the "Be the Solution" award from New Beginnings Leadership Institute.

In addition, I serve as a Commissioner for the Office of Out of School Time Grants and Youth Outcomes for two consecutive years. I partner with smaller nonprofits to strengthen, mentor, and build capacity. Similarly, I serve as an advisor to the 7th District Metropolitan Police Department Commander, DC Housing Authority Executive Office, and community stakeholders.

As a dependable public servant, I advocate for the needs of underserved populations and my organization serves as a connector for District residents, neighboring communities, and government entities. Additionally, through my work I have been able to influence at-risk youth to make better life choices through strategic programming such as the urban institute pass project, exodus girls group in summer camp, and the homework club.
