Council Chairman Phil Mendelson announces a public roundtable before the Committee of the Whole on "Speeding Electrification of WMATA's Bus Fleet." The roundtable will be held at 1:00 p.m. on Thursday, September 30, 2021 live via Zoom Video Conference Broadcast.

The Washington Metropolitan Area Transit Authority's (WMATA) target date for electrifying its fleet is 2045 – over two decades away. While it has plans to launch a two-year pilot project with 12 electric buses and facilities for charging, it is unclear why WMATA is not being more aggressive in its electrification efforts. The purpose of this roundtable is to examine the difficulties and potential challenges in speeding the electrification of WMATA's bus fleet. This hearing will gather testimony from experts on how WMATA could set a more aggressive goal for electrification and get more EV buses on the road. Specifically, the hearing will address lifecycle costs for electric buses, bus range, charging infrastructure, funding opportunities, and the experience of other agencies and jurisdictions with substantial electric fleets.

This roundtable is limited to invited witnesses only. Testimony from each invited witness is limited to five minutes unless a longer time limit is arranged. Witnesses who anticipate needing spoken language interpretation, or require sign language interpretation, are requested to inform the Committee office of the need as soon as possible but no later than five business days before the proceeding. We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.
