Council Chairman Phil Mendelson announces a public hearing of the Committee of the Whole on Bill 24-80, "DC State Education Agency Independence Amendment Act of 2021" and Bill 24-101, the "Office of the State Superintendent of Education Independence Amendment Act of 2021." The hearing will be on Tuesday, October 26, 2021, at 11:00 a.m. via Zoom videoconference.

The purpose of Bills 24-80 and 24-101 is to make the Office of the State Superintendent of Education (OSSE) independent from the Mayor. **Bill 24-80** would make OSSE subordinate to the State Board of Education, provide SBOE with the authority to appoint the State Superintendent of Education, and allow employees of the District of Columbia Public Schools to serve on the SBOE. **Bill 24-101** would make OSSE an independent agency within the District government and limit the Mayor to be able to remove the State Superintendent only for cause. Currently, the Mayor may remove the State Superintendent for any reason. The bill also clarifies OSSE's oversight responsibilities, requiring the agency to verify data produced by local education agencies (LEA) and to investigate allegations of waste, fraud, or fiscal mismanagement by LEAs.

We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.
