The purpose of PR 24-414 is to appoint Dr. Delia L. Houseal to the Commission on Health Equity as a nonvoting community advisory member from Ward 7. The purpose of PR 24-427 is to reappoint Ms. Alicia Wilson to the Commission on Health Equity as a voting member for a term to end on July 7, 2023. The

purpose of PR 24-428 is to appoint Raymond A. Skinner to the District of Columbia Housing Authority Board of Commissioners for a term to end on December 31, 2024. The purpose of PR 24-429 is to appoint Dr. Wanda Thompson to the Citizen Review Panel for the Prevention of Child Abuse and Neglect for a term of three years. The purpose of PR 24-430 is to reappoint Dr. Christopher J. King to the Commission on Health Equity as a voting member for a term to end on July 7, 2024.
