## Implementation of DCRA's Third-Party Inspection Platform (Tertius)

Council Chairman Phil Mendelson announces the scheduling of a public roundtable of the Committee of the Whole on the implementation of the Department of Consumer and Regulatory Affairs' Third-Party Inspection Platform known as Tertius. The hearing will be held on Tuesday, November 30, 2021 at 1:00 p.m. via Zoom. This roundtable notice has been revised to reflect the change in date and time of the roundtable from November 17, 2021 at 2:00 p.m. to November 30, 2021 at 1:00 p.m.

In Title VI, Subtitle G of the Fiscal Year 2021 Budget Support Act of 2020, the Department of Consumer and Regulatory Affairs was authorized to establish an "online platform" through which individuals or entities may hire a third-party inspector, and to charge fees for the use of the platform. At the beginning of October, the Committee began receiving correspondence from third-party inspectors and representatives of developers outlining grave concerns with the rollout of the platform DCRA selected, known as Tertius. This roundtable is being held to collect testimony from third-party inspectors and developers, and to ask questions of DCRA, about the implementation of this new software platform.
