I. BACKGROUND AND NEED

On January 4, 2021, Bill 24-11, the "Alpha Phi Alpha Way Designation Act of 2021" was introduced by Councilmembers McDuffie and Robert White. This bill would symbolically designate First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W., in Ward 5, as Alpha Phi Alpha Way. A symbolic naming is for ceremonial purposes and shall be in addition to and subordinate to any name that is an official name.

Alpha Phi Alpha Fraternity, Inc. was established in 1906 at Cornel University in New York. It was the first intercollegiate, Greek-letter fraternity in the country for African American men. Since its founding, the organization has established over 730 active chapters and has over 290,000 members across the world including Africa, Europe, Asia, and the Caribbean islands. Alpha Phi Alpha has produced well-known and revered African American civil rights activists, especially during the Civil Rights Movement in the 1960s, including the first African American Supreme Court justice, Justice Thurgood Marshall; the Reverend Martin Luther King, Jr.; NAACP founder, W.E.B. DuBois; comedian, Dick Gregory; District native, Duke Ellington; and Charles Hamilton Houston, "The Man Who Killed Jim Crow."

The D.C. Chapters of the Alpha Phi Alpha consists of three undergraduate and three alumni chapters, including the Beta Chapter established in 1907, the Mu Lambda Chapter established in 1923, the Omicron Lambda Alpha Chapter established in 1952, the Nu Beta Chapter established in 1977, the Omicron Omicron Chapter established in 1982, and the Omicron Eta Lambda Chapter established in 1985. These six chapters have been actively engaged in the District's social, civic, and humanitarian issues and have made a significant contribution to the quality of life of District residents. Alpha Phi Alpha Fraternity, Incorporated was directly responsible for the conception, funding, and construction of the MLK Memorial next to the National Mall.

The Mu Lambda chapter was chartered in 1923, and its chapter house is located at 2405 First Street, NW, in Ward 5, the site of the proposed symbolic designation.

Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. The Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys. In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.²

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes,³ whereas a "symbolic name" for a street or alley shall be in addition to and subordinate to any name that is an official name.⁴ An official name of an alley shall contain the suffix "Alley" or "Court." A symbolic name of a street or alley shall contain the suffix "Way" or "Plaza." As established by Bill 24-11, "Alpha Phi Alpha" is a symbolic street designation for First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W.

The Act also establishes a notice requirement for symbolic designations. Pursuant to D.C. Official Code § 9-204.23(b), the ANC in which the symbolic designation is located must be put on notice of the public hearing regarding the proposed naming.⁷ Regarding Bill 24-11, the ANC was notified of the legislation by the Committee on October 4, 2021.

After the symbolic street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, the District Department of Transportation

("DDOT") shall install signage indicating the symbolic name of the alley or street, or portion thereof. Such signage shall be uniform and distinct from signs for official names⁸

Conclusion

Symbolically designating First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W., as Alpha Phi Alpha Way, will recognize the historic fraternity and its good works in the community. Thus, the Committee of the Whole recommends Council approval of Bill 24-11, the "Alpha Phi Alpha Way Designation Act of 2021."

II. LEGISLATIVE CHRONOLOGY

November 3, 2021	The Committee of the Whole holds a hearing on Bill 24-11.
November 16, 2021	The Committee of the Whole marks up Bill 24-11.

III. POSITION OF THE EXECUTIVE

Dan Emerine, Manager, Policy and Legislative Affairs, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the symbolic street naming in Bill 24-11. DDOT testified at the hearing that the cost of the signage contemplated in the bill is \$950. His testimony is attached and also summarized below.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from Advisory Neighborhood Commissions regarding this bill.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on Bill 24-11 on Wednesday, November 3, 2021. The testimony is summarized below. Copies of written testimony are attached to this report.

Byron L. Williams, Member, Alpha Phi Alpha Fraternity, Inc., testified in support of the proposed symbolic designation.

John Wilson, President, Mu Lambda Chapter, Alpha Phi Alpha Fraternity, Inc., testified in support of the proposed symbolic designation.

Rylan Harris, Mu Lambda Foundation Board Member, Alpha Phi Alpha Fraternity, Inc., testified in support of the proposed symbolic designation.

Christopher Ellis, Member, Alpha Phi Alpha Fraternity, Inc., testified in support of the proposed symbolic designation.

Dan Emerine, Manager, Policy and Legislative Affairs, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the designation.

The Committee received written testimony from Besty McDaniel, which is attached.

The Committee received no testimony or comments in opposition to Bill 24-11.

VI. IMPACT ON EXISTING LAW

Bill 24-11 has no impact on existing law. D.C. Official Code § 9-204.01⁹ authorizes the Council to name any public space. D.C. Official Code § 9-204.03(a) authorizes the Council to designate a symbolic name for an alley "that shall be in addition to and subordinate to any name that is an official name." Bill 24-11 symbolically designates First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W., as "Alpha Phi Alpha Way." Additionally, "a symbolic name of a street or alley shall contain only the suffix Way or Plaza," such as proposed by Bill 24-11. Lastly, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. 12

VII. FISCAL IMPACT

Funds are sufficient in the fiscal year 2021 through fiscal year 2024 budget and financial plan to implement the proposed legislation. Because the cost to the District Department of Transportation (DDOT) is estimated at \$950 (\$65 per sign for fabrication and \$125 for installation), the cost of Bill 24-11 can be absorbed, as noted in the November 15, 2021 Fiscal Impact Statement.

A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To symbolically designate First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W., in Ward 5 as Alpha Phi Alpha Way in Ward 5.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Alpha Phi Alpha Way Designation Act of 2021".

Sec. 2. Pursuant to sections 401, 403a, and 423 of the Street and Alley Closing Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01, 9-204.03a, and 9-204.23), the Council symbolically designates the First Street, N.W., between Bryant Street, N.W., and Michigan Avenue, N.W., in Ward 5, as "Alpha Phi Alpha Way".

Sec. 4. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 4a of the General Legislative Procedures Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

Sec. 5. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act approved December

Since December 1906 Alpha Phi Alpha Fraternity, Inc has been tenacious in our campaign for equitable rights and civil rights. Alpha Phi Alpha's local chapters and members in the District of Columbia have kept that fire burning ardently. Nationally, Alpha Phi Alpha was directly responsible for the conception, funding and construction of the Dr. Martin Luther King Jr. Memorial, who is one of our most well-known members worldwide.

Alpha Phi Alpha has been present and actively engaged in the DC community as working professionals since 1923 and we have partnered with numerous community-based organizations focused health, safety, and wellness along with initiatives under various mayors, councilmembers, and Advisory Neighborhood Councils.

Good morning Chairman Mendelson, members of the Council, staff, and District residents. My name is Dan Emerine, and I am the Manager of the Policy and Legislative Affairs Division at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Director Everett Lott regarding nine bills, which are Bill 24-11, the "Alpha Phi Alpha Way Designation Act of 2021," Bill 24-22, the "Jamal Khashoggi Way Designation Act of 2021," Bill 24-24, the "Ruth Bader Ginsburg Way Designation Act of 2021," Bill 24-117, the "Armstead Barnett Way Designation Act of 2021," Bill 24-145, the "Navy Place, S.E. Redesignation Act of 2021," Bill 24-160, the "Willie J. Hardy Memorial Bridge Designation Act of 2021," Bill 24-214, the "Alice Washington Way Designation Act of 2021," and Bill 24-336, the "Wiltberger East Alleys Designation Act of 2021."

The stated purpose of Bill 24-11 is to symbolically designate First Street, N.W., between Bryant Street, N.W. and Michigan Avenue, N.W., in Ward 5 as *Alpha Phi Alpha Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires five total signs, totaling \$950.

The stated purpose of Bill 24-22 is to symbolically designate New Hampshire Avenue, N.W., between Virginia Avenue, N.W. and F Street, N.W., in Ward 2, as *Jamal Khashoggi Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires three total signs, totaling \$570.

The stated purpose of Bill 24-24 is to symbolically designate Virginia Avenue, N.W., between Rock Creek and Potomac Parkway, N.W. and New Hampshire Avenue, N.W., in Ward 2, as *Ruth Bader Ginsburg Way*, and to allow a public space in the District to be named in honor of a justice of the Supreme Court of the United States who has been deceased for less than 2 years. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires three total signs, totaling \$570.

The stated purpose of Bill 24-117 is to symbolically designate the 600 block of Division Avenue, N.E., in Ward 7, as *Armstead Barnett Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 24-145 is to officially re-designate the street known as Ellen Wilson Place, S.E., in Ward 6, as *Navy Place S.E.* For visualization

purposes, I have attached to this testimony a copy of the plat of the designated street. Sufficient signage requires three total signs, totaling \$570.

The stated purpose of Bill 24-160 is to officially re-designate the bridge on Benning Road, N.E., located between 34th Street, N.E., and Minnesota Avenue, N.E., in Ward 7, as the *Willie J. Hardy Memorial Bridge*. For visualization purposes, I have attached to this testimony a copy of the plat highlighting the designated bridge. Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 24-214 is to symbolically designate the 2700 block of Sherman Avenue, N.W., in Ward 1, as *Alice Washington Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated street. Sufficient signage requires two total signs, totaling \$380.

The stated purpose of Bill 24-336 is to symbolically designate the public alley system within Square 441, bounded by Wiltberger Street, N.W., T Street, N.W., T Street, N.W., Florida Avenue, N.W., 6th Street, N.W., and S Street, N.W. in Ward 6, as *Holzbeirlein Bakery Way*, *Joe and Mae Hurd All Sports Club Way*, and *Wiltberger Club House Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the designated alleys. Sufficient signage requires six total signs and 5 posts, totaling \$1,315.

Sufficient signage requires 26 total signs and 5 posts, totaling \$5,115.

DDOT is able to absorb the costs of these signs within its current budget and does

not foresee any operational impact these designations would have on the District's transportation network.

Therefore, the Administration has no objection to these designations, and DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of these Bills being passed.

Council of the District of Columbia Committee of the Whole Public Hearing Bill 24-22, Jamal Khashoggi Way Designation Act of 2021 Statement for the Record, Rep. Gerald E. Connolly (D-VA)

First and foremost, I want to recognize that the decision before the Council to rename the street in front of the Embassy of the Kingdom of Saudi Arabia is strictly a local issue and should be decided by the Council. I have a long record of fighting for the right of the District and its residents to make their own decisions about how they wish to be governed, including defeating attacks on abortion rights and marijuana legalization in the District and of course decades spent championing DC Statehood.

Today, I provide testimony on the bill currently before the Council, Bill 24-22 the Jamal Khashoggi Way Designation Act of 2021, because Jamal Khashoggi was my constituent. In fact, I had dinner with him just months before he was brutally murdered. I am committed to justice and representation for Jamal, and it is with that purpose that I join the Council's deliberations on this legislation.

In February of this year, more than two years after the cold-blooded murder of Washington Post journalist, and my constituent, Jamal Khashoggi, the Director of National Intelligence released a previously classified U.S. intelligence report. The report clearly stated: "We assess that Saudi Arabia's Crown Prince Muhammad bin Salman approved an operation in Istanbul, Turkey to capture or kill Saudi journalist Jamal Khashoggi." It concluded that "since 2017, the Crown Prince has had absolute control of the Kingdom's security and intelligence organizations, making it highly unlikely that Saudi officials would have carried out an operation of this nature without the Crown Prince's authorization."

We've always known, beyond a shadow of a doubt, that Crown Prince Muhammad bin Salman directed the assassination of Jamal Khashoggi. We also know that this operation is part of a broad and ongoing effort to use violence to intimidate and silence dissidents abroad. Furthermore, we know that some of the killers of Jamal Khashoggi were trained in the United States, demonstrating an overwhelming need for reforms to our current arms sales processes and increased accountability. And yet, despite all this, Crown Prince MBS and Saudi Arabia have generally been shielded from accountability, especially by the previous administration, signaling this kind of abhorrent behavior was somehow ok, inviting further atrocities.

That impunity can end with legislation like the bill before the Council today. And we have ongoing legislative efforts moving at the federal level that would do the same.

My bill, H.R. 1392, the Protection of Saudi Dissidents Act of 2021, passed the House with overwhelming bipartisan support earlier this year and is currently moving as part of the FY2022 National Defense Authorization Act.

The Protection of Saudi Dissidents Act is targeted and does four things, specifically:


- o It limits arms exports to Saudi intelligence, internal security, or law enforcement entities if the President finds that Saudi Arabia has engaged in the following activities:
 - Forced repatriation, intimidation, or killing of dissidents in other countries;
 - The unjust imprisonment in Saudi Arabia of United States citizens or residents or the placing of travel restrictions on them or their family members;
 - And the torture of detainees in the custody of the Government of Saudi Arabia.
- o It requires the closure of one or more Saudi diplomatic facilities if the President finds that Saudi Arabia is using diplomatic or consular personnel to harass or harm Saudi nationals in the United States.
- o It requires a report on whether Saudi Arabia has been engaged in a consistent pattern of acts of intimidation or harassment directed against individuals in the United States.
- o And finally, it requires a report on whether the US intelligence community fulfilled its duty to warn Jamal Khashoggi of threats to his life.

This legislation has the support of dozens of human rights organizations, including the Committee to Protect Journalists, Reporters Without Borders, PEN America, Human Rights First, Human Rights Watch, Freedom Now, and many others.

When we turn a blind eye to human rights abuses, we embolden friend and foe alike to continue to engage in these horrific violations. We must end this "two-year pageant of impunity" and finally hold Saudi Arabia accountable for their treatment of dissidents and those who stand up for human rights and against autocratic repression. Jamal Khashoggi was not the only one to face the brutality of the Saudi regime and is not the only one who would benefit from the actions the Council and Congress are considering with respect to accountability for Saudi Arabia.

Please add my voice, as Jamal's Congressman, to the chorus of support for the Jamal Khashoggi Way Designation Act of 2021.
