**I. BACKGROUND AND NEED**

The purpose of PR 24-358, the “District of Columbia Retirement Board Adam Weers Reappointment Resolution of 2021,” is to appoint Adam Weers as one of the three Council appointees to the District of Columbia Retirement Board (DCRB). Mr. Weers is a resident of Ward 5. If approved, Mr. Weers would serve a four-year term to end January 27, 2023. Mr. Weers would replace Michael Warren whose term ended on January 27, 2021.

Mr. Weers holds a Bachelor of Arts degree from Morehouse College, a Master’s degree in Financial Accounting from Georgia State University, and a Master’s of Business Administration from Harvard University. Currently Mr. Weers serves as the Chief Operating Officer for Trammel Crowe Company where he administers the Investment Committee and Executive Commisttee process, and oversees Marketing. Trammel Crowe is a real estate development company in the District and Mr. Weers has been involved in a number of development projects focusing on retail and housing production. He serves on the company’s Diversity, Equity, and Inclusion Steering

Committee. In addition, Mr. Weers currently serves as Chair of the DC Combat Sports Commission.

Mr. Weers testified to his experience on a number of other boards and institutions including Dance Place and Miriam’s Kitchen. He has experience as a financial auditor at Deloitte. He has also participated in various Investment Committees and as a Trustee for the National Housing Production Foundation. He also testified to his insights in the DCRB and highlighted his knowledge of investment from his past experiences and his current role at Trammell Crow. He hopes to bring his experience in pursuing best practices to the Board.

The DCRB is an independent agency of the District of Columbia Government established in accordance with section 121(a) of the District of Columbia Retirement Reform Act of 1979.<sup>1</sup> The Board has exclusive authority to manage the pension funds of the D.C. Police Officers and Firefighters’ and Teachers’ Retirement Funds. The Board has three Council-appointees. In addition, the Board has three members appointed by the Mayor, and one member each appointed by active police officers, firefighters, and teachers, and by retired police officers, firefighters, and teachers.<sup>2</sup> At least two members appointed by the Mayor and at least one member appointed by the Council must be individuals who have professional experience in the banking, insurance, or investment industry.<sup>3</sup>

The DCRB manages two plans: the DC Police Officers and Firefighters’ Retirement Fund and the District of Columbia Teachers’ Retirement Fund. While other cities and states are struggling to figure out how they are going to pay its government employees when they retire, the Police and Firefighters’ retirement plan is over a 100% funded and the Teachers’ retirement plan is over 90% funded. Indeed, the District’s Firefighters and Police Officers’ plan is one of only four plans that is fully funded in the United States.<sup>8</sup> Such success is a direct result of the prudent and wise management of the plans by the DCRB trustees. In part because Mr. Weers has served as a DCRB trustee for over 15 years and worked to facilitate a collaborative atmosphere between DCRB and the Council, the Board and the Council have been able to work together on issues such as fossil fuel divestment, and this contributes to the success of the plans managed by DCRB.

Despite the success of the plans, the Board trustees do face some challenges. In September 2021, the Board hired Gianpiero “JP” Balestrieri as the new Executive Director of DCRB. This follows over a year of acting Executive Directors. In addition, the Board has had numerous senior-level vacancies in several positions, causing uncertainty. The Board has also had negative audit findings that must be addressed. The Committee is comforted by the fact that Mr. Weers has been a steady hand on the Board and actively involved with addressing these issues, including working closely with the Council on legislative initiatives to recruit the new Executive Director.

Given Mr. Weers’s knowledge of the finances and investment will be valuable to DCRB continuing to maintain fully funded plans for the District’s police officers, firefighters, and teachers. Thus, the Committee recommends the reappointment of Mr. Weers to the DCRB.

### III. POSITION OF THE EXECUTIVE

### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on PR 24-358 on October 20, 2021. The testimony summarized below is from that roundtable. A copy of the testimony pertaining to Mr. Weers is attached to this report. Also attached are Mr. Weers's answers to questions submitted by the Committee.

*Adam Weers, Nominee*, testified about his background and willingness to serve on the DCRB as well as his experiences that will contribute positively to the Board.

*Neil Albert, President and CEO, Downtown BID*, provided written testimony in support of the nominee (attached).

The Committee received no testimony or comments in opposition of the appointment.

### VI. IMPACT ON EXISTING LAW

The adoption of PR 24-358 would have no impact on existing law. PR 24-358 fulfills the Council's statutory responsibility to appoint three members to the District of Columbia Retirement Board.<sup>9</sup>

### VII. FISCAL IMPACT

The approval of PR 24-358 will have no fiscal impact. Members of the Board are compensated at an hourly rate that is equivalent to the annual rate of pay in effect for the highest step of grade DS-15 for each hour that the member is engaged in the actual performance of duties.<sup>10</sup> However, this compensation is capped at \$15,000 annually.<sup>11</sup> Funding for Board members' compensation has been provided in the Fiscal Year 2022 budget and financial plan, and comes out of the earnings of the pension funds.

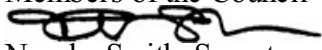



Good afternoon Chairman Mendelson and members of the Committee. My name is Adam Weers, and I am grateful to be with you today to share my thoughts on my nomination to the DC Retirement Board and to answer any questions that you might have for me.

I have been a resident of the District of Columbia for more than 15 years and in that time, have grown to love the District and consider it my personal and professional home. While everyone's definition of home may be a bit different, to my mind, a part of earning the right to call a place your home is being civically engaged in the life of the city. One way to accomplish this engagement, is by actively serving the people, and communities, and organizations who make up the fabric of the city in question. This kind of approach to engagement and community service is something that was instilled in me by my mother, many years ago, and I am proud that a large part of my time in the District has been living out this approach.

It is through this lens that I approach the opportunity to serve the DCRB, and it is this perspective that causes me to be more excited about this role than any other board I have previously served on.
