 - Sec. 3. The Council of the District of Columbia determines that the circumstances enumerated in Section 2 constitute emergency circumstances making it necessary that the Omnibus Progressive National Baptist Convention Redevelopment Emergency Act of 2021 be adopted after a single reading.
