### I. BACKGROUND AND NEED

On October 14, 2021, PR 24-413, the "District of Columbia Uniform Law Commission Heidi Tseu Reappointment Resolution of 2021" was introduced by Chairman Mendelson. The purpose of PR 24-413 is to reappoint Ms. Heidi Tseu as a member of the District of Columbia Uniform Law Commission for a term to end July 1, 2024.

Ms. Tseu is a Ward 3 resident. She received her Bachelor of Arts from the Pennsylvania State University and her Juris Doctorate from the American University, Washington College of Law. Currently she serves as Director of Local Government Affairs for Georgetown University. As Director of Local Government Affairs, she manages Georgetown University's engagement with the District government's legislative branch and executive agencies. Prior to her work at Georgetown University, Ms. Tseu served as Senior Counsel and as Committee Director for the Judiciary and Public Safety Committee at the Council of the District of Columbia. While working at the Council Ms. Tseu gained extensive experience in legislative drafting and in developing and

reviewing District government policies and practices. Further, Ms. Tseu serves on the Board of the American Civil Liberties Union of the District of Columbia. She also serves as a Community Advisory Council Member for the Georgetown University Center for Excellence in Development Disabilities, as a staff fellow for the Georgetown University Center for Social Justice Research, Teaching & Service, and as a staff mentor for the Georgetown University Women's Alliance.

In 2010, the Council adopted the District of Columbia Uniform Law Commission Act which provides the statutory basis for the appointment and duties of the District's commissioners to the Uniform Law Commission (ULC). Members of the Commission serve as official commissioners from the District to the ULC. In addition, commissioners are required to advise the Mayor and Council on proposals for uniform state laws and the effect that those proposals would have on District laws.

The ULC, first established in 1892, provides states with a venue to address the problems resulting from the inconsistences in the law of different states that impede commerce and other interstate activities. The main purpose of the ULC is to study and review the law of the states to determine which areas of law should be uniform. The ULC can only propose laws and it is up to a state legislature to approve the proposed law. The District first sent representatives to the ULC in 1905, and since that date numerous uniform laws have been adopted by the District. The legal subject areas covered include family law, commercial law, trusts and estates, civil, criminal, administrative and environmental law. Uniform laws are different than model laws in that the ULC recommends their adoption, with minimal changes, by as many states as possible. The goal is to promote uniformity in the law among the states. The District's delegation to the Commission consists of seven commissioners, five of whom are appointed, three by the Mayor, one by the Council, and one by the Chief Judge of the Superior Court of the District of Columbia. The General Counsel to the Council, or his or her designee, and a resident of the District who is elected as a life member of the ULC also serve as commissioners. The commissioners must be residents of the District and must be a member in good standing of the District of Columbia Bar.

During the roundtable, Ms. Tseu highlighted her experience working on uniform laws and her work the Commission to date. She testified that, since her appointment, she has participated in all three annual meetings and begun serving on the Study Committee on Mitigation of Public Health Emergency Business Disruptions, as well as serving as Vice Chair of the ULC's new

drafting committee on Public Health Emergency Authorities. Ms. Tseu added that she maintains a deep appreciation for uniform laws, which bring clarity and stability to the law.

Ms. Tseu plans to continue to collaborate with the other commissioners to promote Council adoption of uniform laws. She also hopes to continue to be able to deepen her engagement with commissioners in the Washington D.C. region to collaborate on issues that impact the District, Maryland, and Virginia. In her short tenure, Finally, Ms. Tseu wants to continue her service on the Commission because it will allow her to use her experience and skills in public service to the District.

Based on her impressive credentials, the Committee recommends the appointment of Ms. Tseu to serve on the Commission. She has an in-depth knowledge of legislative issues, including uniform laws, that are being considered by the Council. Moreover, her government experience will continue to be an asset to the Commission as it works with the Council to get bills proposed by the Commission adopted into law. The Committee recommends adoption of PR 24-413.

### V. SUMMARY OF TESTIMONY

*Heidi Tseu, Appointee*, testified and answered questions from Chairman Mendelson regarding her background and experience as it pertains to the District of Columbia Uniform Law Commission and her interest in continuing her service on the Commission.

The Committee also received written testimony from James McKay, current Chair of the D.C. Uniform Law Commission, in support of the reappointment (attached). The Committee received no testimony or comments in opposition to Ms. Tseu's reappointment.

### VI. IMPACT ON EXISTING LAW

Commissioners who serve on the District of Columbia Uniform Law Commission are appointed pursuant to section 3 of the District of Columbia Uniform Law Commission Act of 2010, effective March 12, 2011 (D.C. Law 18-313; D.C. Official Code§ 3-1432).
