43	(a) Section 16-1501 is amended as follows: The existing text is designated as

45	(1) The existing text is designated as subsection (a).
46	(<u>2</u>b) New subsections (b), (c), (d) and (e) are added to read as follows:
47	"(b) The person aggrieved shall not file a complaint seeking restitution of possession
48	pursuant to this section for nonpayment of rent in an amount less than \$600. Nothing in this
49	subsection shall prevent the person aggrieved from filing a complaint to recover the amount
50	owed.
51	"(c)(1) The person aggrieved shall not file a complaint seeking restitution of possession
52	pursuant to this section without a valid rental registration or claim of exemption pursuant to
53	section 205 of the Rental Housing Act, effective July 17, 1985 (D.C. Law 6-10; D.C. Official
54	Code § 42-3502.05), and a current license for rental housing issued pursuant to D.C. Official
55	Code § 47- 2828(c)(1), as certified at the time of filing and documented at the initial hearing.
56	"(2) The Court may waive the requirements for a current license for rental
57	housing in this subsection if the person aggrieved can demonstrate that they were unable to
58	obtain or renew a current rental housing license due to extenuating circumstances, including

59	medical emergencies, agency delays, and circumstances in which a tenant or occupant
60	denies permission for a required pre-license inspection or required repairs.
61	"(3) The requirements of this subsection shall not apply to complaints involving
62	subtenants.
63	"(d) At the initial hearing for any complaint for possession, if the complaint does not
64	allege sufficient facts or the person aggrieved has not produced sufficient documentation to meet
65	all requirements under District law, the Court shall dismiss the complaint.
66	"(e) Subsections (b) and (c) of this section shall not apply to complaints involving
67	commercial tenants.".

70	"(a) The summons provided for by section 16-1501 shall be served 30 days, exclusive
71	of Sundays and legal holidays, before the day fixed for the initial hearing of the action. If
72	the defendant has left the District of Columbia, or cannot be found, the summons may be
73	served by delivering a copy thereof to the tenant, or by leaving a copy with some person
74	above the age of sixteen years residing on or in possession of the premises, or residing
75	thereon, by posting a copy of the summons on the premises where it may be conveniently
76	read. If the summons is posted on the premises, a copy of the summons shall be mailed first
77	class U.S. mail, postage prepaid, to the premises sought to be recovered, in the name of the

85	(a) Section 501 (D.C. Official Code § 42-3505.01) is amended as follows:
86	(1) Subsection (a) is amended to read as follows:
87	"(a)(1) Except as provided in this section, no tenant shall be evicted from a rental unit,
88	notwithstanding the expiration of the tenant's lease or rental agreement, so long as the tenant
89	continues to pay the rent to which the housing provider is entitled for the rental unit; provided,
90	that the nonpayment of a late fee shall not be the basis for an eviction. No tenant shall be evicted
91	from a rental unit for any reason unless the tenant has been served with a written notice which
92	meets the requirements of this section. Notices for all reasons other than for nonpayment of rent
93	shall be served upon both the tenant and the Rent Administrator.
94	"(2) If a notice is served by posting a copy on the premises, a photograph of the
95	posted notice must be submitted to the court. The photograph must have a readable timestamp
96	that indicates the date and time of when the summons was posted.
97	"(3) If the landlord knows the tenant speaks a primary language other than
98	English or Spanish that is covered under the Language Access Act of 2004, effective June 19,
99	2004 (D.C. Law 15-167; D.C. Official Code § 2-1933), the landlord must provide the notice in
100	that language.

101	"(4) The Court shall dismiss a claim brought by a housing provider to recover
102	possession of a rental unit where the housing provider:
103	"(A) Did not provide notice as required by this section;
104	"(B) Filed the claim to recover possession of the rental before the number
105	of days of notice required by this section has elapsed;
106	"(C) In cases where a notice to quit or a summons and complaint are
107	served by posting on the leased premise, failed to provide the Superior Court with photographic
108	evidence of the posted service with a readable timestamp that indicates the date and time of when
109	the notice or summons were posted, or".
110	"(D) In cases where the landlord knows the tenant speaks a primary
111	language other than English or Spanish that is covered under § 2-1933, failed to provide the
112	notice required by this section in that language.".
113	(2) A new subsection (a-1) is added to read as follows:

115	provider's intent to file a claim against a tenant to recover possession of a rental unit for the non-

119	"The total amount of rent owed is [list specific amount due]. A ledger showing
120	the dates of rent charges and payments for the period of delinquency is attached. You have the

122	"[Name of housing provider] has the right to file a case in court seeking your
123	eviction if you do not pay the balance of unpaid rent in full within 30 days of this notice.
124	"You have the right to defend yourself in court. Only a court can order your
125	eviction. For further help or to seek free legal services, contact the Office of the Tenant Advocate
126	at 202-719-6560 or the Landlord Tenant Legal Assistance Network at 202-780-2575."
127	(3) Subsection (b) is amended to read as follows:
128	"(b) A housing provider may recover possession of a rental unit when the tenant is
129	violating an obligation of tenancy, other than nonpayment of rent, and fails to correct the
130	violation within 30 days after receiving notice from the housing provider."
131	(4) A new subsection (r) is added to read as follows:
132	"(r) No tenant shall be evicted from a rental unit unless the housing provider provides
133	documentation to the court at the time of filing a writ of restitution demonstrating that the
134	housing provider has a current business license for rental housing issued pursuant to D.C.
135	Official Code § 47-2828(c)(1), unless the court waived the license requirement. The
136	requirements of this subsection shall not apply to complaints involving subtenants.".
137	(b) New sections 509 and 510 are added to read as follows:
138	"(a) The Superior Court shall seal all court records relating to an eviction proceeding:
139	"(1) If the eviction proceeding does not result in a judgment for possession in
140	favor of the housing provider, 30 days after the final resolution of the eviction proceeding; or
141	"(2) If the eviction proceeding results in a judgement for possession in favor of
142	the housing provider, 3 years after the final resolution of the eviction proceeding.

162	501(c-1) or federal law pertaining to domestic violence, dating violence, sexual assault, or
163	stalking; or

164	"(vi) The parties entered into a settlement agreement that did not
165	result in the housing provider recovering possession of the unit; or
166	"(B) The Superior Court determines that there are other grounds justifying
167	such relief.
168	"(2) An order dismissing, granting, or denying a motion filed under this
169	subsection shall be a final order for purposes of appeal.
170	"(3)(A) A copy of an order issued under this subsection shall be provided to the
171	tenant or his or her counsel.
172	"(B) A tenant may obtain a copy of an order issued under this subsection
173	at any time from the Clerk of the Superior Court, upon proper identification, without a showing
174	of need.
175	"(d) Records sealed under this section shall be opened:
176	"(1) Upon written request of the tenant; or
177	"(2) On order of the Superior Court upon a showing of compelling need.".

243	voluntary, that may be charged to a tenant or prospective tenant and whether the fee or deposit is
244	refundable;

247	"(4) Any additional criteria that may result in denial of the application;

248	"(5) If a credit or consumer report is used, the name and contact information of

250	obtain a free copy of the credit or consumer report in the event of a denial or other adverse

253	specified period, by bedroom size and monthly rent, or if such information is not available, the
254	number of rental units that became available for rent each calendar month in the housing
255	provider's prior fiscal year;

257	housing provider will respond with an approval or denial decision;
258	"(8) The prospective tenant's right to dispute any information relied upon by the

260	upon the housing provider's use of prohibited criteria, and the right to receive a response from
261	the housing provider regarding any information disputed by the prospective tenant;
262	"(9) The prospective tenant's right to a refund for any unused application fee; and
263	"(10) The prospective tenant's right to file a complaint with the Office of Human
264	Rights or pursue civil action via Superior Court if he or she believes the housing provider has

294	"(e)(1) A housing provider shall not base an adverse action solely on a prospective
295	tenant's credit score or lack thereof, although information within a credit or consumer report
296	directly relevant to fitness as a tenant can be relied upon by a housing provider.

298	receives a credit or consumer report containing information that may not be used as the
