(a) The Mayor and the Council previously approved a balanced budget for Fiscal 20 Year 2022. 21 (b) Since the time the Fiscal Year 2022 that budget and financial plan was approved, the 22 federal government provided additional federal payments for COVID relief specifically for 23 emergency rental assistance; certain Fiscal Year 2021 federal payments for COVID relief 24 allocations went unspent; the Chief Financial Officer has issued a revised revenue estimate certifying additional local fund revenues for Fiscal Year 2022; and . In addition, certain budget 25 pressures have arisen-since the beginning of Fiscal Year 2022. 26 27 (c) Pursuant to section 446 of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 774; D.C. Official Code § 1-204.46), the Council must appropriate 28 29 all funds, including federal payments, prior to obligation or expenditure.

30	(c) Appropriated revenues and budget authority for Fiscal Year 2022 must be adjusted
31	immediately to ensure that a balanced budget is maintained while continuing to meet the needs of
32	District residents.
33	(d) In conjunction with the proposed Fiscal Year 2023 Budget and Financial Plan, the
34	Mayor identified additional amounts to increase available resources.
35	(e) Adjustments to the Fiscal Year 2022 budget are necessary to appropriate these
36	additional resources and recognize these additional resources, address existing budget pressures,
37	align budgets with revenue, ensure timely repayment of the Contingency Cash Reserve Fund,
38	and balance the budget.
39	Sec. 3. The Council of the District of Columbia determines that the circumstances
40	enumerated in section 2 constitute emergency circumstances making it necessary that the Fiscal
41	Year 2022 Revised Local Budget Adjustment Emergency Act of 2022 be adopted after a single
42	reading.
43	Sec. 4. This resolution shall take effect immediately.
