The stated purpose of **PR 24-648** and **PR 24-649** is to confirm the appointments of Lauren Orzchowski and Marcus Turner to the DC State Athletics Commission. The stated purpose of **PR 24-650** is to confirm the re-appointment of Rosalyn Overstreet Gonzales to the DC State Athletics Commission. The DC State Athletics Commission oversees the state interscholastic athletics programs and competitions in the District through the oversight of the DC State Athletics Association. The purpose of this hearing is to receive testimony from government and public witnesses as to the fitness of this nominee for appointments and reappointment to the Commission.
