#### I. BACKGROUND AND NEED

On May 3, 2021, Bill 24-233, the "Rebecca Coder Park Designation Act of 2021," was introduced by Councilmembers Pinto, to officially designate the park subsection of Francis Field, bound on the east by 25th Street N.W., on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building located at 2501 M Street N.W. as "Rebecca Coder Park." An official naming of a public space typically enables installation of signage or other identifying features.

Commissioner Rebecca Coder served as a community activist until her passing after a long battle with cancer. Commissioner Coder was a founder and first president of the Friends of Francis Field. She was also a Commissioner representing Advisory Neighborhood Commission (ANC) 2A for ten years. As both a member and eventual Chair of ANC 2A, she helped to fostered and era

of intelligence and civility in local government through her work on the ANC.

Commissioner Coder led successful efforts to provide passive recreation space in the West End neighborhood, specifically the portion of Francis Field that is now a small, pleasant park area, where neighbors can walk dogs, sit on benches, and enjoy this small but welcoming outdoor space. The space proposed to be named in her honor was created in 2009 under her leadership and work through the local Advisory Neighborhood Commission.

#### Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, and the naming of public spaces. Specifically, the Act authorizes the Council to designate or change the name of any public space in the District of Columbia.<sup>2</sup> Public spaces include "any public street, alley, circle, bridge, building, park, other public place or property owned by or under the administrative control or jurisdiction of the District of Columbia."<sup>3</sup>

The Act establishes a notice requirement for the official designation of public spaces: at least 30 days prior to the scheduled public hearing, the initiator of the proposed designation shall submit a copy of the legislation for review and comment to each Advisory Neighborhood Commission ("ANC") in which the public space is located. Regarding Bill 24-233, ANC 2A was notified of the hearing on the proposed name on October 4, 2021.

The Act also promulgates requirements that the Mayor must meet prior to consideration of a public space designation by the Council. First, the Mayor shall provide the Council with comments on the proposed designation submitted by any District agency with jurisdiction over the public space to be designated.<sup>4</sup> DPR, which will have jurisdiction over the park when completed, attended the November 3, 2021 hearing on Bill 24-233 and submitted comments as part of its testimony, thus meeting this requirement. Second, prior to consideration of a designation by the Council, the Mayor shall provide to the Council a surveyor's plat showing the public space to be designated, including any squares adjacent and abutting squares to the designation.<sup>5</sup> The Office of the Surveyor provided the Council with a plat of the designation prior to mark up by the Committee of the Whole. That updated plat is attached to this report.

After the legislation becomes law and all conditions required by the Council and the Act have been satisfied, the Mayor will install signage denoting the public space name.<sup>6</sup> The signage shall conform to the policies of the agency with jurisdiction over the public space, in this case DPR.<sup>7</sup> In addition, the committee print authorizes the Mayor to accept a bronze plaque inset in

stone to be installed at a location in Rebecca Coder Park to be determined by the Mayor in consultation with the Friends of Francis Field. Finally, the Surveyor of the District of Columbia shall record a copy of the act and the Surveyor's plat in the Office of the Surveyor.<sup>8</sup>

The Committee Print makes clarifying changes with regard to the installation of a plaque inset in stone in the park. The Friends of Francis Field have procured the memorial stone and plaque and will gift it to the District. The memorial will be place in the park at a location to be determined by the Mayor after consulting with the Friends of Francis Field.

Officially designating the park subsection of Francis Field, bound on the east by 25th Street N.W., on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building located at 2501 M Street N.W. as "Rebecca Coder Park" will honor the legacy of Commissioner Rebecca Coder as a champion for renovation of this public green space for use by residents. Thus, the Committee of the Whole recommends the approval of Bill 24-233, the "Rebecca Coder Park Designation Act of 2022."

#### II. LEGISLATIVE CHRONOLOGY

May 17, 2021	The Committee of the Whole marks up Bill 24-233.

#### III. POSITION OF THE EXECUTIVE

Brent Sisco, Capital Projects Planning & Design Officer, Department of Parks and Recreation, testified that the Executive supports the legislation and applauded the community engagement in selecting the name to put forward to the Council. Her testimony is attached as well as summarized below.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

On November 6, 2018, ANC 2A approved a resolution proposing to install a plaque honoring former Commissioner Rebecca Coder at Francis Field. A copy of the resolution is attached to the testimony of Gary Griffith, President of the Friends of Francis Field (attached).

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills including Bill 24-233 on Thursday, November 3, 2021. The testimony summarized below pertains to Bill 24-233. Copies of written testimony are attached to this report.

*Florence Harmon, Commissioner, ANC 2A06*, testified in support of the designation and spoke to Commissioner Coder's work to secure neighborhood amenities.

*Gary Griffith, President, Friends of Francis Field*, testified in support of the designation and recounted Commissioner Coder's good nature and work on the ANC.

Jacqueline Lemire, Co-Founder, Foggy Bottom West End Village, testified in support of the designation and spoke of her commitment to serving and supporting the neighborhood.

*Jeri Epstein, Chair, ANC 2A*, testified in support of the designation and lauded the effort to rename public spaces after important community members.

*John George, President, Foggy Bottom Association*, testified in support of the designation and described her volunteerism and efforts to raise the quality of life for her neighbors.

*Jill Eicher, Member, Friends of Francis Field*, testified in support of the designation and recounted Commissioner Coder's contributions to the daily lives of West End residents.

**Peter Sacco, Executive Director, ANC 2A**, testified in support of the designation and described his work as a Commissioner alongside Commissioner Coder including her overall commitment to the West End community.

Susan Haight, President, West End Library Friends, testified in support of the designation and her work with Commissioner on several projects including Francis Field, the West End Library, the fire station, and others.

Brent Sisco, Capital Projects Planning & Design Officer, Department of Parks and Recreation, testified that the Executive supports the designation.

The Committee received no testimony or comments in opposition to Bill 24-233.

#### I. RACIAL EQUITY IMPACT

According to the attached Racial Equity Impact Analysis, Bill 24-233 will have a negligible impact on the lives of Black residents, Indigenous residents, and other residents of color.

#### II. IMPACT ON EXISTING LAW

Bill 24-233 has no impact on existing law. D.C. Official Code § 9-204.01 authorizes the Council to designate (i.e. name) any public space, including facilities. Further, the Act generally provides that no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. Commissioner Coder passed away on May 1, 2018, at the age of 49.

#### III. FISCAL IMPACT

Funds are sufficient in the fiscal year 2022 budget and proposed fiscal year 2023 through fiscal year 2026 budget and financial plan to implement the provisions of the proposed legislation. DPR testified that fabrication of signage for the new park can be absorbed, as noted in the Fiscal Impact Statement (attached).

#### VIII. SECTION-BY-SECTION ANALYSIS

Section 1	States the short title of Bill 24-233.
Section 2	Officially designates the park subsection of Francis Field, bound on the east by 25th Street N.W., on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building located at 2501 M Street N.W. as Rebecca Coder Park.
Section 3	Adopts the Fiscal Impact Statement.
Section 4	Establishes the effective date by stating the standard 30-day congressional review language.

# Florence Harmon Testimony Former Chair and Former ANC2A Commissioner 2007 to 2018

Good morning, Chairman Mendelson, and Members of the Council: I am Florence Harmon. I was an Advisory Neighborhood Commissioner (ANC) 2A from 2007 to 2018.

I am here to testify in support of the "Rebecca Coder Park Designation Act of 2021. Several of you knew Rebecca and knew not only what an outstanding person Rebecca was but also what an effective, talented, and dedicated ANC 2A Commissioner she was. Rebecca secured outstanding neighborhood benefits while undergoing painful medical treatments for serious health conditions that finally took her from us far too soon at the young age of forty-nine. She never let her constituents down; she never complained about her health. For 10 years, I worked closely with Rebecca and never saw her waiver in her dedication to her constituents, always answering emails from her hospital bed and securing relief from DC Officials for various neighborhood issues no matter how sick she was.

Over ten years as the commissioner for ANC 2A02, Rebecca put in thousands of volunteer hours as an unpaid public servant to benefit our neighborhood. The ANC 2A commissioners and constituents are asking you to designate a small park adjacent to Francis Field, which she worked so hard to improve for neighborhood school children and her constituents, as a fitting memorial to Rebecca. I am here to elicit your support for the designation of this small park in the memory of Rebecca.

We could be here for some time if I elaborated on all of Rebecca's

accomplishments for the West End and Foggy Bottom neighborhood, but I think her most significant accomplishment was her leadership and professional in her interactions with City officials and constituents.

Rebecca, as an experienced businesswoman and savvy volunteer, restored the trust of neighbors, commissioners, city officials in the ANC 2Aand each other. She leveraged professionals but Rebeca was also very, very smart. She quickly became proficient in zoning processes, liquor license protests, campus plan details, and a variety of other municipal functions. She deftly maneuvered City processes. Just a few of these accomplishments are:

- Removing harsh lights on Francis Field so that neighbors could sleep and restoring the field through securing unpaid PUD amenities and a navigating byzantine regulatory process.
- Establishing a neighborhood dog park through years of effective advocacy.
- Overturning efforts of a developer to develop the historic Stevens School as a condominium and supporting ANC efforts save the Stevens School (the first school in DC for freed slaves) as a learning institution for young children.
- Securing the designation of the unnamed triangular park at the intersection of New Hampshire Avenue with M. St. and 21st St. as "Duke Ellington Park" in honor of the composer and musician who was born nearby on Ward Place in 1899.
- Tirelessly advocating for the redevelopment of the block where the old ramshackle and sub-standard public library and fire station stood so that the community received affordable housing, a state-of-the-art new library and new fire station.
- Attracting outstanding dining venues to the Foggy Bottom/West End neighborhood while protecting the peace

- of residents by imposing reasonable neighborhood operating hours.
- Going after bad actor nightclub and restaurant operators who disregarded and endangered neighbors.
- Outsmarting big name attorneys from DCs most prestigious law firms in BZA and Zoning hearings when they attempted "sharp" legal tactics to infringe on the rights of her constituents to sleep by erecting huge, highways type signage that glared into constituents' bedrooms at night.
- Shutting down illegal or even legal construction that kept residents up all night.
- Getting sidewalks and potholes fixed and fixing other constituent problems by navigating a City bureaucracy.
- Restoring civil town-gown relations.
- Restoring ANC credibility, civility, and trust in its relations with City officials, neighbors, MPD, and other parties who appeared before the ANC.
- Protecting the "West End and Foggy Bottom" neighborhood by constantly pointing out to developers who misrepresented their businesses as being in Georgetown that we are a unique and exciting neighborhood, and they should be proud to advertise that they were in the West End.
- Ultimately being a significant force in creating a distinct West End neighborhood that is truly unique and vibrant with numerous community amenities and outstanding venues.

I am not aware of another ANC commissioner who worked so hard for her constituents and was so effective on their behalf because of her professionalism, advocacy, and keen intellect.

Rebecca and I didn't always agree on every issue, but we agreed on most and she was a formidable alley against bad actor night club owners and unscrupulous developers. I dare say we won numerous zoning, BZA, ABRA and other legal and regulatory proceedings for the benefit of our constituents in the West End. Rebecca was just so smart and could see angles that I could not see that led to successes.

And when we didn't agree, we may have not been happy with each other's position. But we didn't sit there and insult each other at ANC meetings. Instead, we'd talk, usually over a glass of wine, enjoy each other's company, and end up giggling about some strange display of behavior we had witnessed together. And then she'd say, "I have to go home to the "hubby," whom she dearly loved.

I really miss Rebecca.

I therefore respectfully urge this Committee to approve the "Rebecca Coder Park Designation Act of 2021" as a fitting memorial to one of the City's most outstanding public servants and a DC native.

Good morning, Chairperson Mendelson and members of the Committee. My name is Gary Griffith, and I am the President of a neighborhood organization in the West End called the Friends of Francis Field.

I am in favor of the bill because it recognizes the public-spirited work of a person who improved our neighborhood with her volunteer service and leadership. Through a zoning case in 2007 she led the renovation of an athletic field surrounded by a chain-link fence into more of a community asset, by providing park space for passive recreation as well as sports activity.

This led to ten years of additional service on our Advisory Neighborhood Commission, during the critical years when a new library and a new fire station were built, and two school buildings were set to close. She also was among the founding members of the Foggy Bottom West End Village, which helps neighbors to age in place. The hundreds of hours that she devoted to these projects were more precious than most of us knew, for during this same ten years, she was battling ovarian cancer, which took her life when she was 49 years old.

It is her spirit that we would honor in this naming, because she also enriched us with her friendship and good nature and joy of living. As others have written, and will tell you, she was fun to be around, and she inspired volunteerism in others. I testified 12 years ago to this committee for a bill that she initiated in the ANC to name a small triangular park in the neighborhood for Duke Ellington, the musical great who was born nearby ... and it bears that name today. Rebecca did that kind of thing, and it enriched our lives by doing so.

This bill, involving the small park area she created, will recognize her work and keep alive the spirit of volunteerism in local government that she embodied.

My additional written testimony is included in the appendices below, which includes statements and documentation from neighborhood organizations, Advisory Neighborhood Commission 2A, the D.C. Department of Parks and Recreation, and the office of Councilmember Brooke Pinto.

## Remembering Rebecca Coder (1969-2018)

#### Posted May 25, 2018

Rebecca Coder died on May 1, 2018, at the age of 49. During her final decade of life—a time of great change in the West End neighborhood—she was an energetic community leader and public servant.

To many of us who knew her, she was also a beloved friend and neighbor.


A resident of the District of Columbia from childhood, she grew up in the Chevy Chase neighborhood of the District, and attended Woodrow Wilson High School, from which she was graduated in 1987.

She received a Bachelor of Science degree from the University of Wisconsin-Madison in 1990, and returned to the District to begin a career in banking, initially at the American Security Bank. She joined the National Cooperative Bank in 1996, and became a senior vice president six years later.

In 2002 she married Christopher Haspel; the couple purchased a condominium in the West End the same year. In 2003, she began writing about art exhibits and nearby galleries for the *West End Guide*, a local publication.

Her first big neighborhood project, beginning in 2007, was the improvement of Francis Field, a neglected public recreation space. As a founder and the first president of the non-profit Friends of Francis Field, she shepherded a landscape architecture plan through the zoning and approval process.

That began the transformation of a neighborhood nuisance into a community asset. She remained active in that group, and played a major role in the planting of 43 trees in May 2017. (See photo below).



Her interest in the neighborhood and improving the field led to a suggestion by her neighbors that she run for election to the non-paid, non-partisan Advisory Neighborhood Commission (ANC) so that the West End might be better represented. She did so in 2008, defeating an incumbent, and winning 82 per cent of the votes cast. She was re-elected in 2010, 2012, 2014, and 2016, and was serving in her tenth year.

The West End Library was in her single-member district. Its redevelopment became one of the projects that she steadfastly supported from the time of its initial suggestion in 2009.

Her ANC colleagues elected her chairperson in January 2010. During that crucial time of regulatory hearings for the library redevelopment, she testified in several proceedings, including the District Council.

As chair of the ANC, she introduced the resolution in favor of the library plan proposed by a local development team. That passed unanimously and became the crucial grass-roots foundation for community support of the West End Library project—support that stood up during a long and complicated process of regulation and legal challenges by interest groups located outside the neighborhood and outside the District.



The redevelopment of the West End fire station was another of the successful projects she championed.

In 2009, she was also instrumental in having a small park near the West End birthplace of jazz legend Duke Ellington named officially—by the District of Columbia and the U.S. Congress—as Duke Ellington Park.

In 2013, at the age of 44, she became a founding board member of another non-profit, local organization: the Foggy Bottom/West End Village, which continues to assist its members to age in place.

Rebecca Coder was a leader who seemed to personify the neighborhood that the West End was becoming in the last decade: smart, young, interesting, and upbeat.

Her participation in the May 2017 tree planting—just one year ago—was typical of her easy, elegant manner. She picked up a shovel, dug in, and got the job done ... while she let others give the speeches.

In addition to the large and visible projects she supported and advocated, she spent countless hours in her ANC role, attending mundane hearings before District agencies that were little noticed by the general public but meant the world to some unsung constituent or another.

When some of us encouraged her to run for a more visible public office, she'd tilt her head and squint her eyes a little, as if she were really thinking about it. But we realized early on that her heart beat to a more beautiful rhythm. She was not a politician, but something much more rare—she was a volunteer—and a good neighbor ... and a beautiful friend.

Despite her 13-year battle with ovarian cancer, Rebecca always seemed to find time to help others.

One of her ANC colleagues remembered: "Rebecca was most poised person I've known ... she never got flustered and she was such a generous, fun, soul."

Her intelligence, her graceful style, and her generosity with her time and resources, were noted by many. Another colleague remarked: "She leaves a living legacy anywhere you turn in the West End."

Mayor Muriel Bowser described her as "a generous, caring and thoughtful woman who was always willing to help out in the community in any way possible."

Rebecca Kilcummings Coder was born on January 4, 1969, in Edmonton, Alberta, Canada. She was adopted and brought to the United States that same year. When she was four years old, her family settled in Washington, DC. She is survived by her husband Christopher Haspel, her father David Coder, and her brother Joshua Coder. Her mother, Mary Katherine McDermott, died in 2016.

A funeral mass for Rebecca was held at St. Stephen Martyr Church in the West End on May 10, with hundreds of her friends and neighbors in attendance. Memorials are in the planning stage at the West End Library and on Francis Field.

We are writing to request that the name of Rebecca Coder be considered as the second honoree for the Wall of Honor at the West End Library.

Rebecca Coder died on May 1, 2018, at the age of 49. During her final decade of life—a time of great change in the West End neighborhood—she was an energetic community leader and public servant.

A resident of the District of Columbia from childhood, she grew up in the Chevy Chase neighborhood of the District, and attended Woodrow Wilson High School, from which she was graduated in 1987.

#### RE: Proposal to Install a Plaque Honoring Former Commissioner Rebecca Coder at Francis Field

Dear Councilmember Evans,

At its regular meeting on September 20, 2018, Advisory Neighborhood Commission 2A ("ANC 2A" or "Commission") considered the above-referenced matter. With seven of seven commissioners present, a quorum at a duly-noticed public meeting, the Commission voted unanimously (7-0-0), after a motion made by Commissioner Harmon and seconded by Commissioner Smith, to adopt the following resolution:

ANC 2A supports the request of the Friends of Francis Field, of which Rebecca Coder was the first president and subsequently an ANC 2A Commissioner for ten years, to memorialize her successful efforts to provide passive recreation space in the West End neighborhood, specifically the portion of Francis Field that is now a pleasant park, where neighbors can walk dogs, sit on benches, and enjoy this small but welcoming outdoor space, created in 2009 under her leadership.

There is no intention to rename Francis Field, which has several sub-sections, including the large athletic field, Francis Pool, and, since 2015, Francis Dog Park. Rather, the request is for an act by the DC Council to designate a small and distinct portion of Francis Field, lying entirely outside of the athletic field, as follows:

"To designate the park area of Francis Field adjacent to the west side of 25<sup>th</sup> Street NW, in Ward 2, as Coder Park."

A landscape plan of this area, with an accompanying photograph of the area, is attached to this resolution.

ANC 2A also supports the placement of a small bronze plaque, 10 inches by 4 inches, in the circular sidewalk shown in the attached plan. The plaque would read:

No other signage is contemplated or requested. A proof of this plaque is also attached to this resolution. The plaque is consistent with current "DPR Donation Guidelines for Plaques and Trees," which state:

"The sign/plaque must be made of lasting materials (i.e. brass, stainless steel, powder-coated steel or stone). It should not exceed about 6" x 12" nor should be elevated more than 9" above the surrounding soil. If it is to be mounted to a wall or masonry surface it should be bolted or set in mortar."

Those Department of Parks and Recreation (DPR) guidelines also state that language such as "in memory of" requires DC Council approval, which the Friends of Francis Field has informed ANC 2A that it has discussed with your office and feels confident that you will support.

The plaque and its installation will be funded entirely with private funds, at no cost to the District of Columbia.

ANC 2A thus respectfully requests that your office take action regarding this request.



#### PARK PARTNER COOPERATIVE AGREEMENT BY AND BETWEEN

## THE DISTRICT OF COLUMBIA DEPARTMENT OF PARKS AND RECREATION AND THE FRIENDS OF FRANCIS FIELD

Agreement Number: FO-2019-0001

This Park Partner Memorandum of Agreement(herein referred to as "the Agreement") is made by and between the District of Columbia, a Municipal Corporation, acting by and through the District of Columbia Department of Parks and Recreation ("DPR") and the Friends of Francis Field (the "Partner"), a District of Columbia 501(c)(3) not for profit corporation whose mission includes supporting Francis Field, located adjacent to 2435 N Street, NW (the "Park") by advocating, fundraising, maintaining and assisting DPR in the planning process for the Park. DPR and Partner may individually or collectively be referred to as the "Party" or the "Parties".

#### Recitals

WHEREAS, pursuant to D.C. Official Code § 10-301-304(a) and Title 19 of the District of Columbia Municipal Regulations ("DCMR"), § 720 and § 1105, DPR may form partnerships with neighborhood, community and civic groups to permit private persons and organizations to improve and beautify parks, playgrounds, and recreation centers under DPR's jurisdiction and to accomplish a stated goal or mission of DPR; and

WHEREAS, consistent with the aforementioned authority afforded DPR, DPR has instituted programs known as the "Adopt-a-Park Program" and the "Friends of Program" for the improvement, beautification, advocacy, fundraising, and certain maintenance of DPR managed real property, also known as public park sites; and

WHEREAS, DPR desires to enter in cooperative agreements with individuals, corporations, associations, community and/or neighborhood civic groups or organizations whereby such entities or persons agree to provide for or cause to be provided for the maintenance, renovation, and/or beautification of park sites and agree to cooperate with and assist DPR in the performance of the necessary administrative and regulatory functions essential to the implementation of such programs; and

WHEREAS, DPR is the District of Columbia agency charged with the management and operation of the Park; and

WHEREAS, the Park Partner desires to participate in the "Friends of Program," and perform certain fundraising, advocacy, improvement, maintenance, beautification, and/or coordination of such activities at the Park, pursuant to the responsibilities outlined and agreed upon in this Agreement; and

WHEREAS, the Park Partner is a District of Columbia 501(c)(3) not for profit corporation with the Federal Employer Identification Number 26-3553149, whose mission includes supplementing the work of DPR as it relates to the Park, and the Park Partner acknowledges it is in good standing with the District of Columbia and is authorized to execute and perform this Agreement; and

WHEREAS, it is understood and agreed between the parties to this Agreement that any and all construction, fundraising on Park property, maintenance, and coordination of the improvements at the Park, including but not limited to landscaping and/or installation of equipment of any sort located on the Park property, must be prior approved by DPR in writing notwithstanding any other provision contained herein; and

WHEREAS, it is understood and agreed that prior to the entry onto the Park for purposes of the Agreement, the Park Partner shall specifically obtain from DPR any and all necessary approvals and permits onto said property, as may be required by DPR before entering onto the Park property for the purpose of making physical improvements to the property, such as, but not limited to, moving earth, planting trees, or adding structures or additions to existing structures; and

WHEREAS, it is understood and agreed that DPR, insofar as it is legally permitted to do so, shall assist Park Partner in obtaining the required permits or licenses directly related to Park Partner's activities on said property; provided however the Park Partner shall bear any and all costs and expenses connected in any way with obtaining said permits and licenses; and

NOW THEREFORE, the Parties hereto agree as follows:

#### I. Scope of Agreement

- a. General. This Agreement shall apply to maintenance of and improvements to the Park and Park Partner's activities at the Park. The recitals above are incorporated herein and made a part of this Agreement.
- b. Partnership Plan. In accordance with 19 DCMR § 720 et seq., Park Partner shall submit to the Director of DPR, a plan for the maintenance, beautification, general improvements to the Park, and where applicable a Statement or Scope of Work, which upon written acceptance by DPR, will be considered an addendum to this Agreement and shall be hereto incorporated by reference as "Attachment A.2".

#### c. [RESERVED]

#### II. Term and Termination of the Agreement

This Agreement shall become effective as of the date of full execution and shall continue in force and effect until December 31, 2022 (the "Initial Term"), unless earlier terminated by DPR or the Park Partner as herein provided. Upon expiration of the Initial Term, the Agreement may be renewed for an additional term (the "Renewal Term") but only by

written agreement by the parties hereto. If Park Partner desires to extend the Initial Term, it should provide written electronic notice to DPR at least thirty (30) days, but not more than one hundred eighty (180) days prior to the expiration of said Initial Term. DPR or Park Partner may terminate this agreement for any reason by written electronic notice to the other Party.

- 2) Partnership Agreement Document
- 3) Standard Partnership Agreement Provisions Document
- 4) Agreement Attachments other than the Standard Partnership Agreement Provisions Document

#### Site Improvements

- In conjunction with DPR's Capital Projects Division, Friends of Francis Field will continue development of a revised master landscape plan for Francis Field, by continuing to contract a professional landscape architect.
  - Plan to be subject to approval of DPR, for submission by DPR to the U.S.
     Commission of Fine Arts.

  - o Plan to include the naming of this sub-section of Francis Field as "Rebecca Coder Park", and the placement of a sidewalk plaque, provided that enabling legislation is passed by the Council of the District of Columbia and signed by the Mayor of the District of Columbia.
- Continue the implementation of the 2017 agreement for the improvement of the playing field and other areas of Francis Field.
  - o Assess health of the 43 trees planted in May 2017, and replacement of any dead or dying trees in conjunction with the Casey Trees Foundation.
  - o Monitor the progress of the 2017 improvements and related maintenance needs.
  - Assess the balance of field use and the maintenance required to maintain a green, natural, and safe environment for athletic, recreational, and architectural purposes for which the field was acquired and set aside.
- Continue the study of irrigation issues and solutions begun in 2017.

#### Outreach:

- Continue to work closely with ANC 2A, including presenting updates at regularly held ANC meetings as requested.
- Continue to work closely with Francis Field stakeholders including residents in the condominium buildings adjacent to Francis Field, School Without Walls, and others.

Chairman Mendelson and Members of the Council:

Regarding "Bill 24-233, Rebecca Coder Park Designation Act of 2021," I would like to add to my testimony to clarify that there will be <u>no cost</u> to the District of Columbia for the bronze plaque and rock mentioned in the proposed legislation.

The Department of Parks and Recreation (DPR) estimated at \$4,000 as the cost in its executive testimony. Brent Sisco of that department wrote to me on November 4, 2021, about a more accurate estimate, and I replied that while the estimate was about right, there would be <u>no cost</u> to the District or its taxpayers, as this cost is well-covered by the existing \$20,000 donation agreement our organization, Friends of Francis Field, has made to the District of Columbia relating to our organization's partnership agreement with DPR for Francis Field landscaping improvements. This was accepted and was signed by DPR Director Delano Hunter on October 16, 2019.

A copy of that donation agreement is attached to this email message.

The related "Park Partnership" agreement between Friends of Francis Field and DPR was sent with my previous written testimony regarding this Bill 24-233 on 10/12/21, and is already in the Dropbox testimony as "Griffith Testimony.pdf. That agreement includes improvements to Francis Field, and contains Attachment A.2 of the partnership agreement, which states in part:

"Plan to include the naming of this subsection of Francis Field as 'Rebecca Coder Park,' and the placement of a sidewalk plaque, provided that enabling legislation is passed by the Council of the District of Columbia and signed by the Mayor of the District of Columbia."

In conference with Peter Norhden, the DPR architect assigned to the Francis Field improvement agreement, it was decided that it would be more efficient to place the plaque in a rock and add the rock to a patch of bare ground at sidewalk level, rather than to attempt to install the brass plaque in the existing sidewalk. Thus, the legislation as submitted by Councilmember Pinto mentions a rock and that placement of the plaque.

We hope this information will be helpful and welcome, and we request that this note be placed in the record for the above referenced bill.

My name is Jacqueline Lemire.

I am a co-founder of the Foggy Bottom West End Village which works to assist residents in Foggy Bottom West End who desire to remain independent in their homes.

In 2011 we were working to establish a development board whose members would be responsible for determining the viability of a Village in Foggy Bottom West End. One of the people we approached was Rebecca Coder who lived in the neighborhood. She had a full time job as a senior Vice President of National Cooperative Bank. She was an ANC Commissioner in our neighborhood which, in itself, could be counted as a full-time job. In addition, she somehow managed to address other needs in the community such as working to transform neglected Francis Field into a community asset.

Rebecca was only 42 at the time that we approached her – much younger than the neighborhood residents we were proposing to assist – but she immediately agreed to join the nascent development board. Her knowledge of financial matters was a major asset in our efforts to determine if we could financially support a Village. When Articles of Incorporation were signed in 2013, Rebecca was listed as a founding member. She then agreed to be the Treasurer of the Village, a position that she held for five years – until several months before her premature death at the age of 49.

Rebecca's commitment to community needs to be and deserves to be remembered. Designating the park subsection of Francis Field as Rebecca Coder Park would be a valuable step in doing so.

### <u>Testimony of Peter Sacco, Executive Director of ANC 2A, Regarding</u> the Rebecca Coder Park Designation Act of 2021

Committee of the Whole Hearing November 3rd, 2021

Good afternoon Chairman Mendelson and members of the Committee. Thank you for giving me the opportunity to testify in support of the "Rebecca Coder Park Designation Act of 2021." My name is Peter Sacco and I serve as the Executive Director of Advisory Neighborhood Commission 2A, which covers the Foggy Bottom and West End communities. I was first elected as a Commissioner on ANC 2A in November of 2012 and had the great opportunity to serve alongside Rebecca Coder on the ANC from 2013 until her passing in 2018. During that time I witnessed firsthand Rebecca's deep commitment to Foggy Bottom and the West End.

You have already heard today about Rebecca's deep involvement in some of the pillars of our community, including the Foggy Bottom West End Village and the Friends of Francis Field. What I wish to speak to is Rebecca's overall commitment to the West End community. When Rebecca was first elected to the ANC in 2008, an election she won through a write-in campaign, she served as the sole West End representative on the ANC. She then became instrumental in the growth and transformation of the neighborhood that we have seen in recent years, growth that allowed the West End to add a second ANC representative as part of the 2010 U.S. Census.

Rebecca worked heavily on the redevelopment of the West End Library site, the DC Public Library's first project to be funded through a public-private partnership. The new library has become a jewel of the neighborhood, one of the busiest libraries in the city, and the new home of the ANC's office and monthly meetings. In association with the library redevelopment, Rebecca also worked heavily on the redevelopment of the West End's Square 50 parcel, which included a new home for DC Fire and EMS' Engine No. 1, providing crucial public safety resources for the community, and 52 units of affordable housing for households at or below 60 percent AMI and three Permanent Supportive Housing units for households at or below 30 percent AMI. These units represented some of the very first units to receive funding from the Housing Production Trust Fund in ANC 2A.

Rebecca's advocacy on behalf of the West End also included her work to prevent the closure of the West End's Francis-Stevens Education Campus, ANC 2A's neighborhood school serving grades pre-K through 8. After the DC Public Schools announced the intended closure of the school in 2012, Rebecca worked alongside her ANC colleagues and community members to advocate for the continuation of school operations. This ANC and community advocacy included the development of an improvement and marketing plan for the school, and we were fortunate that in 2013 DCPS announced that the school would remain open. Since the announcement, the school has seen significant gains in its test scores and enrollment and has undertaken a successful partnership with Foggy Bottom's School Without Walls High School.

I will lastly note that Rebecca was instrumental in the creation of Duke Ellington Park, a triangle park honoring the West End's own Duke Ellington, who was born less than a block from the location of the park. The park has seen numerous improvements from the Golden Triangle BID over the years and the ANC has hosted several annual jazz concerts in honor of Duke Ellington's birthday.

In summary, Rebecca Coder served as a dedicated ANC commissioner and community leader during her nearly five terms on ANC 2A. Her accomplishments are numerous and have resulted in transformational change, especially for the West End community. We owe Rebecca so much gratitude for her work to improve public facilities throughout our community. It is with these reasons in mind that I heavily support the "Rebecca Coder Park Designation Act of 2021" and ask that the DC Council swiftly pass the legislation.

I am Brent Sisco the Capital Projects Planning & Design Officer for the Department of Parks and Recreation (DPR). I am pleased to testify before you today on the proposed designation of a community asset under DPR's jurisdiction; a subsection of the park at 2501 M Street, NW in Ward 2, known as Francis Field.

The proposed legislation designates a subsection of Francis Field that is to be named "Rebecca Coder Park." The subsection is bound on the east by 25th Street NW, on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building at 2501 M Street NW.

DPR believes the naming or renaming of a public asset needs a robust public engagement process to ensure broad community support and awareness of any renaming action. We would like the thank the Friends of Francis Field, for their work in highlighting the public service of Rebecca Coder and for their advocacy in championing this renaming action. We do note, that ANC 2A has passed a resolution in support of this renaming and that the Ward 2 Councilmember, Brooke Pinto, has introduced the legislation. As a result, DPR believes that a sufficient level of community engagement has occurred. In this case, and in all naming or renaming actions, DPR does not take a position in support or against the renaming.

As noted in the legislation's introduction, Rebecca Coder was a founding member and the first president of the Friends of Francis Field and was instrumental in helping to provide neighborhood friendly, passive recreation in the subsection of Francis Field to be designated in

her honor. Ms. Coder also served five terms as an Advisory Neighborhood Commissioner, representing the West End Neighborhood where the park is located. Commissioner Coder lost her fight with ovarian cancer in May 2018 while still in office. I would like to take this opportunity to thank Rebecca Coder for her public service and her support of DPR and public recreation as an ANC Commissioner. Moreover, I would again like to thank the Friends of Francis Field for their advocacy in this matter.

If the Council moves forward with the proposed renaming of this subset of Francis Field, DPR has estimated that the purchase and installation of a bronze plaque inset in a rock, reading "In memory of Rebecca Coder, 1969-2018, Friends of Francis Field" to be \$4000.00. DPR will utilize funding from the General Improvements Pooled fund to procure and install the bronze plaque if the legislation is passed.


