I. BACKGROUND AND NEED

On March 21, 2022, Proposed Resolution 24-649, the "District of Columbia State Athletics Commission Marcus Turner Confirmation Resolution of 2022," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 26-649 would confirm the Mayor's nomination of Mr. Marcus Turner for appointment as a member of the District of Columbia State Athletics Commission for a term to end November 7, 2024. Mr. Turner is being appointed to fill a vacancy created by the early departure of Rev. Karen Curry and this appointment will not count toward the 2-term limit (D.C. Official Code D.C. Official Code § 38-2661.11 (c)(3)(e).

Mr. Turner is a resident of Ward 7. He received his Bachelor's Degree in Accounting from Howard University and a Master's in Business Administration from the University of Maryland Global Campus. Mr. Turner is a native Washingtonian and an experienced contract management professional. Along with a demonstrated and fervent personal experience in athletics as a student,

he is the parent of a student in the District who participates in youth sports. Having previously served as an ANC member (ANC 7B01), Mr. Turner is well poised to serve on a collaborative body such as the Athletics Commission.

The District of Columbia State Athletics Commission (DCSAC) was established as an independent agency (D.C. Official Code § 38-2661.11 *et seq.*) in 2016. The DCSAC oversees the function and operations of the District of Columbia's State Athletics Association (DCSAA); recommends changes to and annually approves the DCSAA handbook; establishes athletic appeals panels to hear appeals from LEA decisions related to participant eligibility and decisions of the DCSAA and issue final decisions of such panels; advises the Mayor, the Office of the State Superintendent of Education (OSSE), and the Council on matters related to interscholastic athletics in the District and recommends rules to regulate interscholastic athletics programs and competitions.

The Commission is tasked with appointing a Chairperson annually from its members and must meet at least quarterly. The Commission consists of 9 voting members who must be residents of the District and are appointed by the Mayor with the advice and consent of the Council and 6 *ex-officio* non-voting members. Further, at least one of each of the voting members the Commission must be:

- A parent of a student enrolled in a member public charter school located in the District;
- A parent of a student enrolled in a DCPS school;
- A parent of a student enrolled at a private or parochial member school located in the District;
- A member of the District of Columbia Interscholastic Athletic Association, or its successor; and
- A member of the Public Charter Interscholastic Athletic Association, or its successor, if a majority of public charter schools that offer interscholastic athletics programs are members of the DCSAA.

Voting members are to serve a term 4 years and may be reappointed for a single term. *Exofficio* members of the Commission are:

- The State Superintendent, or their designee;
- The Chancellor of DCPS, or their designee;
- The Chair of the Public Charter School Board, or their designee;
- The Deputy Mayor of Education, or their designee;
- The Director of the Department of Parks and Recreation, or their designee; and
- The Director of the Department of General Services, or their designee.

In the Fiscal Year 2022, the Council approved an operating budget for the DCSAA of \$1,270,000 with 7.0 FTEs.

Mr. Turner is being appointed to the Commission as a voting member as a parent of a student enrolled in a private or parochial member school. Moreover, he is an experienced business professional with a contracts management background that would be helpful to the Commission and the Athletics Association as they host state athletics programming. He is dedicated to the mission of the Commission with the time and ability to serve. The Committee has heard no objections to Mr. Turner's appointment. Therefore, the Committee recommends the adoption of PR 24-649.

III. POSITION OF THE EXECUTIVE

Mr. Marcus Turner is the Mayor's nomination for appointment to the District of Columbia State Athletics Commission.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-649.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on PR 24-649 (and two other nominations to the District of Columbia's State Athletic Commission) on Monday, April 25, 2022. The testimony summarized below, and attached, is from the portion of the hearing pertaining to Mr. Marcus Turner.

Marcus Turner, Nominee, testified and answered questions from Chairman Mendelson regarding her background and experience as it pertains to the District of Columbia's State Athletics Commission and her interest in serving on the Commission.

The Committee received no testimony or comments in opposition to Mr. Turner's appointment.

VI. IMPACT ON EXISTING LAW

Members of the District of Columbia State Athletics Association are appointed pursuant to D.C. Official Code § 38-2661.11.

VII. FISCAL IMPACT

PR 24-649 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 38-2661.12(d), members of the District of Columbia State Athletics Association do not receive compensation.

VIII. SECTION-BY-SECTION ANALYSIS

Good afternoon, Chairman Mendelson and members of the Committee. My name is Marcus Turner. I am a native Washingtonian and lifetime DC resident. I grew up in Ward 5 and graduated from both DC public schools and Howard University. My wife and I are currently raising our three children in Ward 7. I am excited for the opportunity to contribute to the DC State Athletic Commission.

My career working for a private federal contractor requires being dependable and a person that "gets things done." I am accustomed to collaborating with multiple departments and working with differing perspectives to achieve common objectives.
