I. BACKGROUND AND NEED

The purpose of Proposed Resolution 24-578 is to confirm the appointment of Mr. Nick Rodriguez as a member of the Public Charter School Board (PCSB). If confirmed, Nick Rodriguez will fill a currently vacant seat on the Board.

The District of Columbia School Reform Act of 1995' ("SRA") gave the District of Columbia the authority to start independent, autonomous, public schools, commonly known as charter schools. The law initially gave authority to the District of Columbia Board of Education to charter these schools and also established the PCSB. The seven-member board was created for the purpose of authorizing new charters, monitoring the operations and student academic progress of the schools under its purview, and ensuring that the public charter schools under its authority are in compliance with the terms of their charter and applicable federal and local laws. As an independent authorizer of public charter schools, the PCSB is responsible for chartering new

schools through a comprehensive application review process; monitoring existing charter schools for compliance with applicable local and federal laws; and ensuring public charter schools are held accountable for both academic and non-academic performance. The PCSB is currently the District of Columbia's sole charter school authorizer and now oversees 66 charter schools on 120 campuses.

Mr. Rodriguez has had an extensive career in education in the District and nationwide. Early in his career, Mr. Rodriguez worked as a Program Director and Consultant for the California Association of Student Councils to empower youth and communities through leadership development and advocacy, and then later served as the Co-Founder and K-12 Director for the Education Delivery Institute (EDI). At EDI, Mr. Rodriguez led the transition from seed grant to sustainable fee-for-service funding with an annual budget of over \$4M and originated and oversaw a portfolio of over 50 engagements with state agencies, districts, and schools. Mr. Rodriguez is currently the Chief Executive Officer for Delivery Associates, a global organization with a focus on education, health, and climate. In this role, he has worked with the Tennessee Department of Education and Achievement School District, Texas Education Agency, Council of Chief State School Officers, Gates Foundation, and other education partners to support the development of projects that will have a positive impact on academic achievement and school system operations.

Mr. Rodriguez is being appointed to the Public Charter School Board as a voting member as a parent of a student enrolled in a public charter school located in the District. Given the candidate's extensive expertise in furthering educational excellence and the candidate's understanding of the Board's processes and standards towards ensuring high quality educational options for the students in the District of Columbia, the Committee recommends approval of PR24-578. The Committee of the Whole reports favorably on PR 24-578, adopts the report on this measure, and recommends approval by the Council. The Committee makes no changes to the Print adopted by the Committee.

Mr. Nick Rodriguez is the Mayor's nominee for appointment to the District of Columbia Public Charter School Board.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-578.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on PR 24-578 (and two other nominations to the District of Columbia Public Charter School Board) on Monday, April 25, 2022. The testimony summarized below, and attached, is from the portion of the hearing pertaining to Mr. Nick Rodriguez.

Dr. Jessica Sutter, Ward 6 Representative, DC State Board of Education, testified in support of Mr. Rodriguez and the three other nominees to the Public Charter School Board.

Dr. Michelle Walker-Davis, Executive Director of the Public Charter School Board, testified in support of Mr. Rodriguez and three other nominees to the DC Public Charter School Board. She noted that Mr. Rodriguez will provide insight and expertise on how the DC PCSB policies impact the decision-making of an LEA Board.

Shannon Hodge, Founding Executive Director, DC Charter School Alliance, testified in support of Mr. Rodriguez and the three other nominees to the DC Public Charter School Board, and urged the Council to move swiftly to move the confirmations to a vote in order to return the DC PCSB to its full capacity and function.

Valerie Jablow, Public Witness, testified about the nomination process, noting each of the nominees' connection to charter schools in DC.

Kristina Kyles-Smith, Executive Director, Two Rivers Public Charter School, testified in support of the nomination of Mr. Rodriguez to the DC Public Charter School Board. She notes in her testimony that Mr. Rodriguez has been instrumental in her development as an educational leader.

Nick Rodriguez, Nominee, testified and answered questions from Chairman Mendelson regarding his background, experience, and ability to serve on the District of Public Charter School Board.

The Committee received no testimony or comments in opposition to Mr. Rodriguez' appointment.

VI. IMPACT ON EXISTING LAW

Members of the Public Charter School Board are appointed pursuant to D.C. Official Code § 38-1802.14, which established the Board.

VII. FISCAL IMPACT

15. Why have you agreed to serve and how do you plan to help the Board fulfill its role and mission during your time on the Board?

I have agreed to serve on this board because I believe that educational equity is critical to delivering an equitable and prosperous future for all of us. Here in the District, that means that every parent should have access to excellent educational opportunities for their children throughout this city and in the communities where they live. This belief has guided me from early in my career and has shaped my professional life, where I focus on helping governments and school systems to deliver better results through better implementation. It has also shaped my volunteer service, where I have served on two local charter school boards here in the District and chaired one of them. And because I am a 15-year District resident and a parent of children enrolled in DC schools, the stakes are personal as well.

A strong and well-functioning PCSB is absolutely necessary to deliver on this broader vision for DC education. Its oversight extends to just under half of the students in the District, so its work affects our entire education ecosystem. Moreover, the PCSB has a solemn duty to ensure that the city's charter schools are accountable both to the students they serve and the broader communities that surround them. This duty often presents the PCSB with difficult decisions – decisions that require both wisdom and a willingness to listen and engage constantly with a wide range of stakeholders.

If I have the opportunity to serve, I hope to adopt this stance of listening and engaging, and to bring what I learn together with my own set of diverse perspectives – as parent, as resident, and as education professional – to help the board make wise choices that strengthen the educational opportunities available to all District students and families.

16. What challenges do you believe face the charter sector and how do you believe these challenges can be addressed?

I believe that the next four years will be an important time in the evolution of education in our city. We have all been living through the shared trauma of a pandemic for two years and are beginning to make progress on what it would look like to come out of it together. As we do that, our leaders – including the members of this Council, members of the community, educators, families, and other stakeholders – are asking serious and profound questions about how our system needs to evolve to meet the needs of the current moment and of the more equitable future that we're all trying to build together. These questions cluster around a few core themes:

- Accountability: Amidst all this change, how do we ensure that charter schools remain and become even more accountable for equitable and high quality results in the way they serve students and families?
- Community partnership: At the same time, how do we develop a broader sense of charter sector responsibility to local communities and to the broader mission of improving DC education writ large?
- Growth: In this context, how should we manage the growth of the DC charter sector, taking into account results, demand, and impact on the wider education ecosystem?

The PCSB will be making several important policy decisions that touch on these questions in 2022 – in particular, a revised accountability framework for schools and, with that, revised criteria and processes for considering applications to open new schools. To address these challenges, the PCSB must get these early policy choices right, and then follow through with robust, results-oriented, and equitable implementation of those policies. In particular, we should apply these frameworks with three trends in mind:

- New performance data: We will get this for the first time this year after a two-year lapse, and it will give us a sense of the scale of the challenge the pandemic has created, as well as its distribution across place and population. We will want to calibrate our decisions to match the needs that this data reveals.
- Residential patterns: As we move past some of the acute phases of the pandemic, we will be able to view emerging trends in residential data with more confidence. The data will tell us important things about who is moving where and living where, and the implications for what families need from schools and where. This, in turn, will influence important aspects of the growth question.
- New ways of partnering across DC government: Partnership is a pillar of the PCSB strategic plan, and the pandemic has challenged governments everywhere to break down siloes between sectors. We should spot and seize these opportunities as we manage through and out of the pandemic together.

These are the major challenges I see facing the charter sector. They are deeply intertwined with the challenges facing the DC education sector as a whole. If I have the opportunity to serve on the PCSB, I look forward to working with the Council and other stakeholders to find and implement solutions together.

Good afternoon, Chairman Mendelson, and members of the Council. I would like to thank you all for considering my nomination and I would also like to thank Mayor Bowser for nominating me to the Public Charter School Board.

My name is Nick Rodriguez. I'm a 15-year resident of the District and a parent of three children, two of whom are school age and are currently enrolled at one of our city's public charter schools. More specifically, I am the parent of a child with special needs and our family has benefited from services provided by Early Stages, Strong Start, and DCPS over the years. I know first-hand, through the special education system, how the different sectors of our city's school system can work together to make a difference for children and families. And I'm also aware of the many ways that collaboration could improve.

In my day job, I am the CEO of Delivery Associates, a small consulting firm that focuses exclusively on delivering results in the public and social sectors. Our mission is to help governments and their partners – both in DC and across the country – to deliver better results through better implementation. I work across sectors, but my main focus has been serving school systems. This has given me the opportunity to do work in the education sector here in our city: at various points over the years, I have been a part of strategic planning and delivery partnerships with DCPS, with OSSE, and with several individual charter LEAs, working with them to set clear goals for students and families and establish systems for managing and monitoring implementation and delivery of those goals.

Like many DC residents, I have lived here a long time but grew up somewhere else. I was born in Los Angeles to immigrant parents who greatly valued education. One of my earliest memories is being in elementary school and being told that we were moving to the suburbs. When I asked why, they gave an answer many parents at the time were giving: "We're moving out of the city so you can go to a better school."

For some reason, I never forgot that - I never forgot the seeming wrongness of it, even though it's a fact that we all know and live with today - the idea that parents who are able to move often choose where they live because they know that schooling is not equitable. It was the beginning of a set of questions that led me to the career I chose in educational equity and the broader work I do today in the field of public and social impact.

And this speaks to the broader question of why I am here today. The thing I thought as a child, then, is what I continue to believe today: all parents should have access to excellent education in the city and the specific place where they live. This is a goal that still eludes us, but it is my deeper 'why' and it's why I want to serve on this board.

I believe my background is relevant for this position for a few reasons. First, my family represents the diversity of this city: we are Latinx/Hispanic, Asian/Pacific Islander, and Black - and most of us are new Americans.

Second, as a parent, I have a strong stake in this system's success. Through enrollment at DCPS, charter schools, Strong Start, and Early Stages, I have seen this system from multiple angles, and hopefully have a perspective on what is strong about it and what could be improved.

Third, I believe my board service on two individual charter school boards - at Capital City Public Charter School and Two Rivers Public Charter School - is relevant, as it has given me a sense of how charter schools in the city are governed, of what they need from the PCSB, and what the PCSB and the broader education sector should be expecting from them. This work has included chairing a student performance committee that revamped the way a school worked with its outcome data, overseeing the development of multiple school strategic plans, supporting, and listening to educator and parent feedback about the work of both schools, chairing a search committee to hire a new Executive Director for one school, and refining and revising governance, accountability, and compensation structures for school leadership.

And finally, my professional career makes me knowledgeable about DC's current education ecosystem, but not a partisan for any particular part of it. As I noted earlier, I have done work directly with DCPS, OSSE, and several charter schools. I have also worked in a volunteer capacity with multiple advocacy and parent groups here in our city. I've grown to deeply respect and appreciate the many perspectives and voices that leaders from all corners bring, while also recognizing that there's always more we can do to widen that circle. And where it is helpful, I can also bring perspective from outside the city and outside the sector because of where my work takes me. My hope is that these experiences would help me to bring a well-rounded perspective to the PCSB.

I believe that the next four years will be an important time in the evolution of education in our city. We have all been living through the shared trauma of a pandemic for two years and are beginning to make progress on what it would look like to come out of it together. As we do that, our leaders - including the members of this Council, members of the community, educators, families, and other stakeholders - are asking serious and profound questions about how our system needs to evolve to meet the needs of the current moment and of the more equitable future that we're all trying to build together.

The questions facing the PCSB are focused on a few core themes: they are about charter school accountability, decision-making, and growth, and the impact on the wider DC education ecosystem that this next iteration of the board will have to consider. Some of them will play out in some decisions that the board will be considering this year - in particular, a revised accountability framework and, with that, revised criteria and processes for considering applications to open new schools. Those will be critical decision-making points that will set the tone for this term. And they will lead to other operational implications for the PCSB in the years to come as the board begins to apply these new frameworks in its decision-making.

The core task I see of the next four years is getting policy choices right around growth, equitable access, accountability, and supports in 2022, and then applying them in a way that is results-

focused and equitable in 2023 and beyond. We will also have to manage and be ready for three trends that are coming during this time.

The first is taking a hard look at performance data once we have access to it again later this year, after a two-year lapse. I know we all expect some really tough news about the toll this pandemic has taken on student learning. It will be important to understand the shape of this news, dig in for root causes, and be ready to adjust our work accordingly in response.

The second is, over time, getting more clarity about the impact of the pandemic on residential patterns - who is moving where and living where, and the impact that has for our student population and what families need from schools. We'll need to keep a close eye on this data and be ready to respond to it.

And the third is an opportunity to think better about cross-agency and cross-sector collaboration. Partnership is a pillar of the PCSB strategic plan, and one that I am particularly interested in. The pandemic has rightly created an expectation that government will do this better, and I'd be interested in leaning in to support PCSB leadership and staff in driving this part of the work.

In conclusion, I have seen firsthand what every aspect of DC's education system can do to serve parents. I've seen a lot of good things, and also some things that could be improved. And as a parent, I'm deeply aware that the benefits our family has received are not yet evenly accessible across our whole city.



As stakeholders in this system, we want DC to be a place where residents from all backgrounds feel that they belong. When it comes to education, that means a place where the various parts of our school system - working in partnership - can provide equitable and high-quality educational experiences to all kids in all places, meet families where they are, and improve results and outcomes for everyone.

The PCSB has a vital role to play in contributing to this vision. If I have the opportunity to serve, I would hope to center that vision in the way I listen, the partnerships I build, and the decisions and votes that I take.
