#### I. BACKGROUND AND NEED

The purpose of Proposed Resolution 24-580 is to confirm the appointment of Ms. Shantelle Wright as a member of the Public Charter School Board (PCSB). If confirmed, Shantelle Wright will fill a currently vacant seat on the Board.

The District of Columbia School Reform Act of 1995' ("SRA") gave the District of Columbia the authority to start independent, autonomous, public schools, commonly known as charter schools. The law initially gave authority to the District of Columbia Board of Education to charter these schools and also established the PCSB. The seven-member board was created for the purpose of authorizing new charters, monitoring the operations and student academic progress of the schools under its purview, and ensuring that the public charter schools under its authority are in compliance with the terms of their charter and applicable federal and local laws. As an independent authorizer of public charter schools, the PCSB is responsible for chartering new

schools through a comprehensive application review process; monitoring existing charter schools for compliance with applicable local and federal laws; and ensuring public charter schools are held accountable for both academic and non-academic performance. The PCSB is currently the District of Columbia's sole charter school authorizer and now oversees 66 charter schools on 120 campuses.

Ms. Wright has had extensive experience leading charter schools in the District. Ms. Wright has served as the Founder and Chief Executive Officer of Achievement Prep Public Charter School in Washington, DC. Achievement Prep is an award-winning, college preparatory public charter school network located in Southeast Washington, DC. Achievement Prep's mission is to prepare students to excel as high achieving scholars and leaders in high-achieving scholars and leaders in high school, in college, and beyond. Ms. Wright grew the Achievement Prep network from a single site school serving 68 scholars to a three school network serving approximately 1,000 children in PreK-3 through 8<sup>th</sup> grade. Achievement Prep has been one of the highest performing charter networks in the District.

Ms. Wright currently serves as the Chief Program Officer for EdNavigator, a non-profit organization that seeks to empower every family in the country with access to affordable, high-quality, on-demand support along the path to a great education, from before preschool to college and beyond. As a member of the executive leadership team, Ms. Wright is responsible for establishing the vision and direction for all of the organization's work and programming and is responsible for ensuring that EdNavigator provides exceptional educational support that makes a difference for families. To do so, she continually works to improve navigation strategies and practices and build sustainable and valuable service.

Ms. Wright is being appointed to the Public Charter School Board as a voting member. Given the candidate's expertise in furthering educational excellence and exceptional charter school leadership in the District of Columbia, the Committee recommends approval of PR24-580. The Committee of the Whole reports favorably on PR 24-580, adopts the report on this measure, and recommends approval by the Council. The Committee makes no changes to the Print adopted by the Committee.

#### III. POSITION OF THE EXECUTIVE

Ms. Shantelle Wright is the Mayor's nominee for appointment to the District of Columbia Public Charter School Board.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-580.

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on PR 24-580 (and three other nominations to the District of Columbia Public Charter School Board) on Monday, April 25, 2022. The testimony summarized below, and attached, is from the portion of the hearing pertaining to Ms. Shantelle Wright.

- *Dr. Jessica Sutter, Ward 6 Representative, DC State Board of Education*, testified in support of Ms. Shantelle Wright and the three other nominees to the Public Charter School Board.
- *Dr. Michelle Walker-Davis, Executive Director of the Public Charter School Board*, testified in support of Ms. Wright and three other nominees to the DC Public Charter School Board. She noted that Ms. Wright's leadership expertise will inform the DC PCSB's work on the priority of effective organization.

Shannon Hodge, Founding Executive Director, DC Charter School Alliance, testified in support of Ms. Wright and the three other nominees to the DC Public Charter School Board, and urged the Council to move swiftly to move the confirmations to a vote in order to return the DC PCSB to its full capacity and function.

*Valerie Jablow, Public Witness*, testified about the nomination process, noting each of the nominees' connection to charter schools in DC.

*Shantelle Wright, Nominee,* testified and answered questions from Chairman Mendelson regarding her background, experience, and ability to serve on the District of Public Charter School Board.

The Committee received no testimony or comments in opposition to Ms. Wright's appointment.

#### VI. IMPACT ON EXISTING LAW

Members of the Public Charter School Board are appointed pursuant to D.C. Official Code § 38-1802.14, which established the Board.

I have operated a charter school during the pandemic and I intimately understand the complex issues the DC Public Charter School Board faces, not just from theory, but as an actual practitioner. As a lawyer, I understand the significance of the School Reform Act, the policies, and the regulations governing charter schools. I will bring my years of experience in education and law to the Board to help shape the important charge we've been given and the decisions we face. I believe it's crucial for members of this Board to deeply understand education, school leadership, the DC community landscape, and how the decisions we as leaders make impact children, families, DC residents, and the city as a whole. I have that deep knowledge and expertise. As a member of the DC Public Charter School Board, I will bring a passionate focus on equity and quality to make sure that the nearly half of DC public school students educated in charter schools are getting the quality education that makes them feel valued and prepares them for lifelong learning, fulfilling careers, and economic security. It would be an honor to serve my city, teachers, school leaders, staff, and students in this capacity.
- 15. What challenges do you believe face the charter and how do you believe these challenges can be addressed?
  - The deep inequities revealed by the pandemic, particularly in communities of color hit hardest by COVID-19, will ripple in our children's education and in other parts of their lives for years to come. This makes the work we do and the decisions we make even more critical than they already were before the pandemic. As we work toward

recovery, what we prioritize and what we value will change the trajectory for generations to come. This Board has an obligation to make sure that the charter sector is an active participant in the city's recovery. The Board must create transparent and equitable accountability standards in this new post pandemic reality that will fully support — not hinder — schools from doing the work necessary for children to thrive. This includes listening and learning from school leaders, students and families. The Board has the delicate balancing act of ensuring each charter school has the freedom and flexibility to innovate and meet students' needs, while also making sure the schools are succeeding, are freely and fairly open to all, and employ equitable practices within. The Board must set clear expectations for student success (via accountability frameworks) post pandemic and create structures to hold schools accountable for the results. Lastly, as the city continues to grow and change, the Board will need to play a critical role in ensuring DC has a comprehensive cross sector education ecosystem (traditional public, charter and private) that meets the needs and demands of the city and ensures resources are allocated appropriately. As a member of the Board, I will listen to all information presented, read and learn as much as I can, and make informed decisions that put students and families first.

Good afternoon, Chairman Mendelson, and members of the Committee of the Whole. My name is Shantelle Wright. I am honored to be before you today as a nominee for a Mayoral appointment to the DC Public Charter School Board. I want to start by thanking Mayor Bowser for her consideration, and by thanking each of you here today for your time and your service.

To understand my nomination, you have to understand who I am.

I'm a proud Ward 8 DC resident, attorney, educator, and founder and former charter school leader.

Almost 30 years ago, I moved to this city to attend the George Washington University School of

Law. I quickly knew that the District would be my forever home.

Since I stopped practicing law nearly 20 years ago, I've dedicated my life to public education and fighting for children who look like me — children who are growing up in harsh environments like I did and who rely daily on the hope instilled by caring adults in their schools. I was raised by a single mother who worked two jobs to keep a roof over our heads and food in our mouths. We didn't have much, but my mother knew the power a good education would provide and insisted school be a top priority in my life. Starting in 6th grade, I was part of the "Urban Suburban" program, which meant I rode two hours to school from the inner city to the suburbs, and two hours home from school each and every day.

I'm proud of the education my mother fought for me to get. But no child should ever have to travel four (4) hours round trip and leave their neighborhood to get a good education. That was the driving force behind why 14 years ago, I founded — and had the honor to lead — Achievement Prep, a



public charter school network intentionally and strategically located in Ward 8. It has been the greatest professional joy for me and an absolute privilege to serve the children and families of Washington, DC. I've won many awards and received accolades over the years working in the District and with Achievement Prep, but my proudest moments by far have come from children defying the odds, breaking down barriers, and seizing the opportunities a great education brings.

I often think about our founding class of scholars. In 2008, 68 families of rising 4th and 5th graders put their faith in me and gave me the great privilege of teaching their children. I'm still honored they believed in us and took a chance on the unknown of Achievement Prep – instead of keeping their children in the schools they came from or choosing a school they already knew.

That first year, I went into the homes and sat on the couches of each and every founding family and asked them what their hopes and dreams were for their children, a practice I continued for a decade after we started the school. Like many parents, they said they wanted better lives for their children than they had. And my scholars' families, my neighbors, and the families living East of the River told me they wanted their kids to be safe.

Not better classes, not higher test scores, but to simply be safe. They wanted their children to get to and from school safely. Inside the school, they needed to know their kids would be safe — both physically and emotionally.

Even though I made the choice to step down from leading Achievement Prep last July, my commitment to children and families didn't change. Right now, I'm the Chief Program Officer at



EdNavigator, a national nonprofit whose mission is to empower every family in the United States with access to affordable, high-quality, on-demand support along the path to a great education, from before preschool to college and beyond.

And since my earliest days as a Washingtonian, I've been active and involved in my neighborhood and my city. I served with many of our key organizations like Miriam's Kitchen and Martha's Table. Mayor Bowser appointed me in 2017 to serve on her behalf on the United Planning Organization (UPO) Board of Directors, a role I continued for four years. And, when I served as an appointed member of the Mayor's Education Cross Sector Task Force, I brought the same passionate focus on equity and quality that I brought to Achievement Prep. I want to make sure that DC continues to be the fastest growing district in the country, but in an equitable and a comprehensive way that brings all stakeholders to the table.

As a member of the DC Public Charter School Board, I will bring that same passionate focus on equity and quality to make sure that the nearly half of DC public school students educated in charter schools are getting the quality education that makes them feel valued and prepares them for lifelong learning, fulfilling careers, and economic security. It would be an honor to serve my city, teachers, school leaders, staff, and students in this capacity.

I intimately understand the complex issues the DC Public Charter School Board faces, not just from theory, but as an actual practitioner. I will bring my years of experience and unique perspective to the Board to help shape the important charge we've been given and the decisions we face. As we work toward recovery, what we prioritize and what we value will change the



trajectory for generations to come. This Board has an obligation to make sure that the charter sector is an active participant in the city's recovery and that we are creating accountability standards and desired outcomes that will fully support — not hinder — schools from doing the work necessary for children to thrive.

Unfortunately, both here and across the country, our children's education has been politicized. Too many decisions get made based on who screams the loudest or who has the most access. Not enough decisions get made by those who understand our students' life experiences or who have the deep expertise necessary to make the right choices. That's why I want to join the Board.

I would be honored to serve in this new capacity as a DC Public Charter School Board Member. I have the skills, the passion, and the desire to help build a truly equitable public education system. I bring a wealth of knowledge and direct experience. I'm a strategic problem solver with executive leadership, engagement, operations and financial expertise.

If confirmed, my commitment to serve will be unwavering. My fight for equity and informed decision-making will be unapologetic. And my knowledge, experience, and willingness to learn and listen will be unmatched. I am happy to answer any questions you may have. Thank you.
