I. BACKGROUND AND NEED

Proposed Resolution 24-1051, the "District of Columbia State Athletics Commission Sarah Navarro Confirmation Resolution of 2022," was introduced by Chairman Mendelson at the request of the Mayor on November 10, 2022 and referred to the Committee of the Whole. The purpose of PR 24-1051 is to confirm the Mayor's nomination of Sarah Navarro for appointment to the District of Columbia State Athletics Commission to serve a term of four years.

The District of Columbia State Athletics Commission (Commission) is an independent agency that oversees the District of Columbia State Athletic Association (DCSAA). DCSAA is an association of District of Columbia public, public charter, and independent schools (private and parochial). DCSAA participants share knowledge and best practices to enhance student-athlete achievement through athletic programming and to provide quality life-learning experiences.

The Commission consists of 15 members that represent key community stakeholder constituencies and certain District agency heads or their designees: 5 members are agency heads

or their designees, 4 are public members, 3 are parents, and 3 members represent related District Associations. The Commission consists of 9 voting members, appointed by the Mayor, with the advice and consent of the Council and 6 ex-officio nonvoting members. If confirmed by the Council, Sarah Navarro will be reappointed for his second term to the Commission.

Ms. Navarro is the Senior Deputy Chief of Secondary Schools at DCPS. In this role, she leads the District's public school system to provide educational opportunities for all secondary students. She also oversees various educational programs including school counseling, academic scheduling support, ninth grade academies, student engagement athletics, graduation, and career and college preparation. Prior to joining DCPS, Ms. Navarro was the principal of the Maya Angelou Adult Learning Center and founding board chair of the Sojourner Truth Montessori Public Charter School.

Based on her commitment to the mission of the Commission, her District government experience, and her dedication to improving youth equitable outcomes, the Committee recommends the appointment of Ms. Navarro to the District of Columbia State Athletics Commission. The Committee of the Whole recommends adoption of PR 24-1051.

- November 15, 2022 PR 24-1051 is "read" at a Legislative meeting; on this date the referral of the PR to the Committee of the Whole is official and the 45-day period for Council review begins. If the Council does not act by January 8, 2022, PR 24-1051 will be deemed approved
- November 18, 2022 Notice of Intent to Act on PR 24-1051 is published in the D.C. Register.
- November 25, 2022 Notice of the public roundtable is published in the *D.C. Register*.
- December 8, 2022 The Committee of the Whole convenes a public roundtable on PR 24-1051.
- December 20, 2022 The Committee of the Whole marks up PR 24-1051.

III. POSITION OF THE EXECUTIVE

Ms. Navarro is the Mayor's nominee for appointment to the District of Columbia State Athletics Commission.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-1051.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on two District of Columbia State Athletics Commission nominations, including PR 24-1051, on Thursday, December 8, 2022. The testimony summarized below is from that roundtable, pertaining to Ms. Navarro. Submitted copies of testimony are attached to this report.

Sarah Navarro, Appointee, testified and answered questions from Chairman Mendelson regarding her background, experience, and interest as it pertains to continuing to serve on the Commission. Ms. Navarro believes that serving on the Commission will help ensure that athletics programs in the District will continue to provide safe, engaging, and healthy opportunities for all students to thrive. She has begun to attend the Commission meetings and committed to continuing to attend regularly.

VI. IMPACT OF EXISTING LAW

The District of Columbia State Athletics Commission is established pursuant to D.C. Official Code § 38-2661.11. PR 24-1051 is an exercise of the Council's discretion to approve or disapprove Mayoral nominations to Boards and Commissions, pursuant to the Confirmation Act of 1978 (D.C. Law 2-142; D.C. Official Code § 1-523.01).

VII. FISCAL IMPACT

A Fiscal Impact Statement is not necessary for a confirmation. Committee members are not compensated for their service.

Stellar coordination and communication with DC State Athletics Commission (DCSAC) are critical in creating a safe and robust athletics experience for all students. The goals of the DCSAC are to 1) Oversee the functions and operations of the DC State Athletic Association (or "DCSAA"); (2) Recommend changes to and annually approve the DCSAA handbook; (3) Conduct Athletic Appeals Panels and issue final decisions and (4) Advise the Mayor, OSSE, and the Council on matters related to interscholastic athletics in the District and recommend rules to regulate interscholastic athletics programs and competitions. In the time I have been involved with athletics in Washington, DC, I have been very impressed with the operation of the DCSAC and the strides they have taken in meeting these goals and mandates. Director Kenny Owens has done a tremendous job providing steady and thoughtful leadership to the DCSAA and the DCSAC is thorough, and diligent. In recent years the Commission has improved the efficiency of the appeals process and contributed to important updates to the DCSAA handbook. If appointed as a commissioner, I would work to help advance these goals. My position at DCPS allows me a good view into how the operations of the DCSAA impact on-the-ground athletics programs, and I would continue to advocate for solutions that benefit our athletes. I would offer feedback and suggestions regarding the DCSAA handbook and flag any areas that need to be clarified or adjusted. While I would not serve on appeals panels to avoid any potential conflict of interest, I would work with my fellow commissioners to identify best-practices in the appeal processes. Finally, I would take a big picture view of athletics in the city and work with my fellow commissioners to identify high-leverage actions to increase quality and access for athletics in the city.

As the Senior Deputy Chief of Secondary Schools, I'm in an ideal position to serve on the DC State Athletics Commission. In my role, I oversee athletics, Ninth Grade Academies, student engagement, JROTC, school academic scheduling and support, and college career and persistence. These workstreams all provide interlocking programming and policies to support our students wholistically during their time at DCPS and beyond. I will bring my passion as an athlete and former coach, and my expertise as an educator to ensure follow through with goals and important initiatives.

Good morning, Chairman Mendelson, members of the Council, and staff and members of the Washington, DC community. I am Sarah Navarro, a member of the District of Columbia Interscholastic Athletic Association, and Senior Deputy Chief of Secondary Schools for DC Public Schools (DCPS), and I am honored to testify before you today regarding my appointment as a member of the DC State Athletics Commission. I'd like to thank Mayor Muriel Bowser for the nomination and Chairman Mendelson for holding this hearing. As a resident of the Brookland neighborhood in Washington DC, a leader at DC Public Schools, and a longtime athlete, coach, and athletics advocate, I believe I will be a good addition to the District of Columbia State Athletics Commission (DCSAC).

Growing up, participating in sports played a huge part in my life. It taught me how to win, how to lose, how to be a good teammate and a good sport no matter what happens. I went through some difficult times in high school, and I didn't feel particularly connected to my studies, causing me to want to drop-out. It was my tennis team that kept me grounded and engaged and gave me a reason to keep my grades up. I trained hard during the school year and coached tennis to younger kids in the summers. I ended up competing at a division one university, and tennis remains an important part of my life today. As an educator, I firmly believe in the role of athletics in supporting our students wholistically.

After graduating from college, I knew I wanted to spend my career advancing social justice and ensuring that all youth have genuine opportunities to reach their full potential. I worked as a wilderness counselor for at-risk youth, started a transition program for teens in the foster care system, contributed to national policy initiatives to identify and eliminate institutional racism in education, juvenile justice, and child welfare, and served as the principal at the Maya Angelou Young Adult Learning Center in Ward 7. In 2016, I joined the DCPS team as the Director of Pathways. In this role, I helped implement Pathways -- a program designed to support our students who are most under-resourced and at risk of falling behind. I also led the redesign of our alternative schools — now known as Opportunity Academies. One of the key components in this redesign was adding athletics programming to these schools, so our older students who did not meet criteria for participation in the District of Columbia Interscholastic Athletic Association (DCIAA) high school sports, could compete. I'm proud to say that this is the 5th year of the Opportunity League, where we offer basketball, bowling, and track.

As my work at DCPS grew to include our programing and policies in the areas of student engagement, graduation, and college, career, and post-secondary persistence, I had the pleasure of adding athletics to my portfolio in February of 2021. Since taking on this work, I've helped the DCIAA team successfully oversee the return to in-person sports, implement the student-athlete vaccine mandate, and add high school wrestling to our offerings. I'm proud to report that during SY 21-22, we had a high school participation rate in athletics that was more than 70% of the prepandemic participation totals. The fall sports season of this school year was a big success, and I look forward to continuing to strengthen and expand our athletics program in the city in support of our students.

If appointed to the Commission, I will bring my passion as an athlete and my expertise as an educator. The DCIAA represents the largest athletics program in the District of Columbia. Stellar coordination and communication with DC State Athletics Commission are critical in

creating a safe and robust athletics experience for all students. The goals of the DCSAC are to 1) Oversee the functions and operations of the DC State Athletic Association (or "DCSAA"); (2) Recommend changes to and annually approve the DCSAA handbook; (3) Conduct Athletic Appeals Panels and issue final decisions and (4) Advise the Mayor, OSSE, and the Council on matters related to interscholastic athletics in the District and recommend rules to regulate interscholastic athletics programs and competitions. In the time I have been involved with athletics in Washington, DC, I have been very impressed with the operation of the DCSAC and the strides they have taken in meeting these goals and mandates. Director Kenny Owens has done a tremendous job providing steady and thoughtful leadership to the DCSAA and the DCSAC is thorough, and diligent. In recent years, the Commission has improved the efficiency of the appeals process and contributed to important updates to the DCSAA handbook. If appointed as a commissioner, I would work to help advance these goals. My position at DCPS allows me a good view into how the operations of the DCSAA impact on-the-ground athletics programs, and I would continue to advocate for solutions that benefit our athletes. I would offer feedback and suggestions regarding the DCSAA handbook and flag any areas that need to be clarified or adjusted. While I would not serve on appeals panels to avoid any potential conflict of interest, I would work with my fellow commissioners to identify best-practices in the appeal processes. Finally, I would take a big picture view of athletics in the city and work with my fellow commissioners to identify highleverage actions to increase quality and access for athletics in the city.

I believe that serving on the DCSAC will help ensure that athletics programs in Washington, DC continue to provide safe, engaging, and healthy opportunities for all of our students to thrive. I have already begun to attend the DCSAC Commission meetings and will commit to continuing to attend regularly. I will bring an on-the-ground perspective to the board, and I'm positioned to ensure that any follow-up actions resulting from our meetings are seen through at DCPS.
