#### I. BACKGROUND AND NEED

Proposed Resolution 24-1037, the "Director of the Office of Planning Anita Cozart Confirmation Resolution of 2022," was introduced by Chairman Mendelson at the request of the Mayor on October 28, 2022. The purpose of PR 24-1037 is to confirm the Mayor's nomination of Ms. Anita Cozart for appointment as the Director of the Office of Planning, to serve at the pleasure of the Mayor.

The Home Rule Act places the central local planning function for the District of Columbia in the Mayor. The Mayor, during the history of home rule, has delegated this function to the Director of the Office of Planning. Pursuant to Mayor's Order 83-25, dated January 3, 1983, which is the existing authority, the purpose of the Office of Planning is to "assist the Deputy Mayor for [Planning and] Economic Development and the Mayor in the performance of the planning functions of the District of Columbia, and in the preparation of plans for the physical and economic development of the city."

The functions of the Director of Planning are also set forth in Mayor's Order 83-25, which provides that the Director of the Office of Planning shall:

- 1. Prepare, refine and implement the District elements of the Comprehensive Plan for the National Capital.
- 2. Prepare, refine and implement area and specific plans such as the Downtown and neighborhood plans.
- 3. Establish and implement procedures for citizen participation in the planning process.
- 4. Manage the collection of demographic and statistical information, including the computerized MAGIS system, in order to maintain accurate population and land use evaluation and projections.
- 5. Provide planning liaison for the District of Columbia government with other federal and regional agencies, task forces and committees as appropriate.

The Office of Planning is currently organized into seven divisions: Neighborhood Planning; Revitalization and Design; Citywide Planning; State Data Center; Development Review and Zoning; Historic Preservation Office; and Geographic Information Systems and Information Technology.

PR 24-1037 would confirm the appointment of Ms. Anita Cozart to serve as the Director of the Office of Planning, replacing Mr. Andrew Trueblood, who left the office in November 2018. Ms. Cozart served as Interim Director beginning in March 2018 and has served as Acting Director since her nomination by Mayor Bowser.

Ms. Cozart is currently a resident of Ward 5. She holds a Master of City and Regional Planning for the University of California at Berkley, and a Bachelor of Science in Civil and Environmental Engineering from the University of Pittsburgh. She is co-chair of the District government's Black Homeownership Strikeforce and a Board Member for Smart Growth America.

Before serving as Interim Director, Ms. Cozart was Deputy Director of Community Planning and Design for the Office of Planning. In that role, Ms. Cozart oversaw OP's work on neighborhood planning and urban design. Ms. Cozart has led teams responsible for the most recent Comprehensive Plan amendments adopted by the Council in 2020 and 2021. She was also responsible for recent neighborhood planning efforts stemming from the Comprehensive Plan, and she developed the Streets for People program to activate downtown and support the District's economic recovery. Prior to joining the Office of Planning, Ms. Cozart was PolicyLink's managing director where she oversaw nationwide place-based equitable development initiatives. She has over a decade of experience using a racial equity lens in planning, housing, transportation, and infrastructure policy.

During her confirmation hearing, Ms. Cozart described her priorities for OP. With respect to small area plans, she stated that upcoming plans will include reports on Ivy City, Deanwood,

Foggy Bottom, and North Capitol Crossroads (North Capitol and Irving). Both a Friendship Heights and Tenleytown plan, and a Woodley and Cleveland plan are currently under development. With respect to the Comprehensive Plan, she emphasized that OP is currently thinking about what a future plan update may look like, including a shorter and easier to navigate plan in advance of a January 2025 kickoff for a new plan. In response to questions about how OP now integrated a racial equity lens in its work, Ms. Cozart testified that each of the recently completed small area plans has a section focused on disaggregating data from the perspective of the neighborhood and the participants engaged in the planning process. She also stressed the importance of setting benchmarks to measure the results when a plan is implemented. For other plans, including zoning cases, OP is now describing potential outcomes of development projects through a racial equity lens. In response to questions about public engagement changes as a result of the COVID-19 pandemic, Ms. Cozart testified that virtual options have increased access to District residents that may not been able to attend in person meetings in the past, and that in some communities, options for in person engagement is important.

Ms. Cozart has a demonstrated commitment of service to the District. Her wealth of experience, particularly at OP, equips her with the tools necessary to serve as the Director of the Office of Planning. The Committee of the Whole believes that Ms. Cozart is more than capable to serve as Director recommends her appointment.

The Committee of the Whole held a public hearing on PR 24-1037 on Monday, November 21, 2022. The testimony summarized below is from that hearing. Submitted copies of testimony are attached to this report.

*Marcel Acosta, Planning Professional*, testified in support of Ms. Cozart and spoke to his work with the nominee over the years and referred to her as the right person at the right moment to lead the District's planning office.

Anita Cozart, Nominee, testified before the Council regarding her background and desire to serve as the Director of the Office of Planning. She spoke of the projects she has worked on so far at OP, including her leadership in development of the Comprehensive Plan for the Executive, development of programs like Streets for People, and the other planning work ongoing to be released over the coming years. Her written testimony is attached.

There were no comments received in opposition to the nominee.

#### VI. IMPACT ON EXISTING LAW

PR 24-1037 is an exercise of the Council's discretion to approve or disapprove Mayoral nominations of subordinate agency heads in the Executive Service, pursuant to § 1-523.01(a) of the District of Columbia Official Code.

#### VII. FISCAL IMPACT

A Fiscal Impact Statement is not needed for a confirmation resolution. The annual compensation (including fringe) for the Director, which is \$189,991, is included as part of the annual budget for the Office of Planning.

Good afternoon, Chairman Mendelson and members and staff of the Committee of the Whole. My name is Anita Cozart and I am the Acting Director of the DC Office of Planning (OP).

As a proud resident of Ward 5, I am honored to have been nominated by Mayor Muriel Bowser as the Director of the Office of Planning. I welcome the opportunity to discuss my background, experience, and vision for OP.

To start with my background, I am currently in my second tour of service at the Office of Planning. Prior to my appointment as the Interim Director, from 2019 to 2021, I served as the Deputy Director of Community Planning and Design. In that role, I led OP's work on neighborhood planning and urban design. During my time as Deputy Director, I provided oversight to the teams that completed the 2021 Comprehensive Plan update and launched the most recent wave of neighborhood plans including two that the Council has recently adopted for Congress Heights and Chevy Chase. My previous tour of service at OP started in 2003 and ended in 2010. During that time, I served as a Citywide Planner, a Neighborhood Planner with a focus on Ward 4, and ultimately as Chief of Staff.

Between my two tours at OP, I was a managing director at PolicyLink, a nonprofit organization where I led place-based community development initiatives in 35 cities and regions across the United States. At PolicyLink, my focus was on embedding racial equity into housing and transportation policies at the local, state, and federal levels.

My deep commitment to public service and striving for excellence are values that I carry with me to this day. Coupled with my background and experience, I welcome the opportunity to lead OP in delivering on the important work ahead.

In January 2022 when I was appointed as Interim Director, one of my first actions was the launch of the Streets for People Initiative with over \$2.8 million in grants to Business Improvement Districts and Community Improvement Districts in the Downtown. This program supported over 100 recurring public space activation events to bring people back to Downtown. The Streets for

People program will continue into 2023 and lessons learned will support strategies to advance Downtown's economic recovery.

A key aspect of Mayor Bowser's housing goals is to ensure that all District residents have a fair shot at affordable housing, access to opportunities, and building generational wealth, particularly for communities of color. This year, I served as the co-chair of the Black Homeownership Strikeforce, which set a bold goal of 20,000 net new Black homeowners in the District by 2030 and issued recommendations to achieve the goal.

As Interim Director, I also oversaw the completion and submission to Council of three small area plans. This year, Council has approved small area plans for Chevy Chase and Congress Heights that OP developed in collaboration with community partners. In the coming weeks, OP will submit to Council for adoption the Pennsylvania Avenue East Small Area Plan. Each of these small area plans advances housing goals and supports equity and resilience through recommendations that are tailored to neighborhood needs. OP has initiated an additional five place-based planning efforts to implement the Comp Plan with several more launching in 2023.

The mission of the Office of Planning is to plan for the long-term growth of the District in a way that reflects our values of an inclusive and vibrant city. My vision for OP is two-fold -- that OP will earn the reputation as a regional and global leader in developing and executing plans that yield racially-equitable and prosperous communities, and that OP is deeply-engaged with as many District residents and stakeholders as possible as we realize our mission.

If confirmed as Director, over the next several years, I plan to focus on:

- 1. Implementing the 2021 Comprehensive Plan, including the placed-based planning efforts that align with the land use changes outlined in the Comp Plan;
- 2. Laying the groundwork for the 2025 Comprehensive Plan rewrite;
- 3. Accelerating land use and zoning activities that advances the District's goal of 36,000 new housing units, including 12,000 affordable units by 2025; and
- 4. Supporting efforts to reimagine and reinvigorate Downtown.

As I move these focal areas forward, I seek to make the work across OP's divisions more accessible, equitable, and impactful.

With respect to accessibility, one of my actions as Director will be to expand and enhance ways for all residents to easily engage with and inform OP's work. To accomplish this, we will pursue emerging technology, innovative engagement approaches, measurable evaluation methods, and new platforms to share our planning work. I will build upon work underway including: the use of 3D modeling software that illustrates how zoning and urban design can be used to envision great places and spaces along Wisconsin and Connecticut Avenues; the OP Demographic Data Hub, which serves as a one-stop-shop to help people understand population trends citywide and in their communities; and the web-based Public Input platform, which expands opportunities for residents and stakeholders to provide input into OP's ongoing planning initiatives. Looking ahead, the 2025 Comprehensive Plan rewrite is a key opportunity to create a new guide for growth and development that District residents and stakeholders can easily navigate. I look forward to working with the Council to identify approaches to accomplishing that outcome.

With respect to equity, OP's approach has centered the 2021 Comprehensive Plan's priority of racial equity by exploring a key question: How have the District and its neighborhoods changed, how will they continue to change, and for whom? With this question in mind, OP has incorporated several practices in our work, including:

- Understanding and acknowledging the role urban planning has played historically in furthering discrimination and inequitable outcomes in Black communities and communities of color;
- Disaggregating demographic and community participation data by race, gender, and other socio-economic factors, where possible;
- Engaging diverse community voices through a transparent and open process;
- Developing a community-informed vision for equitable and inclusive growth that is rooted in participation; and
- Setting benchmarks for equitable outcomes of the plan or initiative.

Embedding and approaching racial equity as both a process and an outcome has been a key aspect of my career, so I look forward to giving leadership to OP's work in 2023 to develop and begin to implement an action plan that leverages our activities to advance racial equity in a meaningful and measurable way.

Finally with respect to impact, OP plays a key role in shaping our built environment through land use, design, and place-based planning, which impacts how people live, work, and play in our diverse communities. The land use and urban design elements of the 2021 Comp Plan provide a vision and goals for enhancing the quality of the built environment in the District. To this end, OP has developed and will continue to implement streetscape standards for developing areas like Buzzard Point and Union Market to foster new public spaces that welcome residents and visitors into outdoor environments that promote environmental resilience and relate to industrial and commercial activities that historically defined these neighborhoods.

Another way OP will continue to impact the built environment is through review of proposals for zoning changes, particularly in areas impacted by land use changes adopted in the 2021 Comprehensive Plan. Advancing zoning designations that support these land use changes is a critical step toward realizing more housing in the District, including affordable housing, and OP continues to move this work forward. It is critical that as we do this work we also continue to apply a racial equity lens guided by disaggregated data, community engagement, and strategies to address displacement pressures facing many communities.

In conclusion, I am excited about the opportunity to lead the Office of Planning and am grateful to Mayor Bowser for nominating me. Each day I am proud to work with the one-of-a-kind OP team who have such a deep knowledge of our city, a passion for service to our residents, and a commitment to moving DC toward a stronger and resilient future. Thank you for this opportunity to testify today and I look forward to answering any questions you may have.

Good morning, Chairman Mendelson, members of the Committee of the Whole, and staff. My name is Leona Agouridis, and I am Executive Director of the Golden Triangle Business Improvement District ("BID"). The BID is a nonprofit established by District law to provide clean, safe, and vibrant environments, and retain and attract businesses to one of our core D.C. neighborhoods, the Golden Triangle. Thank you for the opportunity to testify on the confirmation of Anita Cozart as the Director of the District of Columbia's Office of Planning. Anita was the first planner hired at the Golden Triangle BID. I saw first-hand years ago her sense of vision and direction as she brought new ideas and initiatives to the organization. Since then, I have watched her leadership grow, I have witnessed her steadfast commitment to the District and all of its residents, and I have admired the perspective and purpose she brings to her work.

Today, I am pleased to be before you to support her nomination as the next Director of the District's Office of Planning.

The pandemic has devastated central business districts ("CBDs") throughout the county and the Golden Triangle is no exception. With 34 million square feet of office space, virtually no residents or cultural institutions, and ground floor retail that is dependent on office workers, the Golden Triangle has been especially hard hit, arguably more than any other neighborhood in the District of Columbia.

Looking ahead, the BID is excited about several new initiatives in partnership with Anita and the Office of Planning. From working to reimagine and replan the Golden Triangle and

Even before the pandemic, the Office of Planning has been an essential partner in the BID's work, providing thought leadership as well as technical and practical expertise. The work of OP is more important now than ever, and Anita is the ideal leader to take the agency forward into what still are very challenging and unprecedented times for the Golden Triangle and District of Columbia.

The pandemic has created a new sense of urgency and broad recognition that we must act boldly and comprehensively to reimagine the CBD. Anita is well positioned to continue to support our efforts in rethinking the neighborhood. We look forward to continuing our very successful partnership with OP under Anita's leadership.
