### I. BACKGROUND AND NEED

On October 3, 2022, PR 24-971, the "Child Fatality Review Committee Shalonda Cawthon Appointment Resolution of 2022" was introduced by Chairman Mendelson. The purpose of PR 24-971 is to appoint Ms. Shalonda Cawthon as a member of the Child Fatality Review Committee from the Office of the Ombudsperson for Children on an at-will basis.

Ms. Cawthon is a Ward 5 resident. She received her Bachelor of Science in Psychology from Murray State University, and a Master of Science in Criminology from Indiana State University. Ms. Cawthon currently serves as the District of Columbia Ombudsperson for Children, assuming that role after her appointment by the Council in July 2022. Prior to that she served as the Regional Program Manager (Region 4) for the Department of Health and Human Services' Administration for Children and Families in Atlanta, Georgia. In that role, she was responsible for providing leadership and strategic direction to Children's Bureau in the Atlanta Regional Office. Ms. Cawthon also provided programmatic oversight, monitoring and technical assistance to the 8

states and tribes within the southeast region for all child welfare programs including the Federal Foster Care program (Titles IV-B and IV-E of the Social Security Act) and the Child Abuse Prevention and Treatment Act (CAPTA).

The Child Fatality Review Committee was established in 2001 and operates under the oversight of the Office of the Chief Medical Examiner (OCME). The CFRC is composed of a minimum of 13 representatives from public agencies along with members from federal, judicial and private agencies, and 8 community representatives. The community representatives are meant to represent all District of Columbia wards. Each member should have specialized knowledge in child development, maternal and child health, child abuse and neglect, prevention, intervention, treatment, or research. Due consideration must be given to representation of ethnic or racial minorities.

#### Pursuant to D.C. Code § 4-1371.03, the CFRC's duties are to:

- (1) Identify and characterize the scope and nature of all child deaths in the District, particularly those that are violent, accidental, unexpected, or unexplained;
- (2) In an effort to reduce the number of preventable child fatalities, examine past events and circumstances surrounding child deaths in the District by reviewing the records, files, and other pertinent documents of public and private agencies responsible for serving families and children, investigating deaths, or treating children, giving special attention to child deaths that may have been caused by abuse, negligence, or other forms of maltreatment;
- (3) Develop and revise, as necessary, operating rules and procedures for the review of child deaths, including identification of cases to be reviewed, coordination among the agencies and professionals involved, and improvement of the identification, data collection, and record keeping of the causes of child death;
- (4) Recommend specific and systemic improvements to promote improved and integrated public and private systems serving families and children;
  - (5) Recommend components for prevention and education programs; and
  - (6) Recommend training to improve the investigation of child deaths.

Section 4604(c-1) of the Child Fatality Review Committee Establishment Act of 2001, effective October 3, 2001 (D.C. Law 14-28; D.C. Official Code § 4-1371.04) requires the Council to "appoint a minimum of one representative from the Office of the Ombudsperson for Children." Ms. Cawthon's appointment, as head of the office, would satisfy this statutory requirement.

Based on her position, credentials and her child welfare expertise, the Committee recommends the appointment of Ms. Cawthon to serve on Child Fatality Review Committee as the representative from the Office of the Ombudsperson for Children. Moreover, the Committee believes Ms. Cawthon meets the requirements to serve on the Board pursuant to D.C. Official Code § 4-1371.04(c-1). For the reasons stated above, the Committee recommends adoption of PR 24-971.

#### II. LEGISLATIVE CHRONOLOGY

#### III. POSITION OF THE EXECUTIVE

Ms. Cawthon is a Council appointee to the Child Fatality Review Committee. The Executive did not submit comments with respect to the appointee.

#### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 24-971.

#### V. IMPACT ON EXISTING LAW

The member of the Child Fatality Review Committee representing the Office of the Ombudsperson for Children is appointed by the Council pursuant to section 4604(c-1) of the Child Fatality Review Committee Establishment Act of 2001, effective October 3, 2001 (D.C. Law 14-28; D.C. Official Code § 4-1371.04).

#### VI. FISCAL IMPACT

PR 24-971 will have no fiscal impact on the District of Columbia budget or financial plan. Members of the Child Fatality Review Committee are not entitled to compensation.

## VII. SECTION-BY-SECTION ANALYSIS

Section 1	States the short title of PR 24-971.
