I. BACKGROUND AND NEED

Proposed Resolution 21-468, the "Children and Youth Investment Trust Corporation Board of Directors Jennifer Budoff Reappointment Resolution of 2016," was introduced by Chairman Mendelson on December 10, 2015 and referred to the Committee of the Whole. The purpose of PR 21-468 is to confirm the Council's reappointment of Jennifer Budoff as a member of the Children and Youth Investment Trust Corporation Board of Directors as a non-voting Council appointee for a term to end April 19, 2017.

The Children and Youth Investment Trust Corporation ("CYITC") was established by the Service Improvement and Fiscal Year 2000 Budget Support Act of 1999 as "a single non-service provider, non-profit organization of which at least 95% shall be used to make sub-grants for the purpose of providing services to District children, youth and their families, including, but not limited to, early childhood development opportunities, safe and enriching centers of learning in

and out of school, and other training, recreational and educational services"¹ In addition to Council appointees, members of the Board include mayoral appointees.²

Ms. Budoff is currently a Ward 3 resident and is currently the Budget Director for the Council of the District of Columbia. She is a graduate of Georgetown University, where she earned a Master of Public Policy. Ms. Budoff also holds a Bachelor of Arts from Vanderbilt University. Ms. Budoff has served on the Board since 2013. This experience equips her to continue to contribute successfully to the Panel's work going forward.

The Committee of the Whole recommends his reappointment.

- February 2, 2016 The Committee of the Whole marks-up PR 21-468.

VII. FISCAL IMPACT

The approval of PR 21-468 will have no fiscal impact. Members are not compensated by the District government.
